**REJOINDER ON BEHALF OF APPELLANT**  
**AGAINST THE COMMENTS / REPLY OF**  
**THE RESPONDENTS NO. 1 & 2.**

**Respectfully Sheweth:-**

Appellant submits rejoinder as under:-

**On Preliminary Objections:-**

- 1)** That the answering respondents have not explained that how the appellant has got neither cause of action nor did locus standi to file the instant appeal. Moreover, the answering respondents has made through impugned orders breakup the services of appellant for eight years, thus appellant being aggrieved person from the illegal act of respondents. Hence, para is misconceived and denied.
- 2)** That the para No. 2 of preliminary objection is totally misconceived and denied. Moreover, the answering respondents has given detail of pressurization.
- 3)** That the Para No. 3 of the preliminary objection is also totally misconceived and denied. Moreover, the instant appeal is Section 4 KP service Act 1974.
- 4)** That Para No. 4 is misconceived and denied. Furthermore, the appeal of appellant is

maintainable on its present form and answering respondents have not given detail that how the instant appeal is not maintainable in present form.

- 5) That Para No. 5 is misconceived and denied, the appellant has no malafide to file the instant appeal and the appeal of present appellant is liable to be accepted under the best interest of justice.
- 6) That Para No. 6 is misconceived and denied. The appellant has come to this Honourable Court with clean hands being aggrieved person and the answering respondents has not given unclean-less on behalf of the appellant.
- 7) That Para No. 7 is misconceived and denied. Furthermore, the appellant made a proper party on such circumstances.
- 8) That the appeal of present appellant is according to law i.e Section 4 of KP Service Tribunal Act 1974.
- 9) That appeal of the appellant is well within law and limitation. Furthermore, the impugned order is void and not sustainable in the eyes of law and have issued in pieces. It is also submitted that the answering respondents have not given any charge sheet / statement of allegation / notice etc, thus any proceeding whatsoever its available against the appellant being unaware and the appellant was not associated with the alleged proceeding, hence appellant came into knowledge of the impugned orders on 03/01/2020, then the appellant on the next day i.e 06/01/2020 submitted departmental appeal and then 13/04/2020 submitted instant service appeal.

**ON FACTS:**

1. Para No. 1 needs no reply as declared correct.

2. That in response to reply of para No. 2. Actually the law and order situation in South Waziristan was bad and once since 2007 till date and this fact is in the knowledge of ever one including children that no employee was in position to attend the official duties and thus in the light of notification of Home Department & Relief Department that the instant area were declared war zone & IDPs and the notification in this respect are available in the custody of Home Department and Relief Department and the appellants submits before this Honourable Tribunal to procure the said notification to produce the same before the Court.

3. That Para No. 3 is misconceived and denied. Actually due to force leave although the appellants and peoples of that area were declared IDPs by the Government due to law and order situation and security risk. Furthermore, the appellants has never remained absent from the duty and the appellants was on duty constrictively. The stance of answering respondents in respect of information is department is misconceived because it was in the knowledge of every one the above facts and further that the answering respondents has not given any charge sheet or stated allegation in this respect.

4. That Para No. 4 is misconceived, actually the appellants was on regularly duty constrictively and never remained absent from duty. Moreover, the appellants has given the clear cut facts to the answering respondents these does not mean that appellants was not on duty, because after year 2018, the appellants never remained absent from a single day and before the year 2010 the appellants has hundreds casual leaves in his credit.

5. That Para No. 5 of the answering respondents is misconceived and denied. The proper reply is


also given by the appellant in supra paras. As no charge sheet / statement of allegation / 1<sup>st</sup> show cause notice / last show cause notice / opportunity of personal hearing in shot no inquiry was conducted by the answering respondents inspite of this the impugned order has been issued and eight years break up period has been made by the respondents through slipshod manner and furthermore the appellant has been deprived from the seniority as due to the appellant. Moreover, the appellant has performed his duty constrictively, mentally and due to the unavoidable circumstances the situation aforementioned has been occurred, which was not on the fault of appellant and nor the government was in a position to divert the same.

6. That Para No. 6 is totally misconceived and denied. The appellant never remained absent there was no fault on behalf of conduct of the appellant. Although the other employee of the same nature have been treaded similarly and no discrimination has been made.

7. That in reply of 7 para, the detailed reply also given by the appellant in supra paras.

8. That Para No. 8 is misconceived and denied, furthermore the detailed reply has been given in supra paras.

i. Para No. 1 is misconceived. Furthermore, the Para No. 1 of the grounds is reiterated.

ii. Para No. ii is misconceived. Furthermore, the detailed reply has been given in supra paras.

Para No. iv is incorrect. Actually the answering has made discriminated with the appellant and not treated with the appellant and not treated the appellant as other employee of the South Waziristan. The appellant is entitled to be treated as the other employee of that area. As stated in supra paras that law and order situation was versed as evident from the report dated 02/04/2010, wherein Molvi Janan employee was murdered, similarly report dated 05/04/2010 that political Naib Tehsildar Birmal was fired with heavy weapon through another report dated 07/04/2010 Angor Adda was fired through Missile and another report dated 09/04/2010 that some miscreants fired two missile. Copies of the same are enclosed as **Annexure "AI"**. Similarly directly BHU Sara Kanda on with the appellant was performing duty was also damaged / miscreants. Copy of the same is enclosed as **Annexure "BI"**. It is also pertinent to mention here that Junior to the appellant was promoted and thus the appellant was deprived from seniority in promotion due to illegal act of the answering respondent, for which the appellant submits for grant of retrospective promotion in seniority. Copies of the relevant documents are enclosed as **Annexure "CI"**.


That Para No. 6 is not denied by the answering respondents.


That in respect of Para No. 9 it is submitted that this Honourable Court tribunal may allow counsel for the appellant for additional grounds during the course of arguments.
