SUBJECT: JOINT PARA WISE COMMENTS OF RESPONDENTS No.01 & 02

Respectfully Sheweth:-

PRELIMINARY OBJECTION:

- i. That the present service appeal is incompetent in its present form.
- ii. That the appellant has got no locus standi to file the instant appeal.
- iii. That the appellant has estopped by his own conduct to file appeal.
- iv. That the appellant has not come to this Honorable Service Tribunal with clean hands.
- v. That the present appeal is bad for mis-joinder and non-joinder of necessary parties.
- vi. That the present appeal is badly Time-barred.
- vii. That the present appeal is not based on solid ground liable to be dismissed with cost.

FACTUAL OBJECTIONS

1. Pertains to record.
2. Pertains to record.
3. Incorrect and not admitted as per joint seniority list was issued much earlier by Inspector General of Prisons on 24/03/2022 whereas Promotion of Class-IV employees to the Post of Junior Clerk (BPS-11) vide IG Prison office order.No.15623 dated 17/05/2022 in which 12 Class-IV employees were promoted to the post of Junior Clerk (BPS-11).The stance of the appellant that he was placed on Serial No.9 at the revised seniority list on which the respondents No.3 to 8 were shown junior to the appellant was not the promotion order of the appellant but was just a seniority list as stood on 01/01/2022 (**Seniority List 24/03/2022 enclosed as Annex-A**).
4. Incorrect and not admitted as per service rules notified on 15/04/2022 the criteria for Class-IV promotion to the post of Junior Clerk (BPS-11) is as under:-
 - a. The candidates must possess qualification as prescribed in service rules.
 - b. A speed of 30 words per minute in typing in English on computer. within one minute.

c. Two years service as such

Provided that if no suitable official is available for promotion then by initial recruitment. In this connection the Class-IV employees of Prison department were informed in written through Superintendent Jail concerned including the appellant regarding/holding Typing Test which was held in the office of Inspector General of Prisons on 05/04/2022 at 11:00 AM alongwith his other colleagues. The appellant attended the scheduled test, however, the appellant failed this mandatory typing test as evident from his result sheet (**Annex-B**) thus he was found ineligible for his next stage promotion. Only those candidates who qualified the mandatory typing test became eligible for the next stage for promotion to the post of Junior Clerk (BPS-11) vide minutes of the meeting of Departmental Promotion Committee held in the office of Inspector General of Prisons on 05/04/2022 (**minutes enclosed as Annex-C**). Accordingly the Committee examined/scrutinized the panel of the qualified candidates one by one thoroughly. After detailed discussion the Committee unanimously recommended the promotion of 12 candidates of class-IV employees to the post of Junior Clerk (**BPS-11**) under 25 percent quota vide minutes of Departmental Promotion Committee held on 16/05/2022(**Annex-D**). Accordingly the Inspector General of Prisons Khyber Pakhtunkhwa issued office order No.15623 dated 17/05/2022(**Annex-E**) about promotion of Class-IV employees to the post of Junior Clerk against 25% quota.

5. Incorrect and not admitted. As evident from his result sheet of typing test he did not qualify the mandatory typing test and his speed was recorded as 22 words per minute while 30 words per minute were required to qualify the typing test. The non selection was caused by the failure of the mandatory typing test as per service rules.
6. Incorrect and not admitted as per service rules notified on 15/04/2022 typing test was mandatory for the promotion of Class-IV employees to the post of Junior Clerk (BPS-11) as his other colleagues is senior or junior carried out the said test.
7. Incorrect and not admitted as explained in the preceding Para's.
8. Incorrect and not admitted. Rest of the Para are subject to the proof.
9. Not related with answering respondents.

OBJECTION ON GROUNDS.

- A.** Incorrect & misleading as the orders of the competent authorities on 17/05/2022 are legal and according to the service rules of Khyber Pakhtunkhwa. Hence not liable to be set aside.
- B.** Incorrect and not admitted. The respondents treat the appellant as per service rules notified on 15/04/2022 alongwith his other colleagues of his cadre.
- C.** Incorrect and misleading, the detail of this Para is elaborated in Para-B above.
- D.** Incorrect and misleading, the appellant did not qualify the typing test which is mandatory for the promotion of Junior Clerk (BPS-11), however, those who qualified the said typing test were promoted and the appellant was not found suitable due to his failure in typing test.
- E.** Incorrect and misleading. Detail is elaborated in Para-D above.
- F.** Detail is elaborated in Para-A above.


G. Detail is elaborated in Para-04 of the factual objections.


