<u>ORD</u>ER

Syed Mansoor Ali Shah, J.- Briefly the respondents were appointed by the Directorate of FATA (pre-merger) as Certified Teachers, Drawing Masters, Theology Teachers and Arabic Teachers in Grade-09. Similar posts also existed in the Provincial Government of Khyber Pakhtunkhwa. In the year 2014, the Provincial Government upgraded similar post in the Provincial Government from Grade-09 to Grade-15. On the basis of the said notification, the respondents also lodged their claim for upgradation from 2014.

- 2. Learned Additional Advocate General, KPK (representing the petitioners) submits that the Education Department, FATA has no nexus with the Provincial Government and is regulated by the Federal Government. In 2016, the Federal Government upgraded these posts through a notification. He further submits that the claim of the respondents that they ought to be upgraded from the year 2014 is not sustainable because the up-gradation policy of the Provincial Government was not binding on FATA. It is submitted that the admitted position is that the posts held by the respondents stand upgraded to Grade-16 since 2016 as per the policy of the Federal Government.
- 3. Learned counsel for the respondents was asked to show whether the respondents are employees of the Provincial Government, however, he has been unable to refer to any document from the record to establish that the respondents are employees of the Provincial Government.
- In this view of the matter, the impugned judgment of the learned Khyber Pakhtunkhwa Service Tribunal proceeds on a factual misunderstanding that the respondents were earlier employees of the Provincial Government and thereafter deputed to FATA. Employees of FATA are not bound by the Provincial policies

Court Associate Supreme Court of Pakistan Islamabad and have been duly promoted in 2016 under the policy of the Federal Government. The claim of the respondent employees seeking promotion since 2014 on the basis of the Provincial policy is misconceived and not maintainable. In view of the foregoing reasons, the impugned judgment(s) are set aside and the titled

appeals are allowed.
