

PARA WISE COMMENTS ON BEHALF OF RESPONDENT

RESPECTFULLY SHEWETH: -

That the respondents from 1 to 3 submit as under:

PRELIMINARY OBJECTIONS:

1. That the present appellant was appointed as TT in the year 1989 but he cannot be promoted from TT to STT as he did not fulfill the required criteria as per policy, because he obtained his degree from unrecognized institution. Hence the appellant has no cause of action and the instant appeal is liable to be dismissed.
2. That the present Appeal of the Appellant is not maintainable in its present form.
3. That the Appellant has logged the instant Appeal to waste the precious time of this Honorable Services Tribunal.
4. That the case of the Appellant is devoid of merit and having no legal force.
5. That the appeal of the appellant is barred by law and limitation.
6. That the appeal is bad for misjoinder and non-joinder of the necessary parties.

FACTS:

1. That Para No 1 is related to the personal information of the appellant but in fact he is 3rd division at SSC Level and did not get equivalency certificate from the IBCC which is the main requirement for considering his Shahadatul Alamia degree as well as for Khasa. There is the condition of passing of compulsory subjects at HSSC level but he did not pass the compulsory

subjects at FA level hence he does not fulfill the prescribed criteria. Moreover, the degree of Shahadatul Alamia which is mandatory to be obtained from the recognized institutions as enlisted by HEC through a notification but the present petitioner has got the same degree from unrecognized and local institutions that is Etehadul Madaris Mardan which is unrecognized and its degree is unverified. (Annexure A, B & C).

- 2. That para NO. 2 is incorrect and denied, as at that seniority list it was on the basis of his 1st appointment and then after the final seniority list which was prepared on the basis of seniority cum fitness as the appellant having low qualification and the others who were finalized in the seniority list were qualified for promotion and were placed at their own places/position in the seniority list as per qualification, law, rules and policy. (Annexure D)
- 3. That Para No. 3 is incorrect and denied, as the appellant has made concealment of facts because he was not qualified for promotion and the respondents were promoted as they were having the requisite qualification to be promoted to STT. (Annexure E)
- 4. That Para No. 4 is incorrect and denied, the appellant did not submit any appeal to the Office of DEO (M) Bannu, although he was informed and he is well aware of the fact that he is not having the requisite qualification to be promoted from TT to STT.
- 5. That Para No. 5 is related to the appellant and his counsel.

GROUND:


- A. That Para A on ground is incorrect and denied, See Para 1 and 3 on Facts.
- B. That Para B on ground is incorrect and denied, See Para 2 and 3 on Facts.
- C. That Para C on ground is incorrect and denied, that for promotion there is not only the condition of the service but also the qualification as stated in the preceding paras, See Para 3 on Facts.
- D. That Para D on ground is incorrect and denied, this department is always to follow law, rules and policy and believe in equality before law, the present appellant is not qualified to be promoted and hence not entitled.
- E. That Para E on ground is incorrect and denied, no violation of any article has been made and promotion is an opportunity and does not fall in the ambit of fundamental rights, no discrimination what's so ever is made by this department as the whole process has been carried out by the DSC on the basis of seniority cum fitness after scrutiny of all the relevant documents.

PRAYER:

In view of the above made submissions it is requested that this Honorable Services Tribunal may very graciously be please to dismiss the instant appeal with heavy cost.

In pursuance of the recommendations of a Committee held under the Chairmanship of Honorable Minister of State for Federal Education and Professional Training with the Heads of religious Institutions Ittehad-e-Tanzeemat ul Madaris Pakistan and approval thereof by the Higher Education Commission's Equivalence and Accreditation Committee in its 6th Meeting held on 6th February, 2017 under the Chairmanship of Chairman HEC, the following decisions are made and notified for information of all the stakeholders:

- i. Shahadatul Alia fil Ulloomal Arabia wal Islamia will be recognized by HEC as equivalent to Bachelor (Pass) degree upon qualifying compulsory subjects viz. English and Pakistan Studies at Bachelor (Pass) level from AIU or any other Chartered University subject to award of equivalence of Sanvia Aama and Sanvia Khasa by IBCC. Equivalence of Shahadatul Sanvia Aama and Shahadatul Sanvia Khasa will be awarded by IBCC as per their recommendations.
 - ii. The concerned Wafaq may admit the students towards Shahadatul Sanvia Aama as per their own system of education i.e. Mutawasta equivalent to Middle standard and HEC will not require Middle School Certificate from the holders of Deeni Asnad.
 - iii. The students who are desirous to get admission in formal Master degree (other than Islamic Studies or Arabic) in a University after Shahadatul Alia may opt any other two (02) elective subjects (other than Arabic and Islamic Studies) in addition to compulsory subjects as per their discretion.
2. This issues with the approval of the Competent Authority.





English and Pakistan Studies at Bachelor(Pass) level from AIOU or any other Chartered University subject to award of equivalence of Sanvia Aama and Sanvia Khasa by IBCC as Matric and Intermediate, respectively. Equivalence of Shahadatul Sanvia Aama and Shahadatul Sanvia Khasa will be awarded by Inter Board Committee of Chairmen (IBCC).

The Government of Pakistan has established Pakistan Madrasah Education Board (PMEB) under an Ordinance No.XL of 2001, dated 18th August, 2001 and Directorate of General of Religious Education (DGRE) dated October 22, 2019. Both the organizations are empowered to register Deeni Madaris and to prescribe conditions for their working including development of Curriculum and required scheme of studies etc.



In pursuance of the recommendations of a Committee held under the Chairmanship of Honorable Minister of State for Federal Education and Professional Training with the Heads of religious Institutions Inshaa-e-Taqdeerat ul Madaris Pakistan and approval thereof by the Higher Education Commission's Equivalence and Accreditation Committee in its 6th Meeting held on 6th February, 2017 under the Chairmanship of Chairman HEC, the following decisions are made and notified for information of all the stakeholders:

- i. Shakhadati Alia fi Uloomul Arabia wal Islaamia will be recognized by HEC as equivalent to Bachelor (Pass) degree upon qualifying compulsory subjects via English and Pakistan Studies at Bachelor (Pass) level from AIQU or any other Chartered University subject to award of equivalence of Saqaf Aama and Saqaf Khass by IBCC. Equivalence of Shakhadati Saqaf Aama and Shakhadati Saqaf Khass will be awarded by IBCC as per their recommendations.
- ii. The concerned Waqf may admit the students towards Shakhadati Saqaf Aama as per their own system of education i.e. Matriculate equivalent to Middle standard and HEC will not require Middle School Certificate from the holders of Deeni Aamad.
- iii. The students who are desirous to get admission in formal Master degree (other than Islamic Studies or Arabic) at a University after Shakhadati Alia may opt any other two (02) elective subjects (other than Arabic and Islamic Studies) in addition to compulsory subjects as per their discretion.
