**ORDER**

The appellant Ex-FC Shakeel Nasir No. 169 was dismissed from service vide Special Branch Establishment Order dated 25.06.2020 due to his involvement in criminal case vide FIR No. 06 dated 05.01.2020 u/s 302/324/148/149 PPC PS Yaqoob Khan Shaheed, Takht-i-Nasrati, district Karak. His departmental appeal was rejected vide Order No. 6102-5/EB dated 04.08.2020 while the revision petition was also rejected vide Order No. S/1170/21 dated 17.03.2021.

2. The appellant, thereafter, filed Service Appeal No. 191/2023 before the Hon'ble Khyber Pakhtunkhwa Service Tribunal, with the following prayers;

*"On acceptance of the appeal, orders dated 25.06.2020, 04.08.2020 and 17.03.2021 of the respondents be set aside and appellant be reinstated in service with all consequential benefits."*

3. The Hon'ble Khyber Pakhtunkhwa Service Tribunal vide judgment dated 19.12.2023 in the following terms;

*"In view of the above, the appeal in hand is accepted and appellant is reinstated in service with all back benefits".*

4. The Hon'ble Supreme Court of Pakistan in numerous cases wherein the Government servants were reinstated with all back benefits by the Services Tribunals denied back benefits on the basis of 'No Work-No Pay principle' reliance is placed on the august Apex Court judgment dated 11.02.2021 in CP Nos. 517-L, 1019-L, 1062-L & 1232-L of 2016 and 1929-L/2017 & Civil Petition No. 1066 of 2022 titled Rahimullah Khan vs Deputy Postmaster General Sothern Postal Region, Khyber Pakhtunkhwa & others.

5. In compliance of the Hon'ble Khyber Pakhtunkhwa Service Tribunal judgment dated 19.12.2023, FC Shakcel Nasir No. 169 is being reinstated into service with immediate effect. As the appellant has been reinstated with all back benefits by the Hon'ble Service Tribunal and to comply with Judgment of Hon'ble Service Tribunal, his period during which he

remained dismissed, he is being paid at rate of Rs. 100/ month as his salary i.e. from 25.06.2020 upto 10.09.2024 which makes period of total 04 years, 02 months & 15 days under sub rule (b) of Rule-54 of Fundamental Rules.

6. This order is issued in above terms.
