



**IMPLEMENTATION PETITION FOR DIRECTING THE
RESPONDENTS TO IMPLEMENT THE JUDGEMENT
DATED 13-06-2024 OF HONORABLE TRIBUNAL IN
APPEAL NO.242/2023 WITH LETTER AND SPIRIT.**

RESPECTFULLY SHEWETH:

Brief facts giving rise to present petition are as under:-

1. That the Petitioner actual date of S.I promotion is 20-02-2001 and SI Confirmation date is 20-02-2003, whereas malafidly/intentionally **on the eve of SP promotion** it has been Shown/Written incorrect dates i-e (20-02-2002&2003) and S.I confirmation dates i-e (20-02-2004&2005) in the DSP Seniority Lists, due to which the Petitioner Seniority badly affected/fall-down from S/No.37 to 63 & 67 and dropped from promotion (Page# 1 to 13).
2. That the Petitioner filed an Service Appeal No.242/2023 in this Honorable Tribunal against the Notification dated 05-09-2022, whereby junior have been promoted as Superintendent of Police (BS-18) by this deliberate incorrect dates insertion of SI Promotion and Confirmation of Appellant in DSP Seniority Lists and against not taking any action the on the representations of Appellant with the statutory period.


3. That the said appeal was finally heard by the learned Members of Bench on 13-06-2024 and the Honorable Tribunal was kind enough to accept the appeal of the petitioner, the Tribunal judged at Para #6 that "promotion which is against the rules, because 33 junior to the appellant was promoted by the respondent and it is due to preparation of seniority list having wrong details about appellant and due to inefficiency of the staff/ dealing clerks of the respondents establishment who were involved in the process of seniority lists of the appellant's cadre".
4. That honorable Tribunal in the judgment further said at Para # 7 that "We are unison to hold that appellant despite being senior, wrongly ignored against the rules by the respondent for promotion to the post of SP, therefore appeal is accepted as prayed for".
5. That the Petitioner meanwhile deprived again from SP promotion in DSB on 17-10-2023, at S/No.67 from suffered/disturbed Seniority List, with remarks that Petitioner appealed in Service Tribunal Peshawar and most junior/blue eyed officials were promoted as SP vide Notification SO(Police-II)HD/8-10/DSB&DPC/2023, dated 20th December 2023 (Page# 41 to 46).
6. That after issuing the judgment dated 13-06-2024 of the Honorable Tribunal, the petitioner Submitted application to the respondent department to kindly pass an appropriate orders according the judgment of the this Honorable Tribunal, but the respondent department failed to obey the judgment of this honorable Tribunal(Page# 48 to 50).
7. That since the announcement of the judgment of the Tribunal, the respondents are not willing to act as per judgment of the Honorable Tribunal due to which the petitioner is facing hardship and deprived from due rights.
8. That being the judgment of the legal forum, the respondents are legally bound to obey the judgment of this Tribunal in letter and spirit.
9. That in-action and not fulfilling formal requirements by the respondents after passing the judgment of this august Tribunal, is totally illegal amount to disobedience and contempt of Court.
10. That the judgment is still in the field and has not been suspended or set-aside by the Supreme Court of Pakistan, therefore, the respondents are legally bound to pass formal appropriate orders.

11. That having no other remedy, the appellant is constrained to file the present implementation petitioner.


It is, therefore, most humbly prayed that the respondents may be directed to implement the judgment of this august Tribunal in letter and spirit and to pass an appropriate SP promotion orders w.e.f. 05-09-2022 with all consequential/back benefits of the appellant as mentioned in the judgment dated 13-06-2024 with correction of Seniority List with position and date of promotion as SI i-e 20-02-2001 and Si confirmation i-e 20-02-2003. Any other remedy, which this august Tribunal deems fit and appropriate that, may also be awarded in favour of petitioner.







JUDGMENT


RASHIDA BANO, MEMBER (J): The instant service appeal has been instituted under section 4 of the Khyber Pakhtunkhwa Service Tribunal, Act 1974 with the prayer copied as below:

“That on acceptance of this appeal, the impugned promotion order dated 05.04.2022 may be set aside and the respondents may be directed to consider the appellant for promotion as SP from the date when juniors to appellant were promoted on 04.09.2022 with all back and consequential benefits with further directions to the respondents to correctly record the dates of S.I promotion (20.02.2001) and confirmation as S.I (20.02.2003) in the service record of appellant as well as in DSP's seniority lists. Any other remedy which this august tribunal deems fit and appropriate that may also be awarded in favor of the appellant.”

2. Brief facts of the case as given in the memorandum of appeal are that The appellant joined the Police Force (FRP) in 1991 and was promoted to various positions, including officiating Head Constable, ASI, Official S.I, officiating Inspector, and DSP. He was reverted to the rank of Head Constable in 2007 and placed in list "D" of officiating ASIs. He challenged these orders in service appeals, which were accepted. The appellant also filed service appeals against orders dated 30.07.2020 and 20.02.2003, which were decided in his favor. The respondent filed appeal No.164-P/2014 in the apex court, which was decided on 07.10.2020. A committee was constituted, and the Inspector General of Police, Khyber Pakhtunkhwa, issued a notification on 22.12.2020, placing the appellant's name below Falák Naz and above Ishtiaq Ahmed in the seniority list of DSPs. The appellant objected to the corrected seniority list and filed an application for correction. A committee approved the correction on 25.07.2022, and another seniority list was issued on 05.08.2022, placing the appellant's name at 67. The appellant objected to the corrected list and the respondent issued an impugned promotion order on 05.09.2022, where juniors were promoted and the appellant was ignored. He filed a departmental appeal on 26.06.2022, which was not responded to, hence the present service appeal.

3. Respondents were put on notice who submitted their comments on the appeal. We heard the learned counsel for the appellant as well as learned District Attorney for the respondents and perused the case file with connected documents in detail.

4. The Learned counsel for the appellant reiterated the facts and grounds detailed in the memo and grounds of the appeal while the learned District Attorney controverted the same by supporting the impugned order.

5. Perusal of record reveals that the appellant joined the Police Force (FRP) as Constable in the year 1991. The appellant after qualifying the requisite trainings was promoted as Head Constable on 14.04.1998, officiating ASI on 04.04.2000, promoted as S.I under Police Rules 13:18 on 20.02.2001, and also promoted as officiating Inspector on 30.07.2010, and DSP on 30.01.2018. While performing duties as Sub Inspector, the appellant was reverted to the rank of Head Constable on 26.10.200 and also name was placed in list "D" of officiating Assistant Sub Inspectors. The appellant challenged those orders in Service Appeal No.1101/2007 in this August Tribunal. The said appeal was finally heard on 23.09.2008 and the appeal was accepted as prayed for. The respondent filed CPLA No.193-P/2009 in the apex court, but same was dismissed as barred by time. The appellant also filed service appeal (No.407/2011) against the order dated 30.07.2010 whereby his name was included in list "F" with immediate effect, instead of 20.02.2003. The said appeal was accepted with directions of enlisting his name in list "F" w.e.f. 20.02.2003 with all consequential/benefits. The respondents filed appeal No.164-P/2014 in the apex court. The apex court decided the appeal on 07.10.2020 and remanded the case to the department to correctly determine the seniority after hearing all police officials who may be affected. A committee was constituted and submitted his recommendations on 23.11.2020. The Additional IGP (Hq) issued the notification on 22.12.2020, based on


recommendation of the committee, wherein the appellant's name was placed below the name of Falak Niaz and above the name of Ishtiaq Ahmad in the seniority list of DSPs. The same decision/compliance was also communicated to the worthy Registrar, Supreme Court of Pakistan on 30.12.2020. The Corrected Seniority list of DSPs was issued on 21.02.2022 by the respondents, wherein the name of the appellant was placed at serial No.37 i.e. after Falak Niaz and above Ishtiaq Ahmad. The CCPO's office has also communicated the correct dates confirmation as ASI, SI and Inspector of the appellant to the AIG (HQ) office, vide memo dated 29.04.2022 and also enclosed the copies of precious correspondence.

6. Appellant's name in accordance with correct seniority list for the year 2021 issued on 02/12/2022 was placed at his proper and correct seniority position at Serial No.37 below the name of the Falak Niaz DSP and above the name of Ishtiaq Ahmad DSP. This seniority list was issued after hearing all the affected employees upon in light of direction of apex court of the country. Recommendation in shape of compliance report was also sent by the respondent to worthy Supreme Court of Pakistan on 30.12.2020. We fail to understand that when seniority of the appellant was corrected in light of direction of the Supreme Court and said [factum of correctness was also communicated to the IGP, KPK by the CCPO on 06/09/2021] by placing name of the appellant at proper place at Serial No.9 having correct dates of promotion as officiating S.I on 20.02.2001 and confirmed S.I 20.02.2003. This information was given by CCPO for the purpose of promotion to the rank of [SP]. This information about date of confirmation as S.I 20.02.2003 was also

communicated to AIG (HQ) by CCPO vide memo dated 29.04.2022 despite having correct information about correct placement of the appellant at his proper seniority position but respondents/establishment issued seniority list of DSPs on 28.07.2022 for year 2022 wherein again appellant was placed at wrong seniority position at serial No.63 which is against the rules and even violation of report of the committee submitted to worthy Supreme Court of Pakistan. Appellant alongwith others applied for correction of seniority list upon which committee constituted, who recommended correction in the seniority list, when again committee recommended correction then it was incumbent upon the respondents establishment to issue correct seniority list and after correction of seniority proceed with promotion of the DSPs to the post of S.P but respondents despite knowing about correct seniority position, considered the juniors to the appellant in the meeting and promoted them by ignoring the appellant vide impugned notification. DSPs Falak Niaz and Mr. Ishtiaz Ahmad above and below the appellant after his proper placement in seniority list of year 2021 prepared in accordance with recommendation of committee constituted upon direction of the worthy Supreme Court of Pakistan, was promoted which is against the rules, because 33 Juniors to the appellant was promoted by the respondent and it is due to preparation of seniority list having wrong details about appellant and due to inefficiency of the staff/dealing clerks of the respondents establishment who were involved in the process of preparation of seniority lists of the appellant's cadre.

7. We are unison to hold that appellant despite being senior, wrongly ignored against the rules by the respondent for promotion to the post of SP,





LIGHT OF HON'BLE PESHAWAR HIGH COURT CONSOLIDATED JUDGMENT
DATED 29.08.2023

Memo:

It has been observed that the regions and districts are seeking guidance time and again regarding the promotions/ confirmations of Out of Turn Promoted Officers of KP Police.

2. The Hon'ble Peshawar High Court, Peshawar has passed a detailed judgment dated 29.08.2023, in the matter of Out of Turn Promotions in Writ Petition No. 1587-P/2022 and other connected cases.

3. The Hon'ble Court has struck down and dismissed the petitions of officers promoted on gallantry basis, therefore, their demotions orders stand effective from their respective dates of issuance and may be treated accordingly. Similarly, the one step promotions earlier granted by the Regions in the wake of terrorism under the category of gallantry acts, are also stand withdrawn.

4. While petitions to the extent of cadets/ cadet instructors, inter-provincial transfers/ absorptions, absorption cases of Executive Constables of KP Police into Telecommunication and Transport Unit of KP and allotment of additional seats for trainings have been accepted and granted relief. Therefore, the promotions/ confirmations of such officers may be processed in compliance with above mentioned

judgment of Hon'ble Peshawar High Court, Peshawar provisionally/ conditionally subject to outcome of respective CPLAs which have been instituted against the judgment dated 29.08.2023 in the Hon'ble Apex Court against categories granted relief as mentioned above.

5. The Hon'ble Peshawar High Court has remitted back the cases of women officers, absorption cases of Class-IV employees as Constables into Telecommunication & Transport Cadre of KP Police to the department. Regarding these remitted cases, KP Police will hear petitioners and issue Speaking Orders separately while keeping in view judgments of Hon'ble Supreme Court of Pakistan on Out of Turn Promotions cases.

6. The Hon'ble Peshawar High Court has also remitted some Out of Turn Promotions cases (beneficiaries of accelerated promotional courses from FRP Unit) to the Hon'ble Khyber Pakhtunkhwa Service Tribunal, Peshawar vide separate judgments dated 29.08.2023 passed in Writ Petition No. 1289-P/2023 titled Tayyab Jan etc & Writ Petition No. 2191-P/2023 titled Muhammad Iqbal Vs Govt: of Khyber Pakhtunkhwa etc. The promotions/ confirmations of officers of this category may not be carried out being sub-judice in separate CPLAs before Apex Court as well as before the Hon'ble Service Tribunal.

7. Whereas, above mentioned consolidated judgment of the Hon'ble Peshawar High Court, Peshawar appears silent regarding cases of drill/ physical instructors seeking benefits under Standing Order No. 17/2014. However, same incentives have been dismissed by the Hon'ble Peshawar High Court in its Larger Bench judgment dated 30.11.2022 in W.P No. 1716-P/2020. Recently, another Writ Petition No. 3944-P/2023 of alike nature has also been dismissed by the Hon'ble Peshawar High Court, Peshawar vide judgment dated 11.10.2023 in the light of aforementioned Larger Bench judgment. Therefore, all Out of Turn Promotions / Confirmations cases pertaining to drill/ physical instructors stand withdrawn, their seniority reckoned along with their hatchmates and demotion orders issued under said category stand enforced.

8. Moreover, the Out of Turn Promotions cases in which promotions were granted without undergoing prescribed trainings/ courses, the above consolidated judgment of Hon'ble Peshawar High Court is apparently silent. However, such cases also fall under Out of Turn Promotions and therefore, the same may also be considered as withdrawn. Besides, demotion orders issued against any other category of Out of Turn Promotions may also be considered as stood validated and hence such demotion orders are to be implemented.

9. Keeping in view the above, promotions/ confirmations may be granted after completing all codal formalities to only those Out of Turn Promotees whose petitions are accepted by the Peshawar High Court, i.e. Cadets/ instructors, inter-provincial transfers/ absorptions and allotment of additional/ extra seats for trainings provisionally/ conditionally subject to outcome of respective CPLAs lodged by the Police department in the Hon'ble Supreme Court of Pakistan.

With profound respect it is submitted that as per my Service record in CCP Peshawar & CPO my accurate Sub-Inspector promotion date is 20-02-2001 and SI confirmation date is 20-02-2003 vide CCPO Peshawar letter No.15529/EC-I, dated 06-09-2021 and vide letter No.3039/EC-I, dated 04-11-2021 and letter No.8224/EC-I, dated 08-05-2024.

1. My name was at Serial No.37 in the seniority list of DSsP issued vide CPO No.352/SE-I, dated 21-02-2022.

2. In seniority List of DSsP issued vide No.1355/SE-I, dated 28-06-2022, my date of Promotion as Sub-Inspector was cited incorrect (14.10.2002) instead of accurate date (20.02.2001) as well as my SI confirmation date was also narrated incorrect (14.10.2004) instead of accurate date is (20.02.2003), due to which my seniority fallen from S/No.37 to Serial No.63 in the said DSP Seniority list.

3. In this connection the C.C.P.O Peshawar replied to CPO numerously vide letter No.13068/EC-I, dated 19.07.2022, vide letter No.13316/EC-I, dated 22.07.2022 and as well as again replied in tabulated form vide letter No.13467/EC-I, dated 27.07.2022 that my date of Promotion as Sub-Inspector is 20.02.2001 and SI Confirmation is 20.02.2003.

4. Unexpectedly, in the Final Seniority List of DSsP issued vide No.1594/SE-I, dated 05.08.2022 my date of Promotion as Sub-Inspector was mentioned again incorrect as 20.02.2003 instead of 20.02.2001 and SI Confirmation was narrated 20.02.2005 instead of 20-02-2003, and my seniority was fallen at S/No.67 from S/No. 37 & 63.

5. The CCPO Peshawar again immediately rectified and replied to CPO vide his letter No.14398/EC-I, dated 12.08.2022, wherein it was intimated with enclosures that as per record of CCP Peshawar, my date of Promotion as Sub-Inspector is 20.02.2001 and SI Confirmation is 20.02.2003.

6. I was deprived malafidly from my due promotion to the Rank of SP (BS-18) in DSB dated 19-08-2022 and again 2nd DSB held on 17-10-202, despite my clear-cut position/Record with clean PER, subsequently my colleague's and juniors to me were promoted to rank of Superintendent of Police (BS-18).

7. Lamentably, for a lengthy period (2003-2024), I was **spitefully**, deliberately victimized from my due rights by various tactics without any guilt. Being aggrieved, I instituted appeals twice in Service Tribunal Peshawar vide Appeals No.1101/2007 and No.407/2011, in High Court Peshawar vide Writ-Petition No.3957-P/2016 and **Four times** heard in Supreme Court of Pakistan: Finally the Honorable **Supreme Court of Pakistan**, after threadbare hearing, restore my due rights, seniority/confirmation vide Civil Appeal No.164-P/2014 dated 17.10.2020. The CPO issued revised Notification No. CPO/E-I/Seniority/ Amendment/corrigendum/2411 dated 22.12.2020.

8. My submitted appeals regarding correction of my SI promotion & confirmation dates, with records were not entertained by the authorities, therefore. I again prayed for justice vides Appeal No.242/2023 in Service Tribunal Peshawar. The Honorable Tribunal after threadbare argument, accepted the pray of appellant on 13-06-2024 that *"appellant despite being senior, wrongly ignored against the rules by the respondent for promotion to the post of SP, therefore, appeal in hand is accepted as prayed for"*.

It is, therefore, humbly requested that the judgments-dated 13.06.2024 of Honorable Service Tribunal Peshawar in Appeal No.242/2023 may kindly be implemented and my seniority/promotion with my colleagues promoted in DSB dated 19.08.2022 may very kindly be accorded with all consequential/back benefits. The accurate date of Promotion as SI i.e. 20.02.2001 and SI confirmation is 20.02.2003 may also kindly be made in my seniority list and records.

I shall be ever pray for your long life and prosperity.


