1. That the above title Appeal was pending before this Hon,ble court and which was fixed on dated 05/07/2024.


2. That the appeal was dismissed in default for non appearance. (*Attested copy of the order is annexed*)

It is, therefore, humbly prayed that on acceptance of this application, subject appeal may kindly be restored and decide on merit.


