- 20. Correct. The services of the appellant have been regularized with effect from 13-01-2022 in light of the Khyber Pakhtunkhwa (Regularization of services of employees of Erstwhile Federally Administered Tribal Areas) Act, 2021 as explained in Para-19.
- 21. Correct. The appellant stood retire from service with effect from 03-10-2023 on attaining the age of superannuation in light of Planning & Development Department order dated: 12-10-2023.
- 22. Pertains to record.
- 23. Correct. As explain in preceding para the appellant does not fulfill the requisite criteria for eligibility of pension i.e. 10 years regular service. Therefore, his claim for pension was regretted.

GROUNDS:

- A. Incorrect & misconceived. The appellant has been treated in accordance with law, Rules and principles of natural justice hence, Article 4 & 25 of the Constitution of Islamic Republic of Pakistan 1973 have not been violated by the respondents.
- B. Incorrect. The appellant has appealed for grant of pay fixation for the purpose of pension and other emoluments with all back benefits not for promotion.
- C. Incorrect. No discrimination has been committed against the appellant; therefore, the respondents did not violate the principle of natural justice.
- D. Incorrect & misleading. Since the appellant was a project employee of the Government of Khyber Pakhtunkhwa therefore, the prevailing pension Rules i.e. "KHYBER PAKHTUNKHWA CIVIL SERVANTS PENSION RULES, 2021" is applicable on him and as per section 3(1)(a) of the ibid Rules "the service

shall not be less than ten years". However, the appellant has only 01 year & 09 Months regular service at his credit.

- E. Incorrect & misleading. Interpretation of Article 371- A of C.S.R made by the apex Court; it is concluded that the service rendered on contract followed by regularization could only be counted for pensionary benefits provided that the civil servant has completed qualifying ten years' service independently.
- F. Subject to proof.
- G. As replied in above paras.
- H. Incorrect. Already replied in para "D" above.
- I. Incorrect. Finance Department vide notification dated: 26-09-2019 regularized fixed pay Class-IV employees whereas the services of the appellant were on contract basis under agreement signed with United Nations.
- J. Incorrect. As per policy of the Provincial Government contract/temporary service which has not been regularized/confirmed through legal instrument is not countable for the purpose of pensionery benefits.
- K. No comments. However, the replying respondents seek permission of this Honorable Tribunal to adduce other grounds during final hearing of the case.

PRAYER:

Keeping in view of the above; it is very humbly prayed that the instant Service Appeal of the appellant may graciously be dismissed with cost.



CLARIFICATION REGARDING PROCESSING OF PENSION CASE OF MR. MIK

Dear Sir.

I am directed to refer to the subject noted above and to enclose herewith a copy of an application dated nil addressed to the Deputy Secretary (Admn), P&D Department received from Mr. Mir Azam Khan, Ex-Naib Qasid, Khyber Area Development Project, SDU, P&D Department for grant of for release of pensionary benefits along with Leave Encashment, Senevolent Fund, GP Fund & RB&DC Fund.

Brief History of the case is that Mr. Mir Azam Khan was Initially appointed on project post as Naib Qasid on 01.07.1987 in the Special Development Unit of Khyber Pakhtunkhwa (Annex-I). After 15 years of service on contract basis, he was transferred to the Khyber Area Development Project through proper channel vide office order dated 07.03.2022 (Annex-II). Recently, his services have been regularized on 30.06.2022 (Annex-III) under the "Khyber Pakhtunkhwa (Regularization of Services of Employees or Erstwhile Federally Administered Tribal Areas) Act, 2021" w.e.f 13.01.2022 and the applicant has rendered 01 year 09 months as regular employee. Now, upon attaining the age of superannuation, Mr. Mir Azam Khan has retired from government service on 03.10.2023 vide Planning & Development Department Order dated 12.10.2023 (Annex-IV). Subsequently, he has requested for pensionary benefits by counting his previous service even though he wasn't a regular employee at that time in light of the Finance Department Notification dated 22.05.2019 and the Finance Department letter dated 26.07.2023 (Annex-V & VI).

In view of above, it is requested that this Department may be guided whether Mr. Mir Azam Khan, Ex-Naib Qasid, KADP, SDU P&D Department is eligible for pension along with other benefits by counting his previous service rendered by him as project employee in light of the Finance Department Notification referred above, please.


