Respectfully sheweth:

PRELIMNARY OBJECTIONS

- 1. That the Appellant is not an "aggrieved" person with the meaning of Section 4 of the Khyber Pakhtunkhwa Service Tribunal Act 1974.
- 2. That the Appellant has got no cause of action /locus standi to file this service appeal because the Appellant did not come on merit.
- 3. That the Appellant has not come to this Honorable court with clean hands rather than the instant service appeal is mainly based on malafide intentions just to put pressure on the respondent department for illegal Pay Protection.
- 4. That the Appellant is estopped by her own conduct.
- 5. That the instant service appeal suffers from laches, hence not maintainable in the present form.
- 6. That the service appeal in hand is badly barred by the relevant provision of Law/Rules/Policy in Field.
- 7. That the appellant was appointed as C.T on Adhoc/school bases for one year, hence not entitled for apply through proper channel
- 8. That no NOC has been issued to the appellant for apply through proper channel.
- 9. That the appellant was appointed as C.T BPS-15 and serving as C.T BPS-15 too, while malafidely she has mentioned her post as PST BPS-12 in the title of the service appeal as well as facts and grounds of the service appeal.

ON FACTS

1) Para -1 of the facts is incorrect hence denied and further stated that the appellant was not appointed as PST BPS-12, but CT BPS-15 vide order dated 05-03-2016 at GGMS Sadbar Kalay Samarbagh in her own opted school on adhoc/school based wherein in the terms and

condition No.7 the appointment order ibid, it was clearly mentioned that the appointment will be on school based, they will have to serve at the place of posting, and their service is not transferable to any other station. Meanwhile, another advertisement for different teaching cadres posts including the posts of CT BPS-15 was also advertised in which the petitioner directly applied to the vacant posts of C.T BPS-15 without NOC, and again secured high marks in her own opted school and were appointed accordingly vide order dated 28-03-2017, on adhoc / school based later on regularized as C.T BPS-15 vide regularization order dated 12-03-2018 w.e.f 28-03-2017. Furthermore, same nature issue has been decided by the Honorable Peshawar High Court Peshawar in W.P No.5181-P/2020 dated 10-06-2021. (Copy of the appointment order dated 05-03-2016 is attached as "A", (Copy of the appointment order dated 12-03-2018 is attached as "B", Copy of the regularization order dated 12-03-2018 is attached as "C", Copy of the judgment dated 10-06-2021 in W.P 5181-P/2020 is attached as "D")

2) Para -2 Is incorrect. The appellant had not applied through proper channel. Moreover, the appellant was not appointed as PST BPS-12 but C.T BPS-15 vides order dated 05-03-2016 on adhoc/school based at GGMS Sadbar Kalay Samarbagh at S.No 34 just for one year as per term and condition No.1 of the appointment order reproduced as "1. The order will commence from 07-03-2016 and shall continue up to 06-03-2017 and this offer will however, not construe in any form, either express or implied any assurance for future employment with the Elementary and Secondary Education Department.

As the school GGMS Sadbar Kalay Samarbagh was far away from her place of residence, so she again applied to the new advertised school based posts and after securing high marks, she was again appointed as C.T BPS-15' vide order dated 28-03-2017on adhoc/school based at GGHS Bagh Dushkeil at serial No.34.

- 3) Para -3 of the facts is correct to the extent that the appellant was regularized w.e.f. 28-03-2017 vide regularization order dated 12-03-2018, because she left her previous post of C.T BPS-15 by taking over the charge of C.T BPS-15 on new station on adhoc/school based.
- 4) Para-4 of the facts pertains to record. However, pay protection cannot be granted to the appellant as per Govt of Khyber Pakhtunkhwa Finance Department Notification No FD(SOSR-1)12-2/2020 (34323) dated 18/3/2021.
 - (Copy of the Finance notification dated 18-03-2021 is attached as Annexure-E)
- 5) Para -5 of the facts is incorrect and further stated the instant service appeal is badly barred by the relevant provision of Law/Rules/Policy in Field as the regularization order of the appellant as issued vide order dated 12-03-2018, while she has filed the instant service appeal in the year 2024.
- 6) Para-6 of the facts needs no comments.

GROUNDS

A. In correct and not admitted. The stand of the Appellant is without any moral and legal justification on the grounds that the appellant has been treated as per law and policies' fact the appellant is neither entitled nor eligible for pay fixation and protection w.e.f 05-03-2016 because







S M ATTIQUE SHAH, J: - The petitioners have invoked the Constitutional jurisdiction of this Court under Article-199 of the Constitution of Islamic Republic of Pakistan, 1973, seeking the following prayer;

"It is, therefore, prayed that by accepting this petition;

a writ of certiorari may please be issued to declare the impugned regularization order respectively attached as annex "G" to "GBA", whereby putitioners initial, had date of entry in service has well, when mentioned, be declared as illegal unlawful, against the mandate of section-I of the Khyber Pakhtankhwa Employees of Elementary & Scenndary Education Department (Appalments).

Regularization of Services) Act, 2017 and thus ineffective upon the rights of petitioners;

a writ of mandamus may be leveled by directing the respondents to issue a formal regularization order of petitioners from the dute/day of their first entry in service as thown in column No.3 of annexure "A".

or

Any other relief deems fit and appropriate in the circumstances of the case may be granted in favour of the petitioners."

In essence, grievance of the petitioners is that, respondents advertized the posts of SST, CT, 181, AT, TT Qari, PET, DM etc in the newspaper in the year 2014-15; that the petitioners applied for the said posts respectively and; succeeded in written test, interview and; were appointed against the ibid posts respectively. Subsequently, the respondents advertised some other posts of SST, CT, AT, PST, PET etc, for which the petitioners also applied, wherein, they succeeded and; were accordingly appointed; that the petitioners relieved from the earlier posts and assumed their duties at the newly appointment places on the same date without gap of a single day and were in continuous service; that the Government of Khyber Pakhtunkhwa enacted an Act i.e.

Khyber Pakhtunkhwa Employees of E&SE Department (Appointment & Regularization of Services) Act, 2017, whereby under section-3 of the Act, the services of all the contract employees were regularized from the day of their initial appointment; that the respondents issued the impugned regularization errice of petitiohers, however, their date of initial appointment was wrongly shown in the impugned orders as their second date of appointment was shown instead of their first date of appointment; that being aggrieved some of the petitioners approached the respondents for correction of date of first entry in regularization, however, their appeals were neither considered nor decided till date, hence, the petitioners have approached this Court for redressal of their grievance by filing the instant writ petition.

- 3. The respondents were put on notice with direction to file the requisite para-wise comments to the writ petition, which were submitted accordingly; whereby they strongly resisted the claim of the petitioners.
- 4. Arguments of learned counsel for the parties heard and available record gone through with their able assistance:

- Perusal of record reveals that the petitioners were appointed in the year 2015 for a period of one year on adhoc, temporary and; contract basis. During the period of their service, the respondents advertised some other posts and; the petitioners also applied alongwith others for the said posts and, were accordingly appointed against the said posts after their selection. Meanwhile, during the currency of their service, the Government of which Pakhtunkhwa passed regularization Act, 2018, whereby the services of the petitioners were regularized pursuant to the ibid regularization from the date of their first appointment i.e from the year 2015.
- this Court in the instant case is that whether the regularization of the pelitioners is to be considered from the date of their first appointment i.e 2015 or from the date of their subsequent appointment i.e 2017. Indeed, upon the subsequent advertisement and; appointment thereunder, the petitioners left their earlier service and opted for their fresh appointment and; therefore, the question of first appointment had lost its significance for having because a past and closed transaction. Thus, the

their regularization under the Act, 2018, as the subsequent appointment of the petitioners was a fresh appointment for all practical and material purposes and; the same cannot be considered as continuation of their earlier service. Therefore, the respondents had rightly not so considered the same for the regularization of the services of the petitioners.

In view of the above, the instant writ petition is dismissed being meritless.
