Respectfully Sheweth: -

**PRELIMINARY OBJECTIONS:**

1. That this office has never delayed the implementation of the decision of this Honorable Services Tribunal.
2. That the seniority list is already been prepared according to the rules and policy of all Class-IV employees as per the direction of this Honorable Services Tribunal and the petitioner has been placed at his own place.
3. That the department has called DSC meeting and after fulfilling the codal formalities he cannot be considered for promotions as he is at S.No. 48, therefore, the execution petition may kindly be dismissed in the favor of department.
4. That the present Objection Petition to the Compliance report is just to pressurize the respondents unduly as the respondents has already submitted a detailed compliance report in this Honorable Tribunal.

**ON FACTS:**

1. That the respondent has initiated the process for putting the petitioner in its original position as per the decision of this Honorable Services tribunal as working paper was prepared and final seniority list of all Class-IV employees was finalized therein according to 2013 rules and the petitioner did not fall in the ambit of promotion zone, they will be promoted as per their own turn. And in the current scenario they cannot be considered for promotions as he is at S.No. 48 and it will open a new Pandora box for the other Class-IV employees who are senior than the petitioner in the seniority list (Annexure A & B).



2. That Para No 2 is incorrect and denied up to the non-consideration of the present petitioner for promotion, wherein the present petitioner along with others was considered for promotion under departmental policy Notification 2013 while the policy notification of the year 2019 is for establishment department and has nothing to do with this department as it has its own policy. For rest of the para and consideration of the one Rasool Khan Daftari and others, this department has followed the law, rules and policy and amendment in the year 2014 which is clear about the promotion of Daftari and a typing speed as well as the cushion period of 6 months for promotion and if not improved shall be reverted as the case may be. (Annexure C & D)
3. That Para No 3 is incorrect and denied, as this office has always to follow law, rules and policy and has implemented the order of this Honorable Services Tribunal in its letter and spirit and compliance report has submitted accordingly in this Honorable Services Tribunal but despite of that this Objection Petition, the petitioners are trying to present their case with twisted facts and figures which if accepted will be a wrong precedents for others and will work as a flood gate for all such like cases and will become an unending chain of litigation. In such like situation there is a legal maxim where two wrongs cannot make one right, (Annexure E)

**PRAYER:**

In view of the above made submissions it is requested that this Hon'ble Service Tribunal may very graciously be please to dismiss the instant execution petition with heavy cost.





**Minutes of the Meeting of Departmental Promotion Committee**

A Meeting of Departmental Promotion Committee was held on dated; 28-06-2024 at 11.30 AM at DEO (M) Office Bannu under the Chairmanship of DEO(M) Bannu, to discuss the promotion cases of Class-IV Govt: servant to the post of Junior Clerks on seniority cum fitness as per Govt: policy, and in the light of Scrutiny Committee / DRC.

The following Officers/Officials attended the meeting: -

01	Nisar Ahmad Appointing Authority	Chairman

The meeting started with the recitation from the Holy Quran. The Chairman welcomed the participants of the meeting and directed the Dealing Assistant to discuss the agenda points with the participants of the meeting. The Dealing Assistant explained that in the year 2022-23, 39 post of J/Clerks were vacant and during the process of promotion from Class-IV to J/Clerks, 13 Class-IV have been promoted out of 33 % quota vide order No. 15708-24 dated; 4-12-2023, whereas 23 J/Clerks have been appointed out of 100 % deceased/Medical Board sons quota vide order No. 15979-16001 dated; 9-12-2023.

He further explained that in the light of Honorable Service Tribunal decision a Scrutiny committee was constituted Vide Notification No. 3833-36 Dated: 23-05-2024 to check the relevant record of the 03 petitioner for the purpose of promotion from Class-IV to /Clerk on the basis of seniority cum fitness. He further presented that the seniority committee checked all relevant documents i.e Seniority list, S/Books, Qualifications and their written knowledge as per detail given below.

**Selection criteria: -**

- 1- Promotion shall be made on the basis of seniority cum fitness subject to provision of minimum qualifications SSC and 25 words per minute typing test /computer knowledge as required for the subject post.
- 2- 33% by promotion of the available vacancies from Class-IV seniority list on the basis of seniority cum fitness.
- 3- The J/Clerk appointed by promotion shall achieve a speed of 25 words per minutes in English typing within six months of their promotion, otherwise they shall be reverted.



**Note:**

After detail discussion the DPC committee members, Scrutinized all the relevant record pertaining to the petitioner promotion case in detail, but it was observed that all the mentioned Class-IV employees are not follow the merit criteria on the basis of seniority cum fitness as they are at S.No. 25,



41, 48 and 54 and they are out of promotion range, if they are promoted out of turn at this stage a Gate way for other effected class-IV will be opened and also the same will create a Pandora box for the department, which will be out of control as there are more than 250 C-IV employees working in the district against Class-IV posts. The committee unanimously decided that the petitioner not follow the merit criteria on the basis of seniority cum fitness, but if the Honorable court desired that the petitioner should be promoted in all means, the Department will follow the Court direction in letter & spirit on the next short date. 

The reply was sought from the respondents, which was duly submitted and as per reply, the petitioner's father retired after qualifying service on completion of 26 years service and not on superannuation.</p>

3. The perusal of the record reveals that as per *order* which is annexed with the reply, it is mandatory that 25% quota falling to the share of initial recruitment in BPS-01 to PBS-04, is reserved for appointment of one of the children of a retiring civil servant on Superannuation and not for an employee retired on qualifying service. Thus, petitioner's father being retired on qualifying service and not on Superannuation, therefore, the petitioner is not entitled to the 25% quota reserved for appointment of one of the children of a retiring civil servant.

4. The learned counsel for petitioner produced an appointment order vide which one Zahid Khan s/o Mir Atlas Khan was also appointed as *Naib Qasid* on Retired Employees Son Quota, whereas, the father of the appointee Zahid Khan also retired on qualifying service on his own request, but this contention of the learned counsel does not persuade us to hold, otherwise, as two wrongs cannot make one right. This Court being Court of law cannot perpetuate a wrong to continue in the name of discrimination. Hence, for the above cited reasons, this petition being bereft of any merit is hereby dismissed.
