



5. That Junior to the Petitioner has promoted to the post of Inspector vide order dated 02.11.2023 but the petitioner was not promoted for the reason that the seniority of the petitioner was disturbed at that time but now the seniority of the petitioner has restored to his original position, so, as per seniority position, the petitioner was senior from the official namely S.I Muhammad Iqbal and S.I Aksar Ali whom were promoted vide order dated 02/11/2023 So, the petitioner has right to be promoted to the rank of Inspector from the date 02.11.2023 i.e Junior was promoted but the department refusing the same despite the clear direction of the Honorable Tribunal. **Copy of the seniority list and promotion order are attached as Annex-C & D.**
6. That the respondents were totally failed in taking action regarded the Hon'able Tribunal Judgment dated 31.07.2024 in true letter and spirit.
7. That the respondent totally violated the judgment of Hon'able Service Tribunal, is totally illegal amount to disobedience and Contempt of Court.
8. That the judgment is still in the field and has not been suspended or set aside by the Supreme Court of Pakistan, therefore, the respondents are legally bound to implement the same in letter and spirit.
9. That the petitioner has having no other remedy to file this Execution Petition.


