

PRAYER: ON ACCEPTANCE OF THIS SERVICE APPEAL, THIS HONOURABLE TRIBUNAL MAY VERY GRACIOUSLY BE PLEASED TO SET ASIDE BOTH THE IMPUGNED ORDERS NO. 1960-67/DSJ/KK DATED 16/10/2020 OF RESPONDENT NO.2 AND DATED 24/07/2024 PASSED IN SERVICE APPEAL NO. 01/2021 BY RESPONDENT NO.1 AND DIRECT THE RESPONDENTS TO RE-INSTATE THE APPELLANT IN SERVICE WITH FULL BACK BENEFITS AND WITH RETROSPECTIVE EFFECT; AND MAY ALSO VERY GRACIOUSLY BE PLEASED TO GRANT ANY OTHER REMEDY DEEM FIT BY THIS HONOURABLE TRIBUNAL IN THE CIRCUMSTANCES, TO MEET THE ENDS OF JUSTICE.

Respectfully Sheweth:-

- 1) Succinct but most relevant facts giving rise to the institution of instant Appeal are that the Appellant was appointed as Computer Operator in BPS-16 vide order dated 21/03/2018.
(Copy of appointment order is hereby annexed as Annexure-A)
- 2) That the Appellant submitted an application for two years Extra Ordinary/Ex-Pakistan Leave vide Application dated 24/01/2020, which after proper procedure was placed before the learned District & Sessions Judge Karak, wherein, 120 days leave with full pay was awarded to the Appellant; i.e. w.e.f 1st March 2020 to 30th June 2020.
(Copies of Application and accord of approval are hereby annexed as Annexure-B)
- 3) That the Appellant thereafter obtained proper No objection Certificate (NOC) for proceeding abroad and accordingly proceeded abroad i.e. for United Arab Emirate.

4) That, after proceedingS of the Appellant abroad the whole world was crippled by Pandemic COVID-19 and strict restrictions were imposed on movement of human-being from one place to another place, which continued for more than two years and got relaxed in the month of April 2022.

(Copies of extracts from websites are hereby annexed as Annexure-D)

5) That the situation was beyond the control of the Appellant and he could not return home land due to national and interlineal restrictions, thus in such eventuality the Appellant submitted an application for extension of his leave period, however, the request of the Appellant was turned down vide office order Endst: No. 1598-04/D&SJ/KK dated Karak the 28/07/2020.

6) That all of a sudden without adopting the proper procedure, final show cause notice issued to the Appellant to which the Appellant submitted his reply and explained his position; however unfortunately major penalty of "removal from service" was imposed upon the Appellant, but the same was not imparted upon the Appellant vide impugned order No. 1960-67/DSJ/KK dated Karak the 16/10/2020.

7) That the Appellant thus preferred Departmental Appeal against the impugned order, but the same was also rejected vide impugned order dated 24/07/2024 by the Appellate Authority.




- 8) That now the Appellant has got no other choice but to knock at the door of this Honourable Tribunal for the remedy and the ends of justice with a prayer in the head note of this Service Appeal, inter alia, on the following grounds.

GROUNDS

- a) That both the impugned orders i.e. removal from service and rejection of departmental appeal are against the law, rules, facts and principal of justice and as such are liable to be set aside.
- b) That the overall situation of the world due to pandemic COVID-19 was well in the knowledge of everyone, thus the state of affairs was beyond the control and access of the Appellant. The same have not been taken into consideration by the Departmental Authorities which is obviously the violation of the principle of ***Audi Alter Partum*** and as such the removal from service order impugned herein are totally ineffective upon the rights of the Appellant.
- c) That the law on the subject has totally been misconceived by the Departmental Authorities whereas the Appellant has been awarded with the major penalty in a very cruel and harsh manner in spite of the fact that the Appellant was never at fault.
- d) That, the absence of the Appellant was not willful, rather the same was beyond the control of the Appellant to join his duties.
- e) That, the impugned order of the Appellate authority is not speaking one and is based on misreading of facts and law.
- f) That, the Appellant has tried his level best to return home land and join back his duties, but due to COVID-19 pandemic restrictions he could not make it possible despite all his efforts.
- g) That, it has been mentioned in the impugned order dated 24/07/2024 of the Appellate Authority that the Appellant has returned from UAE yesterday, and he is not interested in



from service and his appeal was pending then his non return to the country is not a valid ground for dismissal of Appeal.



- i) That no opportunity of personal hearing was granted to the Appellant.

- k) That the proceedings carried out by the Department are *corum non-judice* thus having no sanctity in the eyes of law.
- l) That the Counsel for Appellant seeks permission to rely and advance additional grounds at the time of hearing of this Appeal.

The UAE has suspended, effective March 17, 2020, all visas to all foreigners, with the exception of diplomatic passport holders. The decision did not apply to those who already had their visas issued prior to the aforementioned date.

Federal Authority For Identity, Citizenship, Customs & Port Security (then ICA) noted that the additional precautionary decision will be valid until a mechanism for medical examination has been established in the countries of departure as part of other global measures taken for the common good of all nations to curb further spread of the coronavirus.

Application of Shahid Rasool Computer Operator for extension in earned leave, presented through Mr. Sakhi Abdul Subhan, Computer Operator and forwarded by Senior Civil Judge, Judicial Karak is received. The applicant has already been granted earned leave on full pay vide Office Order bearing Endst. No. 1371-76/D&SJ/KK dated 15.02.2020, which has to be expired on 30th June, 2020. The reason assigned for such extension is that the applicant being abroad at United Arab Emirates is unable to proceed and join duty due to lockdown owing to Pandemic of Covid-19. The purpose of leave was to care his father settled abroad but this fact has been known from the source report that his father has already been arrived to Pakistan and no one is there to be cared for. Similarly, thousands of passengers are coming back from the U.A.E on daily basis and thus the earlier plea of non-availability of flights was colorfully converted into plea of retention of passport by sponsor. The offer and opportunity of presenting additional evidence as well as personal hearing was also not availed.

4. That application of the appellant for extension of leave was declined by Hon'ble District & Sessions Judge, Karak vide order dated 28/07/2020. (Copy is Annexure "D")
5. That departmental proceedings were initiated against the appellant by the Hon'ble District & Sessions Judge, Karak, on 07/07/2020 which was followed by show cause notice. (Copy of Show-Cause Notice is Annexure "E")

which he availed on 01/03/2020 and due to circumstances, beyond control of appellant, Covid 19, he stucked up abroad and was unable to come back, he well in time applied for extension of leave, result whereof was never conveyed to appellant, hence the impugned proceedings against the appellant are void ab-initio.

- C. That there is no question of willful absence of appellant from his duty, rather it was compulsion, beyond the control of appellant due to which, he was unable to come back. Moreso, appellant was ailing and was tested positive of Covid 19, that is why he was unable to resume back and join his duties.
- D. That nationally and internationally circumstances were abnormal, the embassies were not working and it was not possible to fly back to Pakistan. The appellant tried his best to avail flight but it was not possible. The record of ailment and online application for flight is annexed as Annexure "H".
- E. That element of willful absence is necessary for impugned action, which is lacking against the appellant, hence impugned action is nullity in the eyes of law.
- F. That impugned order of removal from service was never communicated to appellant, and appellant received the same through his own efforts on 13/12/2020 and is filing the instant appeal which is well within time.
- G. That appellant is at initial state of his career and the impugned harsh action ruined the entire career of appellant, as well will spoil the career of appellant as such liable to be set aside.
- H. That appellant seeks the permission of this Hon'ble Court to rely on additional grounds at the time of hearing of appeal.


