

**APPEAL U/S 4 OF THE SERVICES  
TRIBUNAL ACT, 1974 AGAINST THE  
ORDERS OF THE RESPONDENTS,  
WHEREBY, THE SALARIES OF THE  
APPELLANT HAS BEEN WITHHELD  
SINCE JULY 2022 TILL NOW.**

**Prayer**

*On acceptance of this appeal, the impugned orders, whereby the salaries of the appellant has been withheld may very graciously be set aside and the appellant may be returned the salaries since, July 2022, till date with all back benefits.*

**Respectfully Sheweth:**

- 1) That the appellant is the permanent bonafide resident of District Orakzai and belongs to a respectable family. That the appellant has also been issued Computerized National Identity Card (CNIC), wherein his date of birth is 01.07.1969. (Copy of CNIC I enclosed as Annexure "A")
- 2) That the appellant has been appointed by the Political Agent, Orakzai Agency vide Notification No.4267-68/PA/ID dated 09.10.1996 as Levy Sepoy in consideration of the resignation of the father of the appellant as the father of the appellant attained the age of superannuation and on the post of vacated by the father. (Copy of the notification is enclosed as Annexure "B")
- 3) That the office of the Political Agent also maintained the service book and service record of the appellant and for this purpose the officials of Political Agent have made entries in the service book of the appellant, wherein his date of birth is written as 1969 instead of 01.07.1969 i.e. according to the CNIC the date of birth of the appellant is 01.07.1969. (Copy of service book is enclosed as Annexure "D")
- 4) That after the merger of the erstwhile FATA into the province of Khyber Pakhtunkhwa, the services of the appellant was also switched from the Political Khasadar Force to the regular police since 2019.

- 5) That the appellant is still serving in the Police Department and working as Constable (1154) at Police Station Ghaljo District Orakzai , but the salary of the appellant has been withheld since July 2022 till date on the allegations of difference in the date of birth mentioned in the service book and CNIC. (Copy of the service certificate is enclosed as Annexure "E")
- 6) That being aggrieved the appellant submitted departmental appeal for the release of his salaries, but in vain as no reply has been given till expiry of statutory period.
- 7) That being aggrieved the appellant now approaches this hon'ble Tribunal on the following amongst other grounds inter-alia:-

**GROUND:**

- A) That the appellant being a regular employee of the respondent department and is still performing his services in the Police Station Ghaljo as constable, therefore, the salary of the appellant has illegally been withheld.
- B) That the appellant has spotless record/ no adverse entry into his credit and the appellant is performing his duties efficiently with full zeal and devotion and dedication while the salary of the appellant is withheld without issuance any order/ notification by the competent authority nor the same has been served upon the appellant.

- C) That no opportunity of hearing has been provided to the appellant, nor any explanation / show cause notice has been issued to the appellant , thus, the appellant is condemned unheard by violating the golden principles of natural justice.
- D) That no departmental proceeding and inquiry has been pending against the appellant and the salary of the appellant has been withheld in a slipshod manner illegally.
- E) That the stoppage of salary is the colorful exercise of powers not vest with the respondents.
- F) That the respondents have not confirmed the date of birth with the CNIC of the appellant nor sought CNIC from the appellant.
- G) That other grounds will be taken at the time of arguments with the permission of this Hon'ble Court.

It is, therefore, prayed that on acceptance of this appeal, the impugned orders, whereby the salaries of the appellant has been withheld may very graciously be set-aside and the appellant may be returned the salaries since, July 2022, till date with all back benefits.

Any other relief deemed fit may also be graciously granted.


