**R/SHEWETH:**

**ON FACTS:**

**Brief facts giving rise to the present appeal are as under:-**

1. That initially the appellant was inducted in the respondent department as Arabic Teacher (BPS-09) now BPS-15 vide dated 11/04/1996. That after appointment the appellant started performing his duty quite efficiently and upto the entire satisfaction of his superiors. Copy of appointment order is attached as annexure.....**A**
2. That whereafter the KP Public Service Commission advertised the post of SET now SST (BPS-16) for the respondent department and the appellant having the requisite qualification, applied for the ibid post through proper channel and was accordingly appointed as SET now SST vide Office Order dated 30/10/2003. Copies of educational testimonials, appointment order and merit list are attached as annexure.....**BC&D**
3. That as per seniority list of SST (BPS-16) stood on 01/01/2018 the appellant was enlisted at Serial No 2096 while the private respondents were enlisted at Serial No 2201, 2207 & 2215. Copy of the seniority list is attached as annexure.....**E**
4. That as per eligibility criteria/service rules of the respondent department, the appellant alongwith the private respondents were eligible for promotion to the post of Subject Specialist (BPS-17) in the year, 2018. It is pertinent to mention that as per ibid seniority list the appellant was senior to the private respondents and was entitled for promotion to the post of Subject specialist (BPS-17). Copy of the rules is attached as annexure.....**F**
5. That vide notification dated 10/05/2018 the private respondents were promoted to the post of SS (BPS-17) despite of the fact that the private respondents were junior to the appellant. Copies of the promotion notification and posting notification are attached as annexure.....**G&H**
6. That appellant feeling aggrieved filed departmental appeal against the notification dated 10/05/2018 and in-response after the laps of almost two years, the appellant was promoted to the post of Subject Specialist (BPS-17) vide notification dated 12/02/2020 with immediate effect. Copy of the impugned notification is attached as annexure.....**I**

7. That the appellant is entitled for promotion to the post of SS (BPS-17) with effect from 10/05/2018 under the law and rules, filed departmental appeal, but till date no response has been received so far. Copy of departmental appeal is attached as annexure.....J
8. Hence the present service appeal on the following grounds amongst the others:-

**GROUND:**

- A- That the impugned notification dated 12.2.2020 is against the law, fact and norms of natural justice, therefore, not tenable and is liable to be modified/rectified to the extent of promotion of the appellant w.e.f. 10.5.2018 with all back benefits including seniority.
- B- That the appellant has not been treated by the respondent department in accordance with law on the subject noted above and as such the respondents violated Article 4, 25 of the Constitution of Islamic Republic of Pakistan, 1973.
- C- That impugned notification dated 10/05/2018 is against the law and rules and as such the appellant is entitled for promotion to the post of SS (BPS-17) with effect from 10/05/2018 under the law and rules.
- D- That not allowing/granting ante-dated promotion to the appellant is violative of the Civil Servant Act, 1973 as well as of the Appointment, Promotion & Transfer Rules, 1989.
- E- That non issuance of the ante-dated promotion to the appellant is violative of the precedents of the superior courts, hence the appellant is entitled for the grant of ante-dated promotion from his due date i.e. w.e.f. 10.5.2018 with all back benefits including seniority.
- F- That, the treatment meted out to the Appellant is clear violation of the Fundamental Rights of the Appellant as enshrined in the Constitution of Pakistan, 1973.
- G- That, the Appellant has been discriminated by the respondents on the subject noted above and as such the respondents violated the Principle of Natural Justice.
- H- That by not deciding the departmental appeal of the appellant by the appellate authority is violative of the precedents of the

superior courts and the appellant is entitled for ante-dated promotion from due date.

I- That appellant seeks permission to advance other grounds and proofs at the time of hearing.

It is therefore most humbly prayed that the appeal of the appellant may be accepted as prayed for. Any other remedy which this august Court deems fit that may also be awarded in favor of the appellant.


That vide notification dated 10/05/2018 the above named were promoted to the post of SS (BPS-17) despite of the fact that they were junior to the appellant.


