APPEAL UNDER SECTION 4 OF THE KHYBER PAKHTUNKHWA SERVICE TRIBUNAL ACT, 1974, AGAINST THE ORDER DATED: 04-12-2023 COMMUNICATED TO THE APPELLANT ON 25-04-2024, DURING HEARING OF HIS WRIT PETITION NO. 967/2024, VIDE WHICH THE APPELLANT WAS TERMINATED FROM SERVICE WITH IMMEDIATE EFFECT AGAINST WHICH HER DEPARTMENTAL APPEAL DATED 03.05.2024 HAS NOT BEEN RESPONDED WITHIN THE STATUTORY PERIOD OF 90 DAYS.

Prayer in appeal:

ON ACCEPTANCE OF INSTANT APPEAL THE TERMINATION ORDER DATED: 04.12.2023, MAY KINDLY BE SET-ASIDE AND THE APPELLANT MAY KINDLY BE RE-INSTATED IN SERVICE WITH ALL BACK AND CONSEQUENTIAL BENEFITS.

Respectfully Sheweth:-

The appellant humbly submit as under;

- 1. That appellant is a peaceful and law abiding citizen of Pakistan hailing from District Nowshera.
- 2. That the appellant was appointed as Ward Attendant (BPS-4) after fulfilling all the codal formalities vide order dated 30.06.2022. (Copy of the Office Order dated 30.06.2022 is attached as Annexure

- 3. That thereafter, the appellant was medically examined and when found fit, submitted his arrival report on 01.07.2022 and started performing his duties. (Copy of arrival report dated 01.07.2022 is attached as Annexure B)
- 4. That his bank account was also opened on the letter of DHO Nowshera dated: 24-10-2023, so as to pay him his due salary. (Copy of the letter dated 24.10.2022 is attached as Annexure C)
- 5. That ever since his appointment the appellant performed his duties, but even though he was not paid salary by the respondents. The appellant approached and requested the Respondent No. 3 for payment of his salary, but no positive response was made by the respondents.
- 6. That the appellant was constrained to file writ petition bearing No. 967-P/2024 for the release of his salary. The respondents therein were summoned with directions to file Para-wise comments which were accordingly filed by Respondent No. 03, and the matter was fixed for hearing for 25-04-2024. During the course of arguments it was transpired from the comments that he had been terminated (in back dates) vide Office Order dated: 04-12-2023. (Copy of the Office Order dated 04.12.2023 is attached as Annexure D)
- 7. That keeping in view the fresh development, the writ petition was disposed off leaving the appellant at liberty to avail the remedy if he so desires vide order dated 25.04.2024 (Copy of the Order dated 25.04.2024 is attached as Annexure E).
- 8. That the appellant also submitted his departmental appeal dated 03.05.2024 to the respondents however the same was not responded till the statutory period of 90 days, hence the instant appeal. (Copy of the departmental appeal dated 03.05.2024 is attached as Annexure F)
- 9. That the back dated fake termination letter/ impugned Office Order dated 04-12-2023 is illegal, unlawful and is liable to be set aside interalia on the following grounds.

GROUNDS:

- A. That the appellant has not been treated in accordance with law on the subject hence his right secured and guaranteed under the Constitution of Pakistan 1973 are badly violated.
- B. That the appellant never committed any act or omission which could be termed as misconduct even than his salaries were initially stopped and when he approached the Hon'ble Peshawar High Court Peshawar he was terminated with back dated letter which by itself is an illegal act on the part of the DHO Nowshera

- C. That it is pertinent to mention here that he was on the strength of the department at the time of filing his writ petition, however, when the notice was served upon the DHO Nowshera he in revenge, terminated him in back dates which is ineffective upon the rights of the appellant.
