Act,1974**

Prayer of the service appeal.

“ It is therefore most respectfully humbly prayed to direct the Respondent No,2 (District Education Officer F Swat to issue the promotion order from PST BPS 12 to SPST BPS 14 from the due date (D.P.C.) of the appellant and than issued the promotion order from SPST BPS 14 to PSHT BPS 15 of the appellant from the due date under the Elementary and Secondary Education K.P policy , rules / procedure.

ii. It is further humbly prayed to direct the Respondent No, 2 to include the name and other particulars of the appellant in the SPST BPS 14 seniority list.

iii. It is further prayed to direct the Respondents No, 2 (District Education Officer Female Swat) to implement the Government of K.P. Elementary and Secondary rules and regularizations.

iv. Any other remedy though may not specially prayed for but which circumstance of the appeal could in the interest of justice.

Facts.

- 1.) That the appellant is the permanent resident College colony Afsar Abad Saidu Sharif Swat.
- 2.) That the applicant was appointed as PST vide D.E.O. Female Swat No, dated 24/06/90 .
(Appointment order as Annex: A)
- 3) That applicant was promoted from PST BPS 12 to PSHT BPS 15 vide Respondent No,2 (DEO F Swat) order No, 569-74 dated . 27/02/2013 .
(Promotion order BPS 15 dated 27/2/13 as Annex: B)
- 4) It is pertained to be noted that the Respondent No, 2 ignored the promotion order PST BPS 12 to BPS 14 of the appellant.
- 5) It is pertained to be noted that the primary teachers are divided in the three categories.

i)PST BPS 12. li SPST BPS 14PSHT iii BPS 15
- 6) That under the primary school teachers promotion formula / procedure in the first stage, it is essential have been promoted the PST BPS 12 on the basis of seniority to BPS 14 (SPST) but the Respondent No,2 (D.E.O. Female Swat) not issued the promotion order from PST BPS 12 to SPST BPS 14 of the appellant and directly issued the promotion order from PST BPS 12 to PHST BPS 15 of the appellant which against the Prescribed rules and regulation.
- 7) It is pertained to be noted that Respondent No, 2 (D.E.O. Female Swat) issued so many promotion orders from BPS 12 to 14 No, 15665-70 dated 9/11/2017 and No, 11042-47 dated 31/12/2020 and circulate the promotion orders to concerned S.D.E.O,s Female and entries of BPS 14 made / make in the promote teachers service books, and paid the arrears of BPS 14 to all the promote

teachers but the appellant promotion order BPS 14 not yet issued to date . (Promotion orders dated 9/11/2017 & dated 31/12/2020 are Annex: C & D)

8) That the Respondent No. 2 (District Education officer Female Swat) prepared separate seniority list of PST BPS 12, SPST BPS 14 and PHST BPS 15.(Seniority list BPS 12, 14 and 15 are Annex : E, F , G)

9) That most of the teachers of primary male Swat had such problems, they have also been solved, and primary male teachers have also received their arrears of BPS 14 from the due date.

10) That the act of the Respondents not issuing the promotion order from BPS 12(PST) to BPS 14(SPST) on the due date had mala fide and against law and rules.

11) That the appellant is entitled for promotion from BPS 12(PST) to BPS 14 (SPST) from the due date under the law and rules other like aforementioned teachers.

12. That the Respondent No,2 (D.E.O Female Swat) intentionally and mala fidely not include the particulars of the appellant in the SPST BPS 14 seniority list which against the rules , rules and fundamental rights.

13.) That the appellant submitted an application to Respondent No, 2 vide post office receipt No, 153 dated 4/6/2024 but no reply received to appellant to till date.(Application as Annex: (H & I)

14.) That the appellant submitted Departmental service appeal to respondent No, 1 vide post office receipt No, 152 dated 4/6/2024 but not yet decided in the prescribed period.(Departmental service appeal as Annex: H)


GROUND.

- 1.) That the act of the Respondent No,2 is against the law and rules.
- 2.) That the appellant is entitled for promotion to BPS 12 (PST) to SPST BPS 14 under the procedure of Elementary and secondary Education K.P.
- 3.) That the Respondents department are not adopted the procedure of the promotion formula of primary school teachers by the directions of Government of Khyber Pukhoonkhawa .
- 4.) That the act of the respondents are totally against the law and favors their blue eyed by illegally deprived the appellant from her fundamental right.
- 5) That the appellant is not being treated in accordance with the law and rules on the subject.
- 6) That the has been discriminated with to her utter detriment.
- 7.) That this is a classic case of misuse of the authority and a very colorful and fanciful use of the same.
- 8.) That the appellant was entitled for one or more pre mature increments in BPS 14.
- 9.) That under the constitution of Islamic Republic of Pakistan 1973 all the citizen are equal in the eye of law/ constitution.
- 10.) That the appellant seek permission top advance other grounds and proof at the time of hearing.
- 11.) That the appellant has not been treated in accordance with the law and rules.
