Act,1974**

Prayer of the service appeal.

i) It is therefore most respectfully humbly prayed to direct the Respondent No,2 (District Education Officer F Swat) to issue the promotion order from PST (BPS 12) to SPST (BPS 14) from the date of D.P.C. of the appellant and than issued the promotion order from SPST BPS 14 to PSHT BPS 15 of the appellant from the due date under the Elementary and Secondary Education K.P policy , rules / procedure.

ii.) It is further prayed to direct the Respondents No, 2 (District Education Officer Female Swat) to implement the Government of K.P. Elementary and Secondary rules and regularizations and entry made the BPS 14 (SPST) in the appellant service book and the other relevant record.

iii). It is further humbly prayed to direct the Respondent No, 2 to include the name of appellant in the SPST BPS 14 seniority list.

iv .Any other remedy though may not specially prayed for but which circumstance of the appeal could in the interest of justice demand may also be granted.

Facts.

1)That the appellant is the permanent resident of Barkalai Saidu Sharif Swat.

2)That the applicant was appointed as PST vide DCO Swat No, 6306-8. dated 24/06/2004. (Appointment order In the shape of service book as Annex A)

3) That the applicant was directly promoted from PST BPS 12 to PHST BPS 15 vide D.E.O. F Swat No, 3540-45 dated 24/11/2014.(Promotion order BPS 15 as Annex: B)

4) The appellant was again promoted from PHST BPS 15 to CT BPS 15 and adjusted the appellant at G.G.M.S. Marghuazar Swat vide No, 8011-17 dated 29/8/2022. (Promotion order CT as Annex: C)

5) That applicant was directly promoted from PST BPS12 to PSHT BPS 15 vide Respondent No,2 (DEO F Swat) order No, 3540-4 dated 24/11/2014 that the aforementioned order is unjustified and against the policy/procedure of Elementary and Secondary Education K.P. and the appellant was entitled for promotion from PST BPS 12 to SPST BPS 14 in the first stage other aforementioned teachers.

6) It is pertained to be noted that the primary Schools teachers are divided in the three categories.

i)PST BPS 12. ii) SPST BPS 14 (iii) PSHT BPS 15

7.) That under the primary school teachers promotion formula / procedure in the first stage, it is essential to primary school teacher BPS 12 have been promoted to BPS 14 as SPST on the basis of PST

BPS 12 seniority list, but the Respondent No, 2 (D.E.O. Female Swat) has directly issued the promotion order of the appellant from BPS 12 to BPS 15 and ignored the promotion order of the appellant from PST BPS 12 to SPST BPS 14 which is against the procedure/ formula of promotion of Primary schools teachers.

8) It is pertained to be noted that Respondent No, 2 (D.E.O Female Swat) issued so many promotion orders Primary school teacher (PST) from BPS 12 to 14 vide No, 575-80 dated 27/02/2013 No, 15665-70 dated 9/11/2017 and No, 11042-47 dated 31/12/2020, and entry made of BPS 14 of the aforementioned promote teachers but the applicant promotion order from BPS 12 to 14 not yet issued to till date.(Promotions orders dated 27/02/13, No,09/11/17 & 31/12/2020 are Annex: D, E, & F)

9) That the act of the Respondents not issuing the promotion order from BPS 12(PST) to BPS 14(SPST) on the due date had mala fide and against law and rules.

10) That the appellant is entitled for promotion from BPS 12(PST) to BPS 14 (SPST) on the due date under the law and rules their like aforementioned teachers.

11) That under the constitution of Islamic Republic of Pakistan 1973 all the citizen are equal in the eye of constitution /law.

12).That Respondent No,2 (District Education officer Female Swat) prepared separate seniority list of PST BPS 12, SPST BPS 14 and PHST BPS 15.(Seniority lists are Annex: G, H & I

13)That the Respondent No,2 (D.E.O Female Swat) intentionally and mala fidely not include the particulars of the appellant in the SPST BPS 14 seniority list which against the rules , rules and fundamental rights.

14).That if the appellant was entitled for promotion from BPS12 to 14 ^{from} on the due date (from the date of D.P.C)

the appellant would have got one increment.

- 15).That the appellant was entitled for promotion from BPS 12 to 14 instead of BPS 15 in the first stage from date of DPC under the prescribed formula of Elementary and secondary Education K.P.
- 16).That most of the primary school teachers on male Swat had such problems, they have also been solved, and primary male Primary school teachers have also received their arrears of BPS 14 (SPST)
- 17).That the appellant submitted an application to Respondent No,2 vide diary No, 1448 dated 06/06/2024 but in vain. (Application dated 06/06/2024 as Annex: J)
- 18) That and till no the arrears of BPS 14 have been paid to the appellant.
- 19 .) That the appellant submitted Departmental service appeal to respondent No, 1 vide post office receipt No, 203 dated 06/06/2024 but not yet decided in the prescribed period, (Departmental service appeal as Annex: K)

GROUNDS.


- 1.)That direct promotion from BPS 12 to BPS 15 of the appellant is illegal and against the procedure and rules of the Elementary and secondary Education K.P.
- 2.)That the appellant was entitled for promotion to BPS 12 to BPS 14 under the procedure / rules of the Elementary and Secondary Education K.P .
- 3.) That the act of the respondents are totally against the law and favors their blue eyed by illegally deprived the appellant from her fundamental right.
4.) That the appellant is not being treated in

accordance with the law and rules on the subject.

- 5) That she has been discriminated with to her utter detriment.
- 6) That this is a classic case of misuse of the authority and very colorful and fanciful use of the same.
- 7) That the appellant was entitled for one or more pre mature increments in BPS 14.
- 8) That the appellant seek permission to advance on other grounds and proof at the time of hearing.
- 9) That the appellant has not been treated in accordance with the law and rules.

It is therefore, respectfully prayed that on acceptance of instant service appeal of the appellant with all back benefits.

Consequent upon the recommendation of the Departmental Promotion Committee in its meeting held on 23/09/2022 and in the Government of Khyber Pakhtunkhwa Elementary & Secondary Education Department Notification No. 50(01)05/P/500/Meeting/2012/Teaching cadre dated 13.11.2012, the following Primary School Head Teachers (PSHTs) are hereby promoted to the post of CT in BPS-15 (2020-1980-81,120) plus usual allowances as due as admissible to them under the rules on regular basis in teaching cadre on terms and conditions given below with immediate effect.

PROMOTION FROM PSHT TO BPS-15 TO CT BPS-15
