Praver:

ON ACCEPTANCE OF THE INSTANT APPEAL THE IMPUGNED ORDERS OF TYPING TEST, PROMOTION AND SUBSEQUENTLY EXCLUSION OF THE APPELLANT FROM THE SENIORITY LIST VIDE ORDER DATED 27.05.2024 MAY VERY GRACIOUSLY BE SET ASIDE & THE NAME OF THE APPELLANT MAY PLEASE BE INSERTED

IN THE SENIORITY LIST AND ANTE DATED PROMOTION

MAY ALSO KINDLY BE GRANTED TO THE APPELLANT.

ANY OTHER RELIEF DEEMED APPROPRIATE IN THE CIRCUMSTANCES OF THE CASE NOT SPECIFICALLY ASKED FOR, MAY ALSO BE GRANTED TO THE APPELLANT.

Respectfully Sheweth,

That the appellants submit as under:

FACTS:

- 1. That the appellant being eligible was appointed as sweeper (PBS-IV) in the respondent department.
- 2. That since appointment the appellant is performing his duty regularly and efficiently.
- 3. That the respondents department pick and choose the appellant's junior colleagues on the pretext of an illegal order regarding order of typing test. (Copy of order dated 01.04.2022 is attached as annexure "A".
- 4. That the respondents department promoted the respondents No. 3 to 8 who are most junior to the appellant and the appellant was differed. (Copy of promotion order dated 17.05.2022 is attached as annexure "B").
- 5. That the respondent issued a tentative seniority list of class-IV on 01.01.2024 which the appellant was at S.No.9 (Copy of tentative list dated 01.07 202. Attached as annexure "C").
- 6. That once again on doesd 27.05.2024 the respondents issued official order whereby, he name of appellant was excluded on the pretext of 3 divisioner. And described that the requirements of the magibility for the promotion to the post of Junior Clerk PBS-11 is at leas. 2nd Division qualification which is against the service rules 15. 4.2022. (Copy of order dated 27.05.2024 is attached as annexure "D").
- 7. That the respondents is an another for rive seniority list of class-IV on date 01.03.2024 wherein, the name of the appellant was removed / excluded on the grounds, that minimum qualification for promotion from PBS-04 to PBS-11 is FA/FSc at least possessing 2nd Division qualification. (Copy of tentative list is attached as annexure "E).

- 8. That neither the typing test nor 3rd Division qualification has been described in the service rules dated 15.04.2022 for promotion to the higher post (Copy of rules dated 15.04.2022 is attached as annexure "F").
- 9. That the appellant move departmental appeal against the impugned order vide dated 27.05.2024 to the respondents but no response is yet received. (Copy of departmental appeal is attached as annexure "G").
- 10. That feeling aggrieved from the action and inaction of the department and impugned order vide dated 27.05.2024 the appellant approaches to this Hon'ble Tribunal on the following grounds inter alia:-

GROUNDS:-

- A. That the impugned order vide dated 27.05.2024 and following two other impugned orders are against the law and rule No. SO (P&R)/1/33/2021 notified on dated 15.04.2022.
- B. That the appellant has been appointed in the year 2017 therefore, the appellant is entitle to be treated retrospectively because previously some official were promoted without qualifying typing test.
- C. That non promoting the appellant is gross violation of S.No.37 columns No.4 of service rule issued on dated 15.04.20222.
- D. That the appellant has not been promoted by the respondents due to malafidely.
- E. That the appellant has not been treated equally according the constitution of Islamic Republic of Pakistan 1973.
- F. That junior colleagues of the appellant have been promoted which is clear violation of the right of the appellant.
- G. That the appellant is qualified upto FA and rules described qualification for promotion upoto matriculate.
- H. That the exclusion of 3rd Divisioner from promotion is against the law and rules.
- I. That the appellant is eligible to the post of Junior Clerk.

- J. That issuance of 2nd tentative seniority list for class IV is against the law and rules.
- K. That the appellant is entitled to be included in the 2nd tentative seniority list of class-IV for promotion issued on dated 01.03.2024.
- L. That any other ground which is not specifically mentioned will be taken at the time of arguments with the prior permission of this Hon'ble Tribunal on the instant service appeal.

It is therefore, most humbly prayed that on acceptance of this appeal the impugned orders of typing test, promotion and subsequently exclusion of the appellant from the seniority list vide order dated 27.05.2024 may very graciously be set aside & the name of the appellant may please be inserted in the seniority list and ante dated promotion may also kindly be granted to the appellant..

Any other relief not specifically asked for may also graciously be extended in favour of the Appellant in the circumstances of the case.

Interim Relief

By way of Interim Relief the respondent No.1 & 2 may please be restrained from preparing final seniority list till the final disposal of the instant appeal.

Respected Sir:

- 1. That the names of the appellant were included in the tentative seniority list of Class IV for promotion prepared on dated 05/02/2024 but now due to order dated 27/05/2024, the names of the appellants have been removed from the joint seniority list of Class IV, while the appellant namely Gul Muhammad Said was appointed on 26/08/2017 and was included at the serial No. 9 of the tentative seniority list of Class IV, while appellant namely Farman Abbas appointed on 26/08/2017 was included in tentative seniority list of Class IV at serial No. 13, but both the appellants were excluded from the seniority list on the impugned order vide dated 27/05/2024 due to reason of 3rd Divisioner and 2nd Divisioner.
- 2. That according to the rules of 2021, column No. 37, the qualification for promotion is matriculation and even no division in the education documents has been prescribed in the serial No. 4 of column No. 37.
- 3. That the appellants are qualified upto EA and they are eligible to be included in the seniority list for promotion.
- 4. That feeling aggrieved from the impugned order of revised joint seniority list dated 27/05/2024 approaches to this forum on the following grounds, inter alla:

GROUNDS:

- A. That the appellants names were included in the tentative seniority list of Class IV on dated 01/01/2024 and both the appellants were at serial No. 9 & 13 respectively.
- B. That according to that tentative list, both the appellants were entitled to be included in the joint seniority list of Class IV.
- C. That order dated 27/05/2024 is against the service rules No. SO(P&R)/1-33/2021, notified on dated: 15/04/2022
- D. That appellants are qualified upto E.A, therefore, they are entitled under the rule mentioned above to be included in the joint seniority list of Class IV for promotion.
- E. That even division or marks obtained in the educational career has not been mentioned in the aforementioned rules.
- f. That any other ground which is not specifically mentioned the appellants will be at liberty to the same whenever necessary.

It is, therefore, most humbly prayed that the appellants names may please be included in the joint seniority jith of Class IV for promotion.


