APPLICATION FOR IMPLEMENTATION OF ORDER DATED 14.06.2024 PASSED IN SERVICE APPEAL NO.1461/2023 READ WITH ARTICLE 204 OF THE CONSTITUTION OF ISLAMIC REPUBLIC OF PAKISTAN, 1973 FOR PROCEEDING AGAINST THE RESPONDENTS AS THE RESPONDENTS SPECIALLY RESPONDENTS NO.2 TO 5 NOT COMPLIED THE ORDER/JUDGMENT VIDE DATED 14.06.2024 PASSED BY THIS HON'BLE TRIBUNAL WITH THE CONSENT OF PETITIONER/APPELLANT & RESPONDENTS IN SERVICE APPEAL NO.1461/2023 TITLED AS "REHMAT ULLAH VERSUS GOVT. OF KPK THROUGH CHIEF SECRETARY KHYBER PAKHTUNKHWA"

Respectfully Sheweth:

1. That the petitioner/appellant filed the above mentioned service appeal which was disposed-off by this Hon'ble Tribunal vide order dated 14.06.2024. **(Copy of the judgment dated 14.06.2024 is attached as annexure "A").**

2. That the petitioner submitted application alongwith the above mentioned judgment to the respondent No.2 for compliance of this Hon'ble Tribunal in letter and spirit. **(Copy of the application is attached as annexure "B")**.
3. That the respondent No.1 referred the case to the DIG Headquarter (Rizwan Manzoor) for process the case of the petitioner/appellant and the DIG Headquarter sent a letter No.CPO/CPB 135 dated 31.07.2024 to respondent No.5 (C.C.P.O) whereby he requested to the C.C.P.O to provide detailed report regarding his immediate senior and junior colleagues regarding their present rank and position. **(Copy of the letter is annexed as annexure "C")**.
4. That the respondent No.5/C.C.P.O provide the detailed of senior and junior list colleagues of the petitioner. **(Copy of letter issued by the C.C.P.O is annexed as annexure "D")**.


5. That instead of fixation the seniority of the petitioner as inspector and DSP, the D.I.G Headquarter on behalf of the respondent No.1 issued another illegal letter No. CPO/CPB-150 dated 30.08.2024 to the Commandant Police Training College, Hangu for providing details of recruit course and lower colleagues course in respect of the petitioner. **(Copy of letter is annexed as annexure "E")**.
6. That the respondents are not ready to complied the order of this Hon'ble Tribunal without any legal justification and this act of the respondents is fall into the ambit of contempt of the order of this Hon'ble Tribunal.
7. That now, the petitioner approaches to this Hon'ble Tribunal on the following grounds inter alia:

GRUNDS:

- A. That non-compliance of the order/judgment of this Hon'ble Tribunal is clear cut violation of law and constitution of Islamic republic of Pakistan, 1973.

- B. That under the constitution of Islamic republic of Pakistan any order/judgment of Higher or superior courts /tribunals are binding on the executive bodies, so the respondents are legally and constitutionally bound to comply the order of this Hon'ble Tribunal in letter and spirit.
- C. That the omissions and commission of the respondents come into the definition of contempt of the order of this Hon'ble Tribunal which is a punishable offence under the law and punishment for such offence is six months.
- D. That the respondents delaying the matter on one pretext or the other which is not the mandate of law and justice, so in such like scenario, the wrongdoers/contemnors (respondents No.2 to5) be treated with iron hands as per law till compliance of the order/judgment of this Hon'ble Tribunal.
- E. That any other ground not specifically mention will be raised at the time of arguments with the prior permission of this Hon'ble Tribunal.

It is, therefore, most humbly prayed that on acceptance of this petition, the respondents may be directed to implement the order dated 14.06.2024 and contempt of court proceedings may please be initiated against the Respondents, they be summoned, proceeded against and be punished in accordance with law.

JUDGMENT

KALIM ARSHAD KHAN CHAIRMAN: According to the facts gathered from the record, vide Notification dated 24.03.1996, the name of the appellant was brought on list "D" with effect from 01.10.1995; that the appellant was promoted as officiating ASI with effect from 11.12.1995 vide Notification dated 17.12.1995 and was then confirmed as ASI with effect from 15.01.2003 vide Notification dated 21.06.2003 and his name was brought in list "E"; that the appellant was then

promoted as officiating Sub-Inspector vide order dated 31.05.2004 and was confirmed as Sub-Inspector with effect from 03.04.2008 vide Notification dated 09.04.2008; that the appellant was then promoted as officiating Inspector vide Notification dated 20.05.2008 and was confirmed as Inspector vide Notification dated 31.10.2013; that vide Notification dated 24.10.2014, the appellant was promoted as Deputy Superintendent of Police on regular basis, however, vide office order dated 28.03.2022, the seniority of the appellant as well as some other officials was revised and vide order dated 05.04.2022 the name of the appellant was placed at serial No. 19 of the revised seniority list of 518 DSPs; that feeling aggrieved from the orders dated 28.03.2022 and 05.04.2022, the appellant filed representation on 10.10.2022, which was not decided, therefore, the appellant filed Service Appeal No. 570/2023 before this Tribunal on 15.03.2023, however, on the same day i.e 15.03.2023, the appellant was demoted from the rank of Deputy Superintendent of Police (BPS-17) to the rank of Inspector (BPS-16) and his name was placed at serial No. 202 of the seniority list of Inspectors issued on 06.12.2022; that feeling aggrieved from the order dated 15.03.2023, the appellant filed representation, which was not decided, where-after the appellant filed Writ Petition before the Peshawar High Court, Peshawar, however, the said Writ Petition of the appellant was remitted to Provincial Police Officer, Khyber Pakhtunkhwa, Peshawar for reconsidering the matter; that on 05.07.2023, the appellant withdrew his previous Service Appeal No. 570/2023, which was filed on 15.03.2023 with the permission to file afresh to challenge the demotion

order as well; that the appellant has now filed the instant service appeal on 12.07.2023 with the prayers, which are copied as below:-

- I. *Set aside the impugned letter/notification of the respondent No. 2 No. 579/legal/E-I dated 15.03.2023 as being arbitrary, capricious, malafide, unreasonable, illegal, unlawful, without jurisdiction and without lawful authority.*
- II. *Permanently restrain the respondents from interfering, in any manner whatsoever, with the seniority of the appellant.*
- III. *Fixed/re-fixed the seniority of the appellant along with his "D" list colleagues since 01.10.1995 as per Police Rule 13.18.*
- IV. *Grant any other relief as this Hon'ble Tribunal deems fit and appropriate in the facts and circumstances of the case."*

2. On receipt of the appeal and admission to full hearing, the respondents were summoned but they failed to submit reply/comments, therefore, vide order dated 10.11.2023 they were placed ex-parte.

3. We have already heard learned counsel for the appellant and learned Additional Advocate General for the respondents.

4. Narrowing the canvass, learned counsel for the appellant submitted that if at all the appellant could not have been promoted to the rank of officiating ASI on 17.12.1995, which is considered by the department as out of turn promotion, the appellant was rightful to pray that he was entitled to be considered for promotion to the rank of officiating ASI on 02.08.2002, when his other colleagues seniors and juniors, both, were so promoted. In this respect, he produced copy of letter No. 5155-61/EC-I dated 02.08.2002 and pointed out that the IHCs at serial No. 26, 27, 28, 29 and 31 were his fellows. When confronted with the situation, the learned Additional Advocate General and the representative of the respondents namely Muhammad Suleman, Sub-Inspector (Legal) both submitted that the above referred letter was not found in the record of the respondents. However, they say that let the matter be remitted to them so

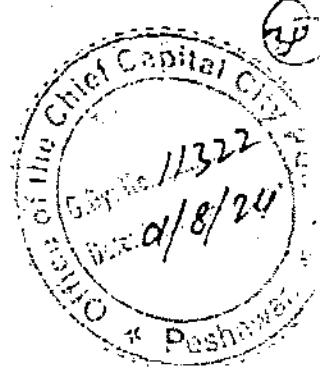

Please refer to the subject cited above and to state that Mr. Rehmat Ullah (now Inspector) was enlisted as selection grade constable on 16.10.1991 in district Nowshera as per report of CCP Peshawar vide letter No. 4649/EC-I, dated 12.03.2023. He qualified Lower College Course on 04.11.1993 from district Nowshera. He was promoted to list "D" on 01.04.1995. Note:- In compliance with Order Sheet of Hon'ble Supreme Court of Pakistan dated 26.01.2023 in Suo Moto Contempt proceedings vide Cr.L.O. Petition No. 38/2021 against Chief Secretary Khyber Pakhtunkhwa and Inspector General of Police Khyber Pakhtunkhwa initiated for not having carried out demotions of Police Officers of Khyber Pakhtunkhwa Police in Out of Turn Promotions cases. Khyber Pakhtunkhwa Police issued Demotions/Repatriations Orders in respect of Police Officers/Officials falling under Out of Turn categories. In response to such demotion/repatriation Orders, the affected Police officers/officials sought relief from Peshawar High Court by filing different Writ Petitions against their demotion/repatriation Orders issued by Khyber Pakhtunkhwa Police as Out of Turn Promotion beneficiaries. The Peshawar High Court suspended such demotions Orders so issued in Out of Turn Promotion cases and granted relief to officers who were beneficiary of Cadetship Scheme, who got absorbed in KP Police from Other Provinces, Officials got absorbed from executive cadre to Telecommunication Cadre within KP Police through a consolidated judgment dated 29.08.2023 in Writ Petition No. 1587 -P/2022 titled "Shah Mumtaz and Others Vs Govt of Khyber Pakhtunkhwa and Others". Moreover, cases of Women Police Officers were remitted back to respondent department to reconsider their positions in term of Para-27 of this judgment and under Writ Petition No. 1289 -P/2023 (Titled Tayyab Jan and others) remitted the cases of Out of Turn Promotions in respect of few Officers of ERP to Service Tribunal Khyber Pakhtunkhwa for their disposal. Service Tribunal has granted interim relief by suspending operations of letters dated 11.03.2023, 12.03.2023 and 16.03.2023.

The Police Department Khyber Pakhtunkhwa has moved CPLAs in the Honorable Supreme Court of Pakistan. Therefore, the Officers who are beneficiary of Cadetship Scheme and the officers who got absorbed from other Provinces to KP Police are placed in the seniority list as per relief already granted by Peshawar High Court in above mentioned judgment in Out of Turn Promotion cases subject to outcome of CPLAs which have already been instituted with Supreme Court of Pakistan against the judgment dated 29.08.2023 of Peshawar High Court. Moreover, the seniority of officers who got promotion in ERP would be subject to the decision of Service Tribunal Khyber Pakhtunkhwa and outcome of CPLA. Furthermore, names of Lady Police Officers, whose cases have been remitted to Department for review are under process and will be decided as per rules, merits and their seniority will be fixed accordingly.
