- 1. That the petitioner was enlisted as Sepoy in Khyber Khassadar Force (Now merged in Khyber Pakhtunkhwa Police), in the year 2007 and since then till issuance of impugned order dated 29.02.2024, performed his official duties with zeal/devotion and utmost satisfaction of the superiors.
- 2. That the respondent departments suspended one LHC namely Shahzeb No. 699 through suspension order 01.09.2023, and later on a corrigendum No.6615 dated 04.09.2023 was

issued whereby the said LHC Shahzeb No.699 was replaced with the present appellant without any justification and without any proof and reason. (Copy of corrigendum order is attached a annexure "A")

- the petitioner while posted FC 3. That Constable at Police Station Jamrud District served Khyber was which charge sheet No.6620/PA respondent bv $N_{0.2}$ Dated 04.09.2023 and leveled the following alleged allegations, "As per learned sources it is reported that you while deputed at Police Station Jamrud were found involved in contacts with drug peddlers in the area. It is reported that you are in contacts with elements who are drug peddling involved in^{i} and narcotics activities, and also involved in concealment of contrabands such activities tantamount to gross misconduct and criminal abetment". (Copy of charge sheet & statement of allegation are attached as annexure "B").
- 4. That in the response of charge sheet the appellant comprehensive reply of charge sheet and denied all the allegation leveled against him. (Copy of reply of charge sheet is attached as annexure "C").

- 5. That the respondent department also issued a final show cause notice on 24.11.2023 against the appellant. (Copy of final show cause notice is attached as annexure "D").
- 6. That in response of final show cause notice a comprehensive reply was submitted by the appellant to respondent department and denied all the allegation leveled against him. (Copy of reply of final show cause notice is attached as annexure "E").
- 7. That the respondent department issued impugned dismissal order against the appellant on 29.02.2024, whereby the appellant was dismissed from service on the ground of alleged allegations mentioned in the impugned order. (Copy of impugned dismissal order is attached as annexure "F").
- 8. That the appellant submitted Departmental appeal on 12.03.2024 against the impugned dismissal order dated 29.02.2024 which was rejected on 16.08.2024 by the respondent No.2 on no good grounds. (Copies of departmental appeal dated 12.03.2024 and rejection order

dated 16.08.2024 are attached as annexure "G & H").

- 9. That feeling aggrieved by the Appellate order of respondent No.2 dated 16.08.2024 the appellant filed revision petition under rule 11-A of police rule 1975 against the order dated 16.08.2024 on 20.08.2024 which was still pending without any response. (Copy of Revision petition is attached as annexure "I").
- 10. That feeling aggrieved the Appellant prefers the instant service appeal before this Hon'ble Tribunal on the following grounds inter alia:

GROUNDS:-

1

- A. That the impugned orders dated 29.02.2024 and 16.08.2024 are passed against the law, facts, norms of justice, hence may be liable for setting aside.
- B. That no departmental and regular inquiry was conducted by the Respondent department and no chance of personal hearing was provided to the appellant in this respect the appellant relied upon the judgment dated 2008 SCMR Page:1369.

- C. That there is no proof or evidence regarding the alleged allegations leveled against the appellant with respondent department.
- D. That there was no complaint made against the appellant and so concern the allegation mentioned in the impugned order dated 29.02.2024 in response of it is stated that the appellant was not present at the spot of said occurrence.
 - E. That no opportunity of cross examination was provided to the appellant and no iota of evidence is available against the appellant regarding alleged involvement of the appellant.
 - F. It is a well settled maxim no one can be condemned unheard because it is against the natural justice of law in this respect the appellant relied upon a judgment reported on 2008 SCMR page:678.
 - G. That any other ground not raised here may graciously be allowed to be raised at the time of arguments on the instant service appeal.

It is therefore, most humbly prayed that on acceptance of this appeal the impugned orders dated 29/02/2024 & 16/08/2024 passed by the respondents may very graciously be set aside and the appellant may kindly be reinstated in service with full back wages and benefits.





DISMISSAL ORDER

FC Shahzeb Khan No. 1324 of District Police Khyher, while he was posted at PS Jamrud, was issued with Charge Sheet No. 6620/PA-DPO Khyber dated 04/09/2023 due to his alleged involvement in concealment of drugs and contacts with drug peddlers and drug peddling.

Thus, a departmental inquiry was initiated against him. During the inquiry proceedings he was given the chance to produce written documentary proof in his defense and appear before the Inquiry Officer, He availed both but failed to submit anything in his defense. It was further revealed that he played a major role in take charging of Nazeer Khan s/o Gohar Amin r/o Dalazak Road, Corporation Colony Peshawar in the case PIR No. 220, dated 25/08/2023 u/s 9D-CNSA instead of Muhammad Israr s/o Muhammad Ibrahim Kuki Khel, who was the real accused and was released without any legal or criminal proceedings. Thus, he was found guilty and recommended to be awarded with major punishment.

The undersigned, as per the recommendation of the inquiry officer, being the competent authority is satisfied about his involvement in criminal abetment and drug peddling and in order to maintain discipline in the force hereby awards the delinquent official with Major Punishment of Dismissal from Service as per Section 4-b(iv) of Police (E&D) Rules 1975 (With Amendments -2014).

 That appellant was enlisted as Sepoy in Khyber Khassadar Force (Now merged in Khyber Pakhtunkhwa Police), in the year 2007 and since then till issuance of impugned order dated: 29.02.2024, performed duties with zeal/devotion and utmost satisfaction of the superiors, evident from absorption of his services in the Khyber Pakhtunkhwa Police Department, vide Notification dated: 13.02.2020 (Serial No.985), needless to add that all those employees, having spotless career and outstanding performance, were merged in the Khyber Pakhtunkhwa Police Department.

 That appellant, while posted at Police Station Jamrud, was served with charge sheet No.6620/PA-DPO Khyber, dated: 04.09.2023 and levelled the following allegations:

"As per learned sources it is reported that FC Shahzeb Khan No.1324 of District Police Khyber while deputed at Police Station Jamrud, was found involved in contacts with drug fiddlers in the area. It is reported that he is in contacts with elements, who are involved in drug fiddling and Narcotics Activities and also involved in concealment of seized contraband. These acts come under the meaning of misconduct as per section 2(iii) and render him liable for punishment under section 3(b) of Khyber Pakhtunkhwa Police Rules, 1975."

Appellant submitted comprehensive reply to the allegations ibid and claimed innocence.

 That Appellant was served with final Show Cause Notice No.2529/PA-DPO Khyber dated: 24.11.2023 with the following accusation:

"That inquiry officer in its findings vide No.840/PA, dated: 16.10.2023 find you guilty of the charges leveled against you as in charge sheet No.6626/PA-DPO Khyber dated: 04.09.2023. That the inquiry officer in his findings in the enquiry initiated against you found you guilty of the charges and recommended award of punishment as per rule."

Appellant submitted reply to the Show Cause Notice ibid within the stipulated time and not only claimed innocence but also requested for personal hearing.

- 4. That the worthy DPO Khyber, without either giving opportunity of hearing or conducting regular inquiry into the matter or providing free and fair opportunity to defend himself, imposed major penalty of dismissal from service upon Appellant vide Order No.952/PA-DPO Khyber, dated: 29.02.2024, hence the instant appeal.
- That Appellant has neither been provided opportunity of hearing nor regular inquiry has been conducted into his alleged accusation, hence has been condemned unheard, which attracts the doctrine of audi afteram partern.
- 6. That no iota of evidence is available on file which could substantiate the alteged hearsay charges/accusation against Appellant. Moreover, Appellant has neither been treated in accordance with law nor he has been extended equal protection of law, enshrined in Articles 4 & 10-A of the Constitution of Islamic Republic of Pakistan, 1973.
- 7. That more than 17 years spotless career of Appellant has been done away with single stroke of pin without care and caution of its legal consequences, moreover, impugned order dated: 29.02.2024 has been passed surmises and conjectures, hence carry no legal weight.
- 8. That any other ground, with the permission of your honor, will be taken at the time of personal hearing, it granted.

It is, therefore, most humbly prayed that on acceptance of instant appeal, impugned order dated: 29.02,2024 of the worthy District Police Officer, Khyber may be set aside and appellant may be re-instated in service with all consequential benefits.

This order will dispose of the departmental appeal preferred by Ex-Constable shih Zeb No. 1324, who was awarded the major punishment of "dismissal from service" under KP PR-1975 (amended 2014) by DPO Khyber vide order No. 952/PA, dated 29.02.2024.

- Brief facts leading to the instant appeal are that the defaulter Constable while posted at PS Jamrud, District Khyber, was proceeded against departmentally on the charges that he was found involved in contacts with drug peddler, collecting monthlies in his area and there were running hotspot in his area for drug activities but he failed to operate against them.
- He was issued Charge Sheet and Summary of Allegations by DPO Khyber. SP/Investigation, Khyber was appointed as Enquiry Officer to scrutinize the conduct of the accused official. The Enquiry Officer after conducting departmental enquiry submitted his findings in which he was recommended for major punishment. The competent authority in light of the findings of the Enquiry Officer awarded him the major punishment of dismissal from service.
- He was heard in person in Orderly Room. During personal hearing, he was given an opportunity to prove his innocence. However, he failed to submit any plausible explanation in his defense. Therefore, his appeal for seiting aside the punishment awarded to him by DPO Khyber vide order No. 952/PA, tlated 29.02.2024 is hereby rejected/filed.

REVISION PETITION UNDER RULE 11-A OF THE KHYBER PAKHTUNKHWA POLICE RULES, subject: 1975 (AMENDED UPTO DATE) AGAINST:

- ORDER NO.952/PA-DPO KHYSER, DATED: 29.02.2024 OF THE DISTRICT POLICE OFFICER (DPO) KHYBER, VIDE WHICH PETTHONER WAS DISMISSED FROM SERVICE, AND
- ORDER NO.4995-99/PA-CCP, DATED: 16.08.2024 OF THE CAPITAL CITY POLICE OFFICER (CCPO) PESHAWAR, VIDE WHICH APPEAL OF THE PEHTIONER AGAINST ORDER DATED: 09.02.2024 OF DPO, KHYBER WAS REJECTED.

On acceptance of Instant Revision Pelition, impugned orders dated: 29.02.2024 (of District Police Officer, Khyber) and 16.08.2024 (of the Capital City Police Prayer. Officer, Peshawar) may be set aside and Pelitioner may be re-instated in service with all consequential benefits.

Respected Sir.

- 1. That Petitloner was emisted as Sepoy in Khyber Khossadar Force (Now meiged in Khyber Pakhtunkhwa Police), in the year 2007 and since then till issuance of impugned order dated: 29.02.2024, performed duties with zeal/devotion and utmost satisfaction of the superion. evident from absorption of his services in the Khyber Pokhtunkhwa Police Department, vide Notification dated: 13.02.2720 [Serial No.935], needless to add that all those employees. having spoiless coreer and outstanding performance, were merged in the Khyber Pakhtunkhwa Police Department.
- 2. That Pelltioner, while posted at Police Station Jamrud, was served with charge sheet No.6620/PA-DPO Khyber, dated: 04.09.2023 and leveled the following ategations:

"As per learned sources it is reported that FC Shahzeb Khan No,1324 of District Police Khyber while deputed at Police Station Jameud, was found involved in coalocts with drug peddlets in the area. It is reported that he is in contacts with elements, who are involved in drug pedaling and Harcotics Activities and also involved in concealment of selved contraband. These ach come under the meaning of miscanduct as aft Section 2(bi) and render him Sobie for publishment Under Section 3(b) of the Khyber Pakhunkhwa Folice Zules, 1975."

Pelilianer submitted comprehensive rapty to the allegations ibid and claimed innocence.

3. That Petitioner was served with final Show Cause Notice No.2527/PA-DPO-Knybox dated: 24,11,2023 with the following occusation:

That inquity Officer in his findings vide No.340/PA, dated: 14.10.2023 finds you guilty of the charges leveled against you as in charge sheet No.6426/PA-DPO Khyber dated: 04.09.2023, That the inquiry Offices in his findings in the enough full oted against you found you pullity of the charges and recommended award of punishment as per Rule."

Petitioner submitted reply to the Show Cause Holice fold within the slipulated time and not only." claimed innocence but also requested for personal hearing.

- 4. That DPO Khyber, without either giving apportunity of hearing or conducting regular inquiry into the matter or providing free and fair apportunity to defend himself, imposed major penalty of dismissal from service upon Petitioner, vide Order No.925/PA-DPO Khyber, dated: 29.02.2024.
- 5. That Pelillioner pretented appeal dated: 12.03.2024, under Rule-11 at the Khyber Pakhlunkhwa Police Rules, 1975 to the Capital City Police Officer, Feshawar, however, rejected vide impugned Order dated: 16.08.2024.
- That Petilioner, being aggrieved of orders dated: 29.02.2024 (of DPO Khyber) and 16.08.2024 of CCPO, Peshawar), approaches your esteemed office, by invoting revisional jurisdiction under Rule 11-A of the Khyber Pathtunkhwa Police Rules, 1975, Inter-alia, on the following Grounds:



GROUNDS:

- that impugned orders of both the loras below are against the law, facts and material available on file, hence untenable.
- that Petilianer was charged Nazeer Khan, in case FIR No.220, dated: 25.08.2024. Under Section 9-D CNSA. Police Station Januard, instead of Muhammad Israr, who was the real accused and was allegedly released by Petitioner, without any legal / criminal proceedings, which is altogether baseless and carry no legal weight, because:
 - Accused Nazeer Khan and Muhammad Israr have been charged in case FIR No.220 dated: 25.08.2024. Under Section 9-D. CNSA. Police Station, Jamrud. by complainant Khalid Khan ASHO. apprehended in presence of constables Hashim. Zeenat Shah and the FIR was chalked by Moharrar Akhtar Hussain, which clearly indicates that Petitioner was neither present on the spot nor he played any role in the entire episode.
 - ii. Accused Muhammad Israr was arrested by the local police and after associating him with the investigation, he was granted Post Arrest Bail by the learned Additional Sessions, Judge-It, Khyber, vide order dated: 12.09.2023, while co-accused Nazeer Khan is behind the bars.
 - iii. Itial in the aforementioned case has been commenced and charge has been figured against both the accused, vide order dated: 22.06.2024 and date: 03.08.2024 was fixed therein for anward proceedings, but astonishingly none of the accused has taken the plea, on the basis whereof Pelitioner has been shunt-out from service.
- C. That Pelitioner has neither been provided opportunity of hearing nor regular inquiry has been conducted into his alleged accusation, hence has been condemned unheard, which attracts the doctrine of audi alteram partern.
- D. That no iota of evidence is available on file which could substantiate the alleged hearsay charges/accusation against Petitioner. Moreover. Petitioner has neither been treated in accordance with law nor he has been extended equal protection of law, enshrined in Articles 4 & 10-A of the Constitution of Islamic Republic of Pakistan, 1973.
- E. That more than 17 years spotless career of Petitioner has been done away with single stroke of pin without care and caution of its legal consequences, moreover, impugned order dated: 29.02.2024 has been passed surmises and conjectures, hence carry no legal weight.
- F. That charges leveled against petitioner in the charge sheet dated: 04.07.2023 are not commensurate with the charges leveled in the final Show Cause Notice, more-so final Show Cause Notice dated: 24.11.2023 was based on charge sheet No.6626/PA-DPO Khyber, dated: 04.09.2023, which has never been communicated to petitioner, rather the said charge sheet was issued to Ex-FC Aziz Khan, which speaks volumes of malafide on part of the Respondent Department.
- G. That any other ground, with the permission of your honor, will be taken at the time of personal hearing, if granted.

It is, therefore, most humbly proyed that on acceptance of instant Revision Petition, impugned orders dated: 29.02.2024 (of District Police Officer, Khyber) and 16.08.2024 (of the Capital City Police Officer, Peshawar) may be set aside and Petitioner may be re-installed in service with all consequential banelits.
