

**PRAYER:**

*On acceptance of the instant Service Appeal:*

- a. *Direct the respondents to include the appellant's name in the BPS-17 seniority list and ensure the*

appellant's promotion to BPS-18 as per the inter se seniority rules and the KPPSC merit list.

- b. Direct the respondents to count the appellant's service period in BPS-17 from the same date as (30/09/2021) other batch-mates selected under the same KPPSC advertisement, considering the delay in issuing the selection letter.
- c. Direct the respondents to promote the appellant to BPS-18 through the same PSB& same date that recently promoted the appellant's batch-mates selected under the same KPPSC advertisement 03/2018 serial No.74.
- d. Include the appellant's name in the seniority list of BPS-17 as per the inter se seniority rules and the KPPSC merit list.
- e. Promote the appellant to BPS-18 through the same PSB that recently promoted the appellant's colleagues who were selected under the same KPPSC advertisement No.03/2018 serial No.74.
- f. Ensure that the appellant's name is included in the BPS-18 seniority list in accordance with the principles of inter se seniority rules and the KPPSC merit list.

g. Count the appellant's service period in BPS-17 from the same date (30/09/2021) as the other batch-mates selected under the same KPPSC advertisement, ensuring parity in seniority and promotion prospects, as the delay in receiving the selection letter should not adversely affect the appellant's seniority

Any other remedy which this Hon'ble Tribunal deems fit that may also be awarded in favour of the appellant.

**Respectfully Submitted:**

1. That the Khyber Pakhtunkhwa Public Service Commission Advertised the post of Head Nurses BS-17, on dated 09/02/2018 through Advertisement No. 3/2018. (Copy of advertisement is attached as annexure "A").
2. That the appellant was selected for the post of Head Nurse (BPS-17) by the Khyber Pakhtunkhwa Public Service Commission (KPPSC) based on the merit list issued under the same advertisement No. 03/2018

serial No.74 as other colleagues. (Copies of Merit List is attached as annexure "B").

3. That the appellant has been serving in the Health Department on a regular basis since 5th January 2015.
4. That despite being selected on merit by the KPPSC and in accordance with inter se seniority rules (it is clearly stated that merit is the foremost criterion for determining seniority for promotion), the appellant's name has not been included in the seniority list of BPS-17 as per rules.
5. That batch-mates who were selected alongside the appellant in the same KPPSC advertisement 03/2018 serial No.74 have been promoted to BPS-18 as per the seniority list, whereas the appellant's name has not been included as per inter-se seniority rules or considered for promotion to BPS-18. (Copy of Seniority List is attached as annexure "C").

6. That the KP Public Service Commission issued the merit list late, and consequently, the appellant received the selection letter later than some of the batch-mates who were selected under the same merit list and advertisement. However, as per inter se seniority rules, merit is the top priority for determining seniority.
  
7. That despite the appellant's repeated appeals to the Health Department and the Director General Health Services (DGHS) KP Peshawar for the correction of the seniority list to include the appellant's name as per the KPPSC merit list and inter se seniority rules, the respondents failed to address the issue. (Copies of Departmental Appeal is attached as annexure "D").
  
8. That the Health Department has recently promoted the appellant's batch-mates, selected under the same KPPSC advertisement, to BPS-18 through the Provincial Selection Board (PSB). However, the appellant's name was again excluded from the promotion and the seniority list. (Copy of letter of BSB is attached as annexure "E").



9. That the appellant aggrieved from the impugned transfer order and having no other remedy preferred the instant service appeal on the following grounds:

**GROUND:**

- A. That the omission of the appellant's name from the seniority and promotion lists is arbitrary and without lawful justification, violating the inter-se seniority rules.
- B. That the KPPSC merit list and inter se seniority rules serve as the basis for the selection and promotion of candidates, and the appellant is entitled to the same treatment as batch-mates who were selected and promoted under the same process.
- C. That the delay in issuing the merit list and selection letter by the KP Public Service Commission should not result in a loss of seniority or promotional opportunities for the appellant (as he already serving on same Health department on regular basis

as a (RNO) Registered Nurse Officer (BPS-16) since 5<sup>th</sup> January 2015.

D. The failure of the respondents to address the appellant's appeals for correction of the seniority list constitutes a violation of the appellant's rights under the law.

E. The appellant is suffering undue hardship and professional stagnation due to the respondents' failure to act in accordance with the inter se seniority rules and the KPPSC merit list.

F. That other ground will be raised at the time of arguments with the prior permission of this Hon'ble Tribunal.

It is, therefore, respectfully prayed that on acceptance of the instant Service Appeal:

h. Direct the respondents to include the appellant's name in the BPS-17 seniority list and ensure the appellant's promotion to BPS-18 as per the inter se seniority rules and the KPPSC merit list.

- i. Direct the respondents to count the appellant's service period in BPS-17 from the same date as (30/09/2021) other batch-mates selected under the same KPPSC advertisement, considering the delay in issuing the selection letter.
- j. Direct the respondents to promote the appellant to BPS-18 through the same PSB& same date that recently promoted the appellant's batch-mates selected under the same KPPSC advertisement 03/2018 serial No.74.
- k. Include the appellant's name in the seniority list of BPS-17 as per the inter se seniority rules and the KPPSC merit list.
- l. Promote the appellant to BPS-18 through the same PSB that recently promoted the appellant's colleagues who were selected under the same KPPSC advertisement No.03/2018 serial No.74.
- m. Ensure that the appellant's name is included in the BPS-18 seniority list in accordance with the principles of inter se seniority rules and the KPPSC merit list.
- n. Count the appellant's service period in BPS-17 from the same date (30/09/2021) as the other batch-mates selected under the same KPPSC

advertisement, ensuring parity in seniority and promotion prospects, as the delay in receiving the selection letter should not adversely affect the appellant's seniority.


- o. Any other remedy which this Hon'ble Tribunal deems fit that may also be awarded in favour of the appellant.



01. They will be on probation initially for a period of one year extendable for a further period not exceeding one year.
02. Their Services can be dispensed with during the probation period, if their work and conduct found unsatisfactory.
03. Their appointment will be subject to medical fitness and verification of character and antecedents/Educational qualification etc by the respective Medical Supdt./ District Health Officer from the concerned Board/Faculty etc.
04. They will not be entitled to any TA/DA for medical examination and joining their first place of appointment.

05. They will be governed by such Rules and orders as may be issued by the Government from time to time for the category of Government Servants to which they belong.
06. They are liable to be posted/served any where in Khyber Pakhtunkhwa/FATA.
07. They will complete normal tenure at their places of 1st posting as per Government rules.
08. They will submit an undertaking on judicial stamp paper stating that the documents submitted with application form are genuine and not fake. Moreover they have not been dismissed from Service by any Govt. or semi Govt. organization.
09. If they wish to resign from Service, they will resign in writing by giving prior notice of one month OR deposit one month pay in lieu of one month's advance notice, in the Government treasury. However they will continue to serve the Government till their resignation is accepted by the competent authority.

If the above terms and conditions are acceptable to them, they should submit arrival report in the institutions mentioned against their names for duty within (14) days of the issuance of this order.
