

**Respectfully Sheweth:**

**Brief facts**

1. Appellant was inducted in the Police Department as a constable on 29-12-1991 on regular basis and then promoted to the post of ASI on 08-03-2019. Since then appellant has been serving as ASI and performing his duty with great zeal and honesty. Copy of service card is enclosed as **Annexure A.**
2. That on 11-01-2023 respondent No.2 issued promotion list E regarding the promotion of Assistant Sub Inspectors to the post of Sub Inspector in which appellant is present at serial No.166. Copy of promotion list E of year 2023 is enclosed as **Annexure B.**
3. That on 13-05-2024 respondent No.2 without issuing seniority list of year 2024 issued a promotion list containing 71 Assistant Sub Inspectors and to call them to appear before the Departmental Promotion Committee meeting held in his office on 16-05-2024. The name of appellant is present at serial No.37. Copy of Call letter dated 13-05-2024 issued by respondent No.2 is enclosed as **Annexure C.**
4. Then respondent No.2 instead of promoting the appellant along with other senior Assistant Sub Inspectors who were present from serial No.165 to 187 in seniority list 2023 promoted the Levies and Khassa Dar police officials of South Waziristan District from Assistant Sub Inspectors to Sub Inspectors on 16-05-2024. Appellant submitted an application to the respondent No.2 for obtaining the seniority list of year 2024 and promotion order dated 16-05-2024 but respondent No.2 refused the request of appellant. Copy of application is enclosed as **Annexure D.**

5. Then on 20-06-2024 appellant submitted departmental appeal against the promotion order dated 16-05-2024 to respondent No.1 who refused to accept the appeal of appellant and returned it to the appellant. Copy of departmental appeal as well postal envelop are jointly enclosed as **Annexure E.**

6. That as per legal requirements, the appellant has been left with no other option but to agitate his grievances before this Honorable Tribunal inter alia on the following grounds:

**Grounds:**

1. That order passed by the departmental authority impugned hereby are arbitrary, discriminatory, legally and factually incorrect, ultra virus, vide ab initio and militate against the principal of natural justice. Hence liable to be set aside.,
2. That appellant is entitle for his due promotion from the post of Assistant Sub Inspector to Sub Inspector according to the promotion list E of the year 2023 but was deprived from his said due promotion by the respondents without any justification and reason. Thus the act of the respondent by not considering the appellant for his due promotion is illegal, discriminatory, void, against the promotion criteria as well as police rules.
3. That the respondent No.2 instead of issuing seniority list of the year 2024 directly issued promotion order dated 16-05-2024 and granted out of turn promotion to the Assistant Sub Inspectors of Levies and Khasa Dar forces of merged area of KPK SWD to the post of Sub Inspector and deprived the appellant without following the seniority list of the year 2023, criteria for the promotion given in the police rules, training, courses of upper and lower and other courses which are necessary for the promotion of ASI to SI. Therefore the act of respondent is illegal, void, against the police rules, promotion criteria, and seniority list and thus liable to be set aside.

4. That the appellant is qualified, senior, passed required examinations as well as training courses for the promotion of ASI to SI but respondent No.2 granted promoting out of turn to those Assistant Sub Inspectors of KhasDars and Levies forces of merged areas who were illiterate, junior, untrained, unqualified and incompetent as compared to the appellant. The promote ASIs have never passed the required training courses which are necessary for the promotion of ASI to the SI. Hence this out of turn promotion without issuing seniority list of year 2024 is against the police rules and demolished the whole structure of police force. Therefore the impugned promotion order against the appellant is illegal and needs to be set aside.
5. That the council for the appellant may graciously be allowed to raise additional grounds at the time of arguments.

**It is, therefore, most humbly prayed on the acceptance of instant appeal Respondents may kindly be directed to promote the appellant according to the seniority list of year 2023 from the post of ASI to the SI with all back benefits from date of 16-05-2024, by setting aside the impugned promotion order dated 16-05-2024.**



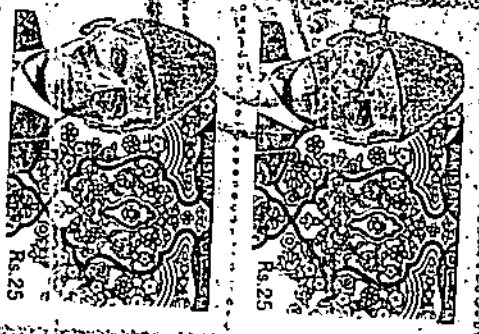
