SERVICE APPEAL U/S 4 OF THE SERVICE TRIBUNAL ACT, 1974 AGAINST THE IMPUGNED ORDER DATED:14.03.2024 WHEREBY MAJOR PENALTY OF REMOVAL FROM SERVICE WAS IMPOSED UPON THE APPELLANT AND HIS DEPARTMENTAL APPEAL FOR RE-INSTATEMENT IN SERVICE WAS FILED AND WAS NOT COMMUNICATED TO THE APPELLANT.

Prayer

By accepting this Appeal, the impugned orders dated 14.03.2024 & order on Departmental Appeal may please be set aside and the appellant may be reinstated in his service with all back benefits.

### Respectfully Sheweth:-

- That the appellant consequent upon the recommendations of Departmental Selection Committee was appointed through order dated:28.04.2017 against the post of CT in Government Middle School Warga Banda District Karak. (Copy of the Appointment order dated:28.04.2017 is annexed as Annexure "A").
- 2. That appellant performed his duties to the entire satisfaction of his Superiors and there was no complaint against the appellant from any quarter. The appellant performed his duties with devotion and dedication to his work.
- 3. That the appellant was awarded Presidential Scholarship in the subject of Chemistry under the Chiness Presidential Scholarship Program for admission in Material Sciences, Qingdao University, Qingdao China.
- 4. That the appellant for securing higher studies applied to the District Education Officer through proper channel for grant of NOC and for four years study leave for Ph.D Program in the subject of Chemistry w.e.f 01.10.2023 to 30.09.2027. The application of the appellant was forwarded to the District Education Officer, Karak. (Copy of the application along with admission notice are annexed as Annexure "B").
- 5. That the appellant was told by the District Education Officer that since process of accepting application of the appellant for leave will take sufficient time therefore, he should leave for China to join his studies. The appellant as per advice of the District Education Officer proceeded to China and joined his studies.
- 6. That the appellant was receiving his monthly salary uptil March, 2024 whereafter it was discontinued and as the appellant was in China therefore, he through relative got information from the Education Office District Karak,

that he has been removed from service without following codal formalities vide order dated:14.03.2024. (Copy of the Salary Slips, Show Cause Notice and order dated:14.03.2024 are attached as Annexure "C").

- 7. That the appellant preferred a Departmental Appeal to the respondent No.01, to which report is submitted by DEO Karak. The appellant was called for personal hearing through letter dated:30.07.2024 but as the appellant was in China therefore, he was unable to have received or got information of the letter dated:30.07.2024. (Copy of the Departmental Appeal, report dated:09.05.2024 and letter dated dated:30.07.2024 is annexed as Annexure "D").
- 8. That when the appellant landed in Pakistan on 21.07.2024 therefore, he on 24.07.2024 submitted application for personal hearing. (Copy of the Passport and application are attached as Annexure "E").
- 9. That the respondents were not giving reply to the appellant therefore, he approached RTI Commission for doing the needful who through letter dated:05.09.2024 informed that his appeal has been seen and filed. (Copy of the letter dated:05.09.2024 is annexed as annexure "F").
- 10. That appellant being aggrieved wherefrom is filing the instant appeal on the following amongst other grounds:

#### GROUNDS:

- A. That the appellant has treated un-equally, against the law and thus is deprived of equal protection before the law.
- B. That the impugned order passed by the department/respondents are illegal, against the facts

and valuable rights of the appellant hence not maintainable and is liable to be set aside.

- C. That the appellant was removed from service through the impugned order dated 14.03.2024 on the ground of willful absence of duty but the respondents has not proceeded against the appellant in accordance with law and flagrantly violated Rule-09 of the Government Service (Efficiency and Disciplinary Rules, 2011).
- D. That the appellant has moved application for leave through proper channel and impression was given to the appellant that his leave application will be approved in due course of time therefore, he should leave for China for joining his studies although under the leave rules the appellant was entitled for study leave which was illegally declined to the appellant.
- E. That appellant is a poor person and the only earning hand of the family therefore he is also entitled to reinstatement.
- F. That as per judgment of the Superior Courts of the country the punished imposed should commensurate with the gravity offence but in the case of appellant such principles has been violated by the respondents.
- G. That Respondents have awarded maximum punishment to the appellant and thus have cause serious miscarriage of justice

H. That any other ground will be raise at the time of arguments with the prior permission of this Honourable Tribunal.

It is, therefore most humbly prayed that accepting this Appeal, the impugned orders dated 14.03.2024 & order on Departmental Appeal may please be set aside and the appellant may be reinstated in his service with all back benefits




