
GROUND:-

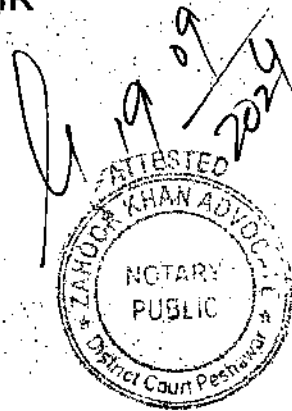



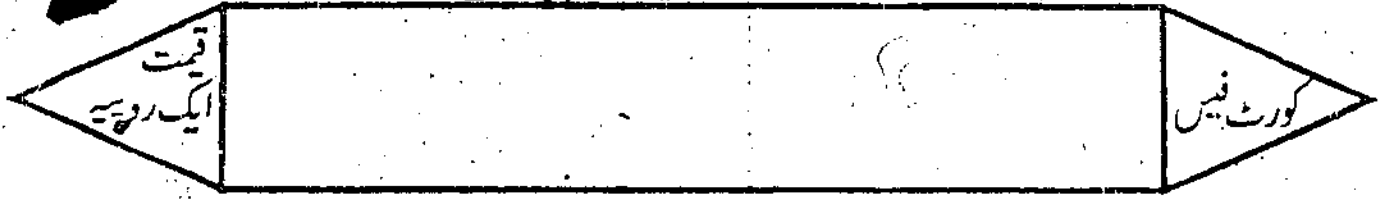
