**APPEAL UNDER SECTION 4 OF THE KHYBER PAKHTUNKHWA SERVICE TRIBUNAL ACT 1974 AGAINST THE IMPUGNED INACTION OF THE RESPONDENT BY VIOLATING THE SERVICE RULES NOTIFIED ON: 10/05/2016 AS AMENDED VIDE NOTIFICATION DATED 04/10/2020 OF THE RESPONDENT DEPARTMENT, WHEREBY THE RESPONDENTS ARE GOING TO PROMOTE THE MASTER IN PUBLIC HEALTH DEGREE HOLDER TO THE POST OF PHC TECHNOLOGIST MULTIPURPOSE (BPS-17) ON THE BASIS OF MASTER IN PUBLIC HEALTH DEGREE HOLDER AND AGAINST THE INACTION OF THE RESPONDENTS BY NOT DECIDING THE DEPARTMENTAL APPEAL OF APPELLANT WITHIN THE STATUTORY PERIOD OF NINETY DAYS.**

**PRAYER:**

That on acceptance of this appeal, the impugned action of the respondents by promoting Master in Public Health Degree Holder to the post of PHC Technologist (MP) {BPS-17} in utter violation of service rules of the Health Department, may kindly be set aside and the respondents may kindly be restrained, not to promote the Degree Holder of Master in Public Health to the post of PHC Technologist (MP) {BPS-17}. Any other remedy which this august Court deems fit may also be awarded in favor of appellant.

**R/SHEWETH:**

**ON FACTS:**

- 1) That appellant was initially appointed as PHC Technician BPS-12 and start performing his duties quite efficiently and to the entire satisfaction of his superior.
- 2) That it is important to mention here that the appellant applied for acquiring his degree for which the respondent department issued

NOC to the appellant and after fulfilling all the legal and codal formalities, the appellant got admission in the relevant field of technology at Khyber Medical University, whereafter the appellant acquired the degree in the relevant field. Copy of the degree is attached as annexure.....A

3) That the Health Department published in the official gazette through notification dated 10/05/2016 framed service rules as amended in the year, 2020. It is important to mention here that according to ibid rules and specifically amendment in the rules provided that the degree holder of Master in Public Health shall be considered for promotion only for those categories, where degree in the relevant technology does not exists, in this the MPH degree holder shall only be promoted to the PHC Technologists (MCH) and Clinical Technologist Pharmacy as there is no degree exists in these two categories of technology. Copy of service rules is attached as annexure.....B

4) That it is also pertinent to mention here that the respondent No 1 through letters dated 10/03/2021 & 06/06/2023 clarify that only BS Health Technology, BS Emergency Care Technology & BS ICU Technology can be considered for the post of PHC Technologist Multipurpose and the appellant acquired degree in BS ICU Technology and is eligible for promotion to the post of PHC Technologist (MP) and accordingly the MPH Degree holder is not eligible to be promoted to the post of PHC Technologist MP in accordance with these letters and according to the service rules. Copies of letters dated 10/03/2021 & 06/06/2023 are attached as annexure.....C

5) That vide notification dated 20/03/2024 the respondent department made promotion to PHC Technologist (MP) BPS-17 from the degree holder in the relevant technology, which clarify that degree course of PHC Technologist (MP) exists. Copy of the notification dated 20/03/2024 is attached as annexure.....D

6) That the respondents just to facilitate blue-eyed persons, a meeting of pre departmental promotion committee was held on 02/08/2024 for the promotion of MPH degree holder, which is violation of the service rules of the respondent department and also against the letters mentioned in the aforesaid Paras. Copy of the letter dated 23/07/2024 is attached as annexure.....E

7) That it is important to mention here that the respondent department vide dated 03/09/2024 scheduled a meeting of Departmental Promotion Committee for the promotion to the post of PHC Technologist (MP) (BPS-17) from other technologies as well as from MPH degree holders, which is clear from the heading

of the said letter dated 03/09/2024. Copy of the letter dated 03/09/2024 is attached as annexure.....F

- 8) That felling aggrieved appellant preferred departmental appeal before the respondents, but no response has been given by the respondent department till the expiry of statutory period of ninety days. Copy of the departmental appeal is attached as annexure.....G
- 9) That having no other remedy the appellant filed the instant appeal on the following grounds amongst the others:-

**GROUND:**

- A) That the inaction of the respondents by promoting the MPH Degree Holders to the post of PHC Technologist (MP) is against the law, facts and norms of natural justice.
- B) That the appellant has not been treated by the respondent Department in accordance with law and rules on the subject noted above and as such the respondents violated Article 4 and 25 of the constitution of Islamic Republic of Pakistan 1973.
- C) That the respondent Department acted in arbitrary and malafide manner by promoting the MPH Degree Holders to the post of PHC Technologist (MP).
- D) That the appellant has been discriminated by the respondent Department on the subject noted above and as such the respondent violated the principle of natural justice.
- E) That the action and inaction of the respondents is violative Section-9 of the civil servant Act, 1973 read with Rule-7 of the appointment, promotion and transfers Rules, 1989.
- F) That the action and inaction of the respondents is violative Article 38-E of the Constitution of Pakistan, 1973.
- G) That the respondents are going to facilitate the blue eyed employees by promoting the MPH Degree Holders to the post of PHC Technologist (MP).
- H) That the respondent department also violating their own service rules by promoting the MPH Degree Holders to the post of PHC Technologist (MP).
- I) That MPH degree shall not be considered for promotion where degree in the relevant technology exists.

- J) That it is important to mention here that in the category/cadre of PHC Technician (MP), the degree of health technology, ICU Technology & Emergency Technology exists, therefore, those PHC Technician who did not acquired degree in the relevant technology may not be promoted to the Health Technologist (MP) on the basis of MPH Degree.
- K) That the appellant seeks permission to advance other grounds and proofs at the time of hearing.

It is therefore most humbly prayed that appeal of the appellant may be accepted as prayed for.



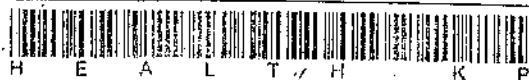
