APPEALS UNDER SECTION-4 OF THE KHYBER PKHTUNKHWA SERVICE TRIBUNAL ACT, 1974 AGAINST **IMPUGNED** ORDER NO. SO(TOURISM)5-81-2022/VOL-III, DATED, MAY, 2024, VIDE WHICH MINOR PENALTY OF "WITHHOLDING OF INCREMENT PROMOTION FOR TWO YEARS" HAS BEEN IMPOSED UNDER RULE-14(5)(II) OF KHYBER PAKHTUNKHWA E & D RULES, 2011, AGAINST WHICH DEPARTMENTAL APPEAL/REVIEW PETITION HAD BEEN FILED THROUGH UMS ON 21ST MAY, 2024, BUT THE SAME HAS NOT BEEN DECIDED WITHIN STIPULATED PERIOD OF 90 DAYS, HENCE, THE INSTANT APPEAL WITHIN STATUTORY PERIOD OF 30 DAYS:

Respectfully Sheweth:

The appellant very humbly submitted as under:-



- 1. That the Competent Authority initiated an enquiry proceeding against appellant on the ground that you have promoted 07 employees of PAITHOM without prior approval of the Competent etc duly mentioned in the statement of allegation/charge sheet and Mr. Amer Latif (PCS-EG BS-20) Member-I, Board of Revenue was appointed as an inquiry officer. (Copy of the notification, Statement of Allegation & Charge Sheet is herby encsleod as Annex-A, A/1 & A/2 respectively).
- That the on the basis of Charge Sheet/Statement of Allegation, Appellant was asked to submit Written
 Defense Within seven days to the inquiry Officer, which was accordingly submitted within stipulated period of time. (Copy of which is hereby encsleed as Annex-B).
- 3. That thereafter the inquiry officer conducts the enquiry in Questioner form and reply has been asked from the Appellant. Finally inquiry report was submitted in which the Charge/Allegation No. 1 & 2 stands proved, however, the allegation No. 3 does not stand proved. (Copy of the Inquiry Report is herby enclosed as Annex-C).
- 4. That thereafter on the basis inquiry report, final show cause notice was served on 13rd September, 2023, in which the Competent Authority have tentatively decided minor penalty of "Withholding of increment and Promotions for two years" and Appellant was asked to reply within 14 days on delivery of show cause notice which was formally submitted by refuting allegation in the Show Cause Notice. (Copy of the letter with Show Cause and reply is hereby encsleed as Annex-D, D/1 & E respectively).
- 5. That competent authority after considering the charge sheet/Statement of allegations and reply to the show cause notice imposed minor penalty of "Withholding of increment and promotions for two years" vide, impugn order, dated, May 06, 2024. (Copy of the impugn order is hereby enclosed as Annex-F).
- 6. That appellant aggrieved from the impugn order filed review petition/department appeal before the Chief Minister Khyber Pakhtunkhwa on 21 May, 2024 through UMS, however, Appeal/ review petition of the appellant

was not decided within stipulated period of 90 days. (Copy of the review petition with UMS receipt is herby enclosed as Annex- G & G/1 respectively).

7. That the appellant herein seriously aggrieved from the impugned orders in which two overlapping minor punishments has been awarded, hence, approach to this Hon'ble Tribunal, through the instant appeal, inter-alias, on the following grounds:

GROUNDS:

- A. That the order passed by the competent authority, impugned herein is discriminatory, arbitrary, legally and factually incorrect and thus are liable to be set-aside by this Hon'ble Tribunal.
- B. That the impugn order of minor penalty based upon unsubstantiated allegations because the promotion order 07 employees of PAITHOM has been subsequently withdrawn, despite of which Minor Penalty has been imposed.
- C. That the Competent Authority recommended Minor Penalty within the meaning of Section-4(a) (ii) but instead of withholding Promotion or increment for two years" the two overlapping minor punishment has been simultaneously awarded for the same charge which is not sustainable in the eyes of law.
- D. That the allegation leveled in the charge sheet had never been proved against appellant. The inquiry officer neither recorded any evidence nor brought on record any documents through Departmental Representative in order to confront the appellant and inquiry in shape of questioner was recorded, irrespective of the fact that the appellant was not awarded any opportunity of any cross examination upon the evidence brought on record.
- E. That enquiry committee report is based upon on assumption and presumption. There is nothing on record which can suggest that charges No-1 & 2 can prove against the appellant, while, on the other hand, appellant submitted sufficient material in reply which was not discussed at all in the inquiry report.
- F. That the appellant was subjected to discriminatory treatment as he done the order of promotion in good

faith which was subsequently withdrawn, despite of which minor penalty has been awarded.

- G. That the appellant rendered meritorious service and there is no adverse entry of any misconduct or insubordination during the entire service and the penalty impugn herein would ruin the bright carrier of the appellant in the long run. The enquiry officer totally deviated from the procedure laid down in the E&D Rules.
- H. That the order passed and impugn herein caused grave miscarriage of justice to the appellant without solid proof of allegations. The enquiry Officer utterly failed to conduct the enquiry as per procedure laid down in the E&D rules.
- I. That the appellant will seek permission of this Hon'ble Tribunal to urge additional grounds at the time of argument of this appeal.

It is therefore most humbly prayed that on acceptance of the instant appeal, this Hon'ble Tribunal may graciously be pleased to set-aside the impugn order No. SO (Tourism) 5-81-2022/VOL-III, dated, 6th May, 2024, vide which overlapping punishment of minor penalty of "Withholding of increment and promotion for two years" has been imposed simultaneously under Rule-14(5)(ii) of Khyber Pakhtunkhwa E & D Rules, 2011, and the same may be declared being illegal, void-ab-initio and of no legal effect and not in accordance with the law OR any other remedy deemed proper and appropriate may also be allowed.

SUBMISSION OF WRITTEN DEFENSE AGAINST CHARGE SHEET

Respected Sir,

I, Hurmat Yab Khan, Chief Instructor hereby submit my written statement as defense against charge sheet vide notification no. SO(T)/5-81/PAITHOM/2023/3553-59 dated 30-05-2023 received to the undersigned on dated 03-06-2023 wherein the undersigned is charged with following statement of allegations wherefore defense is submitted as under please.

1. He promoted seven (07) employees of PAITHOM vide Office Orders dated 19.02.2020 and 02.03.2020 without prior approval of the competent authority, since the case of regularization of PAITHOM's employees was adjudicated before the court of law at that time.

Défence:

- a. It is true to the extent that undersigned only promoted Five (05) employees under powers conferred upon the undersigned under governing rules & regulations of PAITHOM attached as Annex-A. Under the same rules the Ministry of Tourism (Defunct) while regularizing the services of 21 employees of PAITHOM under the direction of Establishment Division, Regulation Wing notification attached as Annex-B allowed the undersigned to regularize the services of these 21 employees w.e.f 01-07-2008 attached as Annex-C under deliberations of the governing rules and regulations of PAITHOM as the power of Appointment, Confirmation and Promotion lies with the Head of the Institute vide Rule 12 sub rule 11.
- b. The undersigned had a staff of 26 employees without any assigned duties and were only drawing salaries. The PAITHOM purpose built building located at Gulibagh Swat was under control of PAK ARMY since 2007 due to which institute had to function as camp office in private rented building in Amankot, Mingora Swat. In order to architect and provide a professional office atmosphere the undersigned being administrative head picked up those lower staff who were educated and ability to perform were allocated additional duties without any extra remuneration. (Annex-D) One of them had also got trained from Tourism Department in accounts section in 2015 (Annex-D-I). The PAITHOM employees have filed a writ petition claiming after service benefits which was graciously allowed by the August High Court, Dar ul Qaza, Mingora Bench on 18-04-2018 decision attached as Annex-E wherein the PAITHOM employees were awarded status of Civil Servants along with all back benefits. Before the vary decision PAITHOM employees were drawing their salaries on regular basis but without any deductions of GP fund, death compensation, Tax etc., but in contrary to this the department did not implemented the decision of the August Court and in response thereto filed a CPLA in the honourable Supreme Court of Pakistan which was disposed off in January, 2020 due to 21 days time barred attached as Annex-E. So at time



of promoting staff there was no adjudication in progress which is evident and attached as proof and undersigned in due prudence and diligence promoted staff as allowed under governing rules of PAITHOM institute and a copy for information was sent to the department and in response thereto the department vide their order dated 22-06-2020 directed the undersigned to hold these promotions and up-gradations in abeyance which was complied with on dated 24-06-2020 and since then these promotions are laying held in abeyance attached as **Annex-F-1 & F-2**.

- c. Later on an inquiry was initiated on the appeal of Mr. Akbar Ali who was promoted to the post of Cashier by the departmental inquiry committee and the whole proceedings of the committee are attached as **Annex-H** for your inspection please.
- d. The rest of the two employees were promoted vide a PAITHOM departmental promotion committee and the minutes of same are attached herewith as Annex-H-I.
- 2. He re-designated the post of Supervisor (BPS-07) to House Engineer (BPS-16) in favour of Mr. Had Nawaz vide Office Order dated 20-06-2013 without approval of the competent authority.

Defense:

1. The undersigned redesignated Mr. Haq Nawaz to the post of Engineer Incharge, a sanctioned post in BPS-16 (sanctioned posts PAITHOM attached as Annex-I) but not on the post of House Engineer because undersigned has got a precedent in hand which is detailed in the following paragraphs. Mr. Haq Nawaz was appointed in January, 2000 (contract attached as Annex-J) as House Engineer on a consolidated salary of Rs:15000/- per month initially for a period of one year by the then Ministry of Tourism (Defunct). The President of Pakistan approved sanction for creation of 93 regular posts in the institute in 2004 (Annex-K) wherein the nomenclature of the post of House Engineer was converted to Engineer Incharge BPS-16.

2. Mr. Haq Nawaz had continuous grievances on the reason being that in 2011 while regularizing the services of employees working on contract for last two years under regularization policy under directive of Establishment Division Office Memorandum the MoT (defunct) regularized the services of Mr. Haq Nawaz by redesignating him on the post of Supervisor (07) instead of House Engineer BPS-16 under the same rules and regulations of PAITHOM. (Annex-C as reference)

3. Under deliberations of 18th constitutional amendment the institute was transferred and handed over to Provincial Government KPK in 2011 along with assets and employees (Copy attached as Annex-L). The Tourism Department appointed a Focal Person as dealing desk for the institute from Tourism Corporation Khyber Pakhtunkhwa. Among these PAITHOM employees, 21 employees were having regular status while others 3 officers level staff were on contract. One among three resigned from his job as he had got job in Malakand University. In December 2012, the services of two officers (Chief Instructor BPS-19 & Management Secretary BPS-16) were regularized in PAITHOM from date of initial appointment but it is again worth noting that the post of Management Secretary BPS-16 were redesignated as Administrative Officer BPS-17 and somuchso the services rendered in BPS-16 were also not calculated setting aside

rules and regulations and his pay was also affixed in BPS-17 with his initial date of Appointment. (Copies of proof attached as Annex-M).

4. The department while implementing order of the court in CoC (attached as Annex-N) the department created 27 posts on the current side vide Finance Department Notification attached as Annex-P wherein the post of Mr. Haq Nawaz was created as House Engineer BPS-16.

5. The undersigned would also like to bring into your notice that in 2011 when institute was executing a NAVTTC sponsored training project the Focal Person PAITHOM directed the undersigned to adjust a person in this project and also sent a letter for this adjustment on the demand of the undersigned attached as Annex-Q and the undersigned adjusted him as visiting faculty instructor for a fixed period of 6 months Annex-Q-1. Thereafter the project was completed and he left. Thereafter, Focal Person again requested to adjust him on any post in PAITHOM and he was appointed as Housekeeping Incharge BPS-5 Annex-Q-11.

6. To cover up these redesignations the department requested Finance Department for recreating of 03 posts in PAITHOM and in response thereto Finance Department created 03 posts as requested by department (Annex-R) wherein the post of House Engineer BPS-16 was abolished and post of Supervisor BPS-07 was created as well as the post of Housekeeping Incharge BPS-05 was abolished and created as Instructor BPS-17 and post of Management Secretary BPS-16 was

abolished and post of Administrative Officer BPS-17 was created.

7. Mr. Haq Nawaz refused to submit his undertaking in the tourism department and filed a CM in the CoC which was decided in his favour and department again created his post as House Engineer BPS-16. The department issued his notification with immediate effect. The case is still adjucated before August High Court which if decided in his favour the department has to notify him w.e.f 01-07-2008 as House Engineer BPS-16. (Attached as Annex-S)

8. August Court has already addressed his grievances and granted him relief by ordering his regularization on the post of House Engineer w.e.f date of

regularization of his other colleagues. (Attached as Annex-S)

3. He failed to perform his functions as assigned to him under the law/rules and did not frame service rules for the employees of PAITHOM till date.

Defense:

As far as the drafting of service rules is concerned the MoT (defunct) has constituted a committee (Annex-T) for drafting service rules of PAITHOM and undersigned was the member/secretary of the committee. These service rules were also sent to the Focal Person PAITHOM (Annex-T-I) for perusal. Thereafter it was the liability of the department to finalize service rules by vetting them from concerned forum and undersigned may please be not held responsible for duties of the administrative department.

The fact and grounds elucidated above are true and to the best of my knowledge and wisdom. Submitted as desired please.

Report of inquiry proceedings against Mr. Hurmat Yab Khan Chief Instructor; Pakistan-Austria Institute of Tourism and Hotel Management

Preliminary

This inquiry report, hereinafter called report is based on inquiry proceedings, hereinafter called inquiry, conducted after Culture, Tourism, Archaeology & Museum Department Khyber Fakhtenkinva, hereinafter called department, Notification No. SO (T)/5-81/PAITHOM/2023/3553-59 dated 30th May, 2023. This Inquiry has been initiated and completed against Mr. Hurmat Yab Khan, the Accused Officer hereinafter called AOwho is posted as Chief Instructor at the Pakistan-Austria Institute of Tourism and Hotel Management, hereinafter called PAITHOM.

Proceedings of inquiry are annexed as Annexure-1 to this report in the form of inquiry Order Sheet. Letter No.PS to MBR-I/Inq/Tourism/13640-41 dated 05th June, 2023 sent to all concerned to attend inquiry on 26th June 2023 is annexed as Annexure-2. This inquiry has been made into three allegation communicated to all concerned vide Statement of Allegations which is annexed as Annexure-3 to this report. Reply of AO to Statement of Allegations is annexed as Annexure-4 to this report. Mr. Akhlaq Ahmed Section Officer of department assisted in inquiry as Departmental Representative, hereinafter called DR. Questionnaires framed by undersigned and replies of AO and DR are annexed as Annexures 5 and 6 respectively to this report.

The term Public Servant used in this report means a person as defined in Section-21 of the Pakistan Penal Code 1860 and is hereinafter called public servant. The term Civil Servant used in this report means a person as defined in the Section 2(b) of the North-West Frontier Province Civil Servants Act, 1973 and is hereinafter called civil servant.

Inquiry

During inquiry each one of the allegations, reply of AO to allegations and annexures, reply of AO in questionnaire, office record presented by DR and relevant notifications issued by Government of Khyber Pakhtunkhwa, hereinafter called government, from time to time were examined in detail following which finding against each allegation has been recorded as follow:







Allegation No.1.

You promoted 07 employees of PAITHOM vide Office Order dated 19.02.2020 and 02.03.2020, without prior approval of the Administrative Department, since the case of regularization of PAITHOM's employees was adjudicated before the court of law at that time;

1. AO promoted a total of seven (07) employees of PAITHOM in various pay scales through two separate orders (Annexures-7 and 8) as follows:

2. These employees were appointed on contract basis as PAITHOM employees, hereinafter called employees, and were therefore public servants. In April 2011 PAITHOM was transferred to government after 18th Constitutional Amendment and services of employees were devolved accordingly. PAITHOM was taken over by department.

3. As a result of Dar-ul-Qaza Swat order dated 18th April, 2018 in a Writ Petition No 507-M/2017 and after dismissal of departmental appeal by department in the Supreme Court of Pakistan on 11th January, 2020 services of employees were regularized with back benefits vide department's Notification on 21st January, 2022. This regularization meant that employees became civil servants instead of public servants.

4. Immediately after dismissal of departmental appeal in the Supreme Court of Pakistan and almost two years prior to issuance of regularization notification by department, AO issued above promotion orders on 19th February and 2nd March 2020. He did not receive any advice of department in this matter nor did he approach it for consultation prior to issuing promotion orders.

5. Since the services of employees were regularized by Dar-ul-Qaza with back benefits therefore they were civil servants at the time of issuance of their promotion orders by AO regardless of the fact that their regularization notification was issued two years later by department.

6. AO in his reply and answers to questions has argued that he had issued these promotion orders on the basis of 'powers conferred upon' him 'under governing rules & regulations of 'PAITHOM', hereinafter called regulations, (Annexure-9). The subject of PAITHOM rules have been discussed in detail under third allegation. Here, it is sufficient to record that:

Regulations which were framed prior to devolution under Federal Ministry of Tourism, hereinafter called ministry, were no longer ì. applicable to employees once they were regularized as civil

servants. Terms and Conditions of service and Promotion of civil servants are governed by the North-West Frontier Province Civil Servants Act, 1973 read with Rule 5 of the Khyber Pakhtunkhwa Civil Servants (Appointment, Promotion & Transfer) Rules, 1989 which have not been applied in these cases.

- ii. Regulation No 12(II) conferred promotion powers upon Principal /
 Director (Annexure-10) whereas AO was and is Chief Instructor
 PAITHOM. He has been called Incharge PAITHOM in official
 correspondence but there is nothing on the record that he was
 entrusted with responsibility of Principal / Director as additional
 charge or even to look after this post.
- iii. Service regulations under Regulation Serial No. 12 (II) were never approved prior to or after devolution. Therefore even if employees 'are considered as public servant in February / March 2020 there were no service regulations under which they could be promoted.
- 7. Therefore the following irregularities have been noted on the part of AO:
 - i. Promotion of seven (07) civil servants employees of PAITHOM vide Office without prior approval of department which resulted in violation of Rule 5 of the Khyber Pakhtunkhwa Civil Servants (Appointment, Promotion & Transfer) Rules, 1989.
 - ii. Exercising of powers of Principal / Director without explicit orders by department to this effect.
 - iii. Application of incorrect and unapproved service regulations in promotion process of employees who were civil servants.

Finding

The allegation stands proved against AO.

Allegation No-2.

You re-designated the post of Supervisor (BPS-07) to House Engineer (BPS-16) in favor of Mr. Hay Nawaz vide Officer Order dated 20.06.2013, without approval of the Administrative Department;

- 1. Immediately before devolution of PATTHOM to department Mr. Haq Nawaz was regularized as Supervisor in BPS-7 as public servantas evident from para-4 of Government of Pakistan Ministry of Tourism Memo No. 2(25)/2002-Plug (Pt-III) dated 9th February, 2011 (Annexure-11)
- 2. He was later regularized as civil servant along with other employees as a result of litigation noted above. But instead of accepting his regularization as Supervisor in BPS-7 he resorted to further litigation seeking for himself the post of House Engineer in BPS-16 on the grounds

that Incharge PAITHOM had already promoted him to the post of House Engineer BPS-16 in 2013 through process of redesignation of the post of Supervisor BPS-7 as House Engineer BPS-16 vide letter No.3 (1)/2011/PAITHOM-ADMN on 20th June 2013 when services of employees were not yet regularized as civil servants in government.

- 3. AO has not defined this fact and has candidly admitted in his reply to allegation and in his reply to question No-3that he has carried dut this redesignation on the analogy of redesignation once carried out by department in 2012. Therefore it is evident that AO has carried out redesignation of the post Supervisor BPS-7 to House Engineer BPS-16. Therefore the following irregularities on the part of AO have been noted in this redesignation process.
 - i. Irregular promotion from BPS-7 to BPS-16 under garb of redesignation. Redesignation is carried out in same BPS. Raising BPS of a same post is called upgradation. He thus carried out both upgradation and redesignation at the same time without due process.
 - ii. Lack of authority to carry out such redesignation in absence of approved regulations for public servants as in 2013 PAITHOM employees were working as public servants not civil servants.
 - iii. Negligence of duty as incharge PATTHOM to seek guidance and prior approval of departmentto issue redesignation / upgradation order under question if it was necessary at all though no relief was granted by any court in 2013 to beneficiary Mr. Haq Nawaz.
 - iv. Exercising of powers of Principal / Director without explicit orders by department to this effect

Finding


The allegation stands proved against AO:

Allegation No-3.

You failed to perform your functions as assigned to you under the law / rules and did not frame / draft service rules for the employees of PAITHOM till date.

- 1. Prior to devolution, PAITHOM was governed by its regulations which were issued by ministry (Annexure-9). However no supporting service regulations were operational at that time under regulation number 12 (II).
- 2. It has come to fore that in June 2009 the Federal Ministry of Tourism constituted a committee to draft service rules for employees, hereinafter called rules (Annexure-12). On 16th February 2010, Board of Governors of PAITHOM, hereinafter called board, approved rules subject to proper signing of the draft by Convener and Secretary of board so that rules







could be communicated to the Finance and Establishment Divisions for their concurrence (Annexure-13). However nothing has been found on the record that rules were either sent to Finance and Establishment Divisions or their concurrence to rules was received in PAITHOM prior to devolution in April 2011.

- 3. Instead, after devolution, on 24th July, 2011 rules were submitted to one Mr. Sajeed Hameed 'focal person' PAITHOM in Tourism Department Khyber Pakhtunkhwa 'for further perusal in the matter' (Annexure-14). DR in his reply in questionnaire has stated that 'as per available record draft rules of PAITHOM are not approved by competent forum'.
- 4. After regularization of employees as civil servants in 2020 these draft rules became irrelevant as these were meant for public servants and were to be approved by board. Under changed circumstances it became the mandate of Standing Service Rules Committee, hereinafter called SSRC, of department constituted under Services and General Administration Department Notification No. SOR. VI(E&AD)2-69/2003 dated 29th January, 2005 amended from time to time read with Rule 3(2) of the NWFP Civil Servants (Appointment, Promotion & Transfer) Rules, 1989. Service rules framed by SSRC were required to be approved by government
- 5. Therefore no irregularity noted on the part of AO as the following facts have come to fore:
 - i. AO had submitted draft service rules inherited from ministry in 2011 to focal person PAITHOM in department for approval of board which remained unapproved till regularization of employees as civil servants
 - ii. Since regularization of employees in 2020, department has yet to convene meeting of SSRC to draft service rules for them

Finding

The allegation does not stand proved against AO.

Recommendations as requested by department.

i. In short run department should frame service rules for employees through SSRC.

ii. In long run department may improve over all operational performance including service conditions of PAITHOM by introducing legislation on the analogy of KP TEVTA Act 2012

REPLY BY HURMAT YAB KHAN, ACCUSED OFFICER (A.O.) TO THE SHOW CAUSE NOTICE SERVED UPON HIM BY THE CHIEF MINISTER KHYBER PAKHTUNKHWA FOR BEING ACCUSED OF MISCONDUCT.

Respected Sir,

This is with reference to the Tourism, Culture, Archaeology & Museums Department's letter No. SO(T)5-81/2022/Vol.III, dated 13th September, 2023 (received to the A.O. on 18th September, 2023) on the subject cited above.

- 2. I, Hurmat Yab Khan, Chief Instructor (BPS- 19), Pakistan Austrian Institute of Tourism and Hotel Management (PAITHOM), Swat, may hereinafter be called as Accused Officer (A.O.). Similarly, the Tourism, Culture, Archaeology & Museums Department, Government of Khyber Pakhtunkhwa hereinafter be called as Administrative Department.
- 3. Copies of the Charge Sheet, Reply given thereto by the A.O. and the letter under reference with copy of the Show Cause Notice are attached, along with their accompaniments, as Annexure AA-I, Annexure AA-II and Annexure AA-III respectively for the facility of reference.
- 4. Sir, The Show Cause Notice appears to have been served upon the A.O. on the basis of three concocted allegations and on some finding of the Inquiry Officer whereby the view point of the A.O. was not reflected in its true perspective as is evident from the following submissions:

Allegation No.1

"You promoted 07 employees of PAITHOM vide Office Orders dated 19.02.2020 and 02.03.2020, without prior approval of the Administrative Department, since the case of regularization of PAITHOM employees was adjudicated before the Court of law at that time."

- (a) Inquiry Officer's observations at Paras 1 & 2 under this Allegation No.1 are admitted for being matter of record.
- (b) Inquiry Officer's observations at Para 3 under this allegation No.1 seems to be misleading because the Inquiry Officer appears to have tried to hoodwink the Competent Authority by, inter-alia, stating that ".....services of employees were regularized with back benefits vide department's Notification No.SO(Tourism)/5-81/2020/4350-88 on 21st January, 2022 (Annexure A-I). This regularization meant that





employees became civil servants instead of public servants." This statement is somewhat confusing and the factual position in this regard is as under:

(b-i) That on a Writ Petition No.507-M/2017, filed by PAITHOM employees, the Darul-Qaza, Swat passed an order on 18th April, 2018 that PAITHOM employees be treated as Civil Servants. However, the Administrative Department filed CPLA in the Supreme Court of Pakistan against the aforesaid Order of Dar-ul-Qaza, which was dismissed on 6th January, 2020 for being time barred. But the implementation on the Order of Dar-ul-Qaza continue lingering on till the Administrative Department notified the regularization of PAITHOM employees as Civil servants with back benefits vide their Notification dated 21st January, 2022 (Annexure A-I). This clarification proves that PAITHOM employees were Public Servants till 20th January, 2022 and there services were regulated under the Rules and Regulations of PAITHOM till that date (i.e. 20.01.2022).

(b-ii) That the facts narrated at Sub-para (b-i) above also prove that there was no adjudication for regularization of PAITHOM employees in any Court of law during the months of February and March, 2020. As such the promotion orders issued by the A.O. on 19.02.2020 and on 02.03.2020 were quite in order.

(b-iii) Inquiry Officer's observation at Para 4 under AllegationNo.1 is not based on some legal provision. The Inquiry Officer should also have asked the DR as to how and why the Administrative Department framed this charge :-after around three and a half year?After getting these promotions held in abeyance vide their letter dated 22nd June 2020? andon none actualized promotions?

(b-iv) Inquiry Officer's observations at para 5 under allegation No.1 are again misleading as any court decision doesn't automatically become applicable on the employees of Public Sector Institutions, Ministries, Divisions, Departments till its implementation by the concerned department is notified. In this case, Dar-ul-Qaza, Swat gave its decision on 18th April, 2018 declaring the PAITHOM employees as civil servants with back benefits and the Subreme Court of Pakistan dismissed the Administrative Department's CPLA on 6th January, 2020. Yet the PAITHOM employees were not treated to have been regularized as Civil servants till the issuance of Administrative Department's Notification on 21st January, 2022. Whereas, the Inquiry Officer is of view that the PAITHOM employees are Civil Servants from the date of Decision of Dar-ul-Qaza i.e. 18.04. 2018 of from the date on which the Departmental CPLA was dismissed by the Supreme Court of Pakistan i.e. 6th January, 2020. If the view point of Inquiry Officer is admitted, then why the PAITHOM employees were obliged to file a COC in Dar-ul-Qaza in July 2020 for getting their decision of 18.04.2018 implemented? It is, therefore, clear that there was nothing wrong with the 7 promotions of public servants of PAITHOM employees carried out by A.O. in his capacity as Incharge PAITHOM on 19.02.2020 and 02.03, 2020.

(b-v) Inquiry Officer's observation at para 6 under allegation no.1 appears to have been made on distorted and self interpreted facts/rules. Here the Inquiry Officer states that

"The subject of PAITHOM Rules have been described in detail under third allegation. Here it is sufficient to record that...:-."

The Inquiry Officer's observation at para 6(i) under allegation No.1 that "Regulations which were framed prior to devolution under Federal Ministry of Tourism, hereinafter called Ministry, were no longer applicable to employees once they were regularized as Civil servants....." The A.O., while agreeing to this view point, intends to add that PAITHOM employees were regularized as Civil servants with back benefits only on 21st January, 2022 whereas the impugned promotions were made by the A.O. on 19.02.2020 and 02.03.2020. As such this allegation after around three and a half year, that too after getting the impugned promotions held in abeyance by the Administrative Department vide their letter dated 22.06.2020, appears to have been concocted with malafide just to victimize the A.O. with the view to teach him a lesson for being straight forward.

Inquiry Officer's observation at para 6(ii) under allegation No. 1 appears to have been made without knowing the background of the case. Being a Senior bureaucrat, the Inquiry Officer must be aware that the northern areas of Pakistan, including Swat valley was hit by a 7.8 magnitude earthquake in October 2005 and left behind thousands of dead bodies, injured humanity and large scale destruction of properties, infrastructure, Schools and hotels and PAITHOM was not an exception. The Federal and Provincial Governments had been trying their best to, inter alia, revive the Tourism Industry in Swat, when in 2007, the Taliban revolted and took over the control of Swat Velly occupying the buildings of Malam Jabba Resort Limited and PAITHOM Guli Bagh Swat. This control was got back by Pakistan Army as a result of an agreement concluded between Pakistan Army and Taliban Pakistan. However, in the first quarter of 2009 second battle of Swat, known as Operation Rah-e-Rast began. During this time, the Pakistan Army took over the control of PAITHOM's building, which is still in their occupation. Under these circumstances, the defunct Ministry of Tourism postponed the idea to fill in the post of Principal/Director (egual to BPS-20) and appointed the incumbent A.O. in October, 2007 as Chief Instructor (BPS-19) besides assigning him the additional responsibility to look after the Administrative and Financial matters of PAITHOM, Swat until further orders as Incharge of the Institute vide defunct Ministry of Tourism's letter No.2(31)/2007, dated 11th July, 2008 (Annexure B-I) As such the A.O. was very much competent to exercise all the powers of the Principal/Director PAITHOM under the Rules and Regulations of PAITHOM including the powers mentioned under Sub Rule





If of Rule 12 of the Rules ibid. As a precedent it is submitted that when an additional secretary is notified as Additional Secretary Incharge he uses all the administrative and financial powers of Secretary of the Ministry or the provincial department.

Inquiry Officer's observations at Para 6(iii), under allegation No.1, does not appear to have been based on some logical or justified grounds. The · impugned observation reads that "Service regulations under Regulation Serial No. 12(II) were never approved prior to or after devolution. Therefore, even if employees are considered as public servants in February/March, 2020 there were no service Regulations, under which they could be promoted." In my explanation to the Inquiry Officer's observation at para 6(ii) above, it has been briefly explained as to under what circumstances the Institute was kept functional by the A.O. However, the Inquiry Officer seems to have already made his mind to prove the allegation Otherwise, being a Senior Bureaucrat he must be aware that Rules making for newly established institutions is a lengthy process in normal circumstances whereas, ever since it's becoming functional in late nineteen nineties the circumstances for PAITHOM never remained normal. The Austrian Principal left the institution at its fledgling stage. Thereafter a Pakistani Mr. Omer Mir was appointed as Principal PAITHOM in 2006 who also left in 2007. There was no one to look after the day to day affairs till the appointment of incumbent A.O. to whom the Inquiry Officer, in his finding on allegation No. 3, himself can not held responsible for any delay at his part in making service rules of PAITHOM. It has been the normal practice in almost all Federal and Provincial government set ups that wherever some institution's service rules are in drafting/approval process or their framed rules are silent on some service. matter, the Government rules are applied till the framing of institutions own rules. The incumbent A.O. and all other employees of PAITHOM were appointed by the defunct Federal Ministry of Tourism/A.O following Government rules. So there was nothing wrong in promoting 7 officials of PAITHOM following Government Rules.

The clarifications/explanations to the observation of the Inquiry Officer on allegation No.1 amply establish that the Inquiry Officer based his observation on the one sided feedback provided to him by the DR whereas the A.O's written reply to the charge sheet and his verbal clarifications made during the course of Inquiry were totally ignored. Hence the findings, based on the one sided story told by DR, of the Inquiry Officer under Para 7 of the Inquiry Report on Allegation No.1 are neither justified nor supported by facts of the case. As such these are





unjustified and are liable to be rejected/dropped by the competent authority on following grounds:-

- A. Para 7(i) of the inquiry report on Allegation No.1 the impugned 7 promotions were made by the A.O in his capacity as Incharge PAITHOM in February/March, 2020 whereas the Khyber Pakhtunkhwa Civil Servants (Appointment, Promotion & Transfer) Rules 1989 became applicable on PAITHOM employees on 21st January, 2022 (Annexure A-I). As such, the question of the violation of Rule 5 of the Rules ibid does not arise, particularly when the Administrative Department vide their letter dated 22.06.2020 (Annexure B-II) had got the impugned promotions held in abeyance and these promotions were never actualized.
- B. Para 7(ii) of the Inquiry Report on Allegation No.1 is based on an incorrect statement. An explicit order was issued by the defunct Ministry of Tourism empowering the A.O. to look after the Administrative and Financial matters of PAITHOM as Incharge of the institute vide their letter No.2(31)/2007-PAITHOM, dated 11th July, 2008 supported by a copy of the Office Note confaining approval of the Federal Secretary, Ministry of Tourism (Annexure B-I).
- C. Para 7(iii) of the Inquiry report on allegation No. 1 is incorrect as the PAITHOM employees were not Civil Servants till 20th January, 2022. They became Civil Servants only when the Administrative Department issued a notification regularizing them as civil servants with back benefits on 21st January, 2022 (Annexure A-I). Hence the finding of the Inquiry report is baseless and is liable to be rejected.

Allegation No.2

"You re-designated the post of Supervisor (BPS- 7) to House Engineer (BPS- 16) in favor of Mr. Haq Nawaz vide Office Order dated 20.06.2013 without approval of the Administrative Department."

- (b) Para 2 of the Inquiry Report under allegation No.2 was based on selective facts of the case. Therefore, it is necessary to go through all the facts relevant to this allegation, which are given hereunder:-

(b-iv) Finance Department, Government of Khyber Pakhtunkhwa, interalia, endorsed the conditional regularization of the posts of House Engineer in BPS-16, Management Secretary in BPS-16 and House Keeping Incharge in BPS-5 vide their Corrigendum No.BO-III/FD/1-22/2021-22, dated 08.07.2021 (Annexure A-II);

(b-v) Finance Department, Government of Khyber Pakhtunkhwa, vide their another letter No. BO-III/FD/5-14/SNEs/2021-22, dated 29.09.2021 (Annexure A-III) changed their earlier sanction by again conditionally abolishing/creating the above said three posts of PAITHOM with changed nomenclatures and pay Scales as under:-

- (1) House Engineer (BPS-16) to Supervisor (BPS-07)
- (2) Management Secretary (BPS- 16) to Administrative Officer (BPS- 17) and
- (3) Housekeeping Incharge (BPS- 05) to Instructor (BPS- 17).

This unique example of discrimination merits to be noted.

(b-vi) Administrative department vide its Notification No. SO(Tourism)/5-81/2020/4350-88 dated 21st January, 2022(Annexure A-I), inter-alia, conditionally regularized the Services of M/s. Haq Nawaz as Supervisor (BPS- 07), Mr. Liaquat Raza as Administrative Officer (BPS- 17) and Mr. Waheed Murad as Instructor (BPS-17). Please note that post of House Engineer (BPS-16) was downgraded as Supervisor (BPS- 07), whereas the post of Management Secretary (BPS-16) was upgraded to BPS-17 with changed nomenclature of Administrative Officer and the post of Housekeeping Incharge (BPS-05) was upgraded to BPS-17 with its changed nomenclature of Instructor:

(b-vii), Administrative department vide Notification No. SO(Tourism)/5-81/2020/3284-95, dated 23rd May, 2023 (Annexure A-IV), has once again regularized the Services of Mr. Haq Nawaz as under:

- As Supervisor (BS-07) from 01.07.2008 to 30.06.2013,
- As House Engineer (BPS- 16) from 01.07.2013.

(b-viii) Being an aggrieved of down grading Mr. Haq Nawaz had constantly been agitating for getting his grievance settled, the A.O., in his capacity as Incharge PAITHOM, in exercise of the powers vested in him vide Sub Rule II of Rule 12 of the Rules and Regulations of PAITHOM re-designated and upgraded Mr. Haq Nawaz as Engineer Incharge (BPS- 16) on 20.06 2013 and there was no objection on this re-designation/up-gradation for long ten years both by the Audit department, and Administrative Department. The said Motel is generally headed by a Unit Manager equal to BPS-16 or 17. When the A.O. raised some questions about his placement in PTDC Motel Saidu Sharif vide his application, dated 25-05-2023 (Annexure B-IV), it was, not responded till to date thereby closing the chapter of A.O. placement in PTDC Motel Saidu Sharif.

(b-xi) The Inquiry Officer's finding at Para 3(i) is endorsed to the extent that re-designation/up-gradation were made by the A.O. in exercise of the powers vested in him under sub-rule II of Rule 12 of the Rules & Regulations PAITHOM.

(b-xii) However, the Inquiry Officer's finding under Para 3(i), 3(ii), 3(iii) and 3(iv) are ill-conceived and frivolous and are liable to be rejected.

Allegation No. 3

"You are failed to perform your functions as assigned to you under the law/rules and did not frame / draft service rules for the employees of PAITHOM till date."

Since allegation could not be proved by the Inquiry Officer, hence no comments are required to be offered on his observation under this allegation.

GIST OF ALLEGATIONS AND REPLIES GIVEN THERETO BY A.O.

The A.O., being a chief Instructor (BPS-19), PAITHOM, was not explicitly authorized to exercise the powers vested in Principal/Director (BPS-20) of the institute in terms of sub-rule I, II, III & IV of Rule 12 of the Rules and Regulations PAITHOM.

However, to keep the organization functional the Ministry of Tourism/A.O. had been making appointments/regularizations and up-gradations etc. applying the government service rules in exercise of the powers vested in Incharge PAITHOM under sub rule II of Rule 12 of the Rules and Regulations of PAITHOM. It is further submitted that the practice of following government rules in those institutions whose rules are either silent on some particular matter(s) or their rules are not yet framed is in vogue in almost all the Federal and Provincial institutions. Therefore, applying of government service rules in case of PAITHOM employees is in order.

3. Since the case of regularization of PAITHOM employees was being adjudicated before the court of law at that time hence the seven promotions cannot be made by the A.O.

The writ petition in Dar-ul-Qaza No.546,655,507-M/2017 filed by the employees of PAITHOM was decided in favor of the petitioners on 18-04-2018 declaring the PAITHOM employees as civil servants. However, the administrative department filed a CPLA against the aforesaid decision and that CPLA was also dismissed by the Supreme Court of Pakistan on 06-01-2020 as such there was no adjudication before any court of law during the months of February and March when the A.O. made these 07 promotions hence there was nothing wrong therein.

4. Approval of the competent authority (i.e. administrative department) was not solicited to the up-gradation of Mr. Haq Nawaz.

The administrative department and Inquiry Officer did not quote any rule under which the A.O./Incharge PAITHOM was required to seek approval of the administrative department and even the administrative department and Audit department did not raise objection thereto for long ten years.

5. You did not frame the service rules for the employees of PAITHOM.

The A.O. being Incharge PAITHOM drafted the service rules in 2011 and submitted the same to the administrative department on 24th July, 2011 but the same are still laying there despite personal follow up. Due to this, the Inquiry Officer could not prove this allegation.





6. Employees of PA THOM were civil servants and administrative department should have been consulted for 07 promotions in February, March 2020.

PAITHOM employees became civil servants on 21st January, 2022 hence there was nothing wrong in promoting the 07 employees of PAITHOM in February, March, 2020.

In view of the situation elucidated above it has become crystal clear that the three allegations against the A.O. were proved by the Inquiry Officer in collusion with DR with malafide intentions and not on merits of the case.

Prayers

It is humbly prayed that the A.O. may please be honorably exonerated from all the three allegations as the Inquiry Officer had not made any recommendation to punish the A.O. Moreover, the A.O. may please be allowed personal hearing with the Chief Secretary and Chief Minister, Government, of Khyber Pakhtunkhwa enabling him to brief them as to how he is victimized throughout his service in PAITHOM after devolution, just because he always tried to go by the book.

This is with reference to the Tourism, Culture, Archaeology & Museums Department's letter No. SO(T)5-81/2020/4350-88, dated 6TH May, 2024 (received to the A.O. on the same date through whatsapp) on the subject cited above.

- 1. I, Hurmat Yab Khan, Chief Instructor (BPS- 19), Pakistan Austrian Institute of Tourism and Hotel Management (PAITHOM), Swat, may hereinafter be called as Accused Officer (A.O.). <u>Prayers</u>

It is humbly prayed that the A.O. may please be honorably exonerated from all the three allegations as the Inquiry Officer had not made any recommendation to punish the A.O. Facts and grounds clearly show that how AO is victimized throughout his service in PAITHOM after devolution, just because he always tried to go by the book. Moreover, the A.O. has come up with clean hands and has not done anything wrong under the rules ibid wherefore he was penalized unjustly. Honorable Chief Minister is humbly prayed to set aside the penalty as a notion of fair justice please.


