APPEAL UNDER SECTION-4 OF THE KHYBER PAKHTUNKHWA SERVICE TRIBUNAL ACT, 1974 AGAINST THE IMPUGNED ORDER DATED 12.06.2024 WHEREBY MAJOR PENALTY OF DISMISSAL FROM SERVICE HAS BEEN IMPOSED UPON THE APPELLANT AND AGAINST NO ACTION TAKEN ON THE DEPARTMENTAL APPEAL OF THE APPELLANT WITHIN THE STATUTORY PERIOD OF NINETY DAYS.

#### PRAYER:

That on acceptance of this appeal the impugned orders dated 12.06.2024 may very kindly be set aside and the appellant be re-instated into service with all back benefits i.e. w.e.f 03.05.2023. Any other remedy which this august Tribunal deems fit that may also be awarded in favor of the appellant.

# R/SHEWETH: ON FACTS:

## Brief facts giving rise to the present appeal are as under:-

- 1- That the appellant was the employee of the respondent department and has served the department as Constable No. 4886 for quite considerable period quite efficiently and upto the entire satisfaction of his superiors.
- 2- That the appellant while performing his duty at the concerned station, the following allegations were leveled against the appellant:
  - i. He alleged that nature of explosion in CTD Police Lines, Kabal District Swat was fabricated by officers/officials.
  - ii. He also stated facts were tarnished and twisted as there is no electricity in Armour/Kot.

- iii. He stated about the treatment meted out to constabulary alleged this disbursement of national consensus amount was not appropriate as given the government/department.
  - iv. He stated about rights of constabulary are forfeited by senior command without any material facts and putting same before your chain of command.

- 5- That the appellant has served the department for more than 11 years with dedication and honesty and has never committed the said acts mentioned in the impugned order, rather only the appellant was requested the higher authorities to conduct fair and impartial investigation and to dig out the responsible involved in the incident of Explosion in CTD Police Lines, Kabal District Swat which is a legal and favorable statements in great honour of the Police Force while the appellant is un-aware from the other allegations which were leveled against him and the same are baseless and fabricated.
- 6- That there was no malafide intention behind the said request of the appellant out only for keeping higher reputation of police force in the public and to keep secure the force from such kind of incidents in future but the appellant has been proceeded departmentally instead of giving honour to his request which was in the best interest of all police force throughout the Province.

8- That appellant feeling aggrieved and having no other remedy but to file the instant appeal on the following grounds amongst the others.

### **GROUNDS:**

- A- That the impugned order dated 12.06.2024 is against the law, facts, norms of natural justice and materials on the record, hence not tenable and liable to be set aside.
- B- That the appellant has not been treated in accordance with law and rules by the respondent on the subject noted above and as such violated Article-4 and 25 of the Constitution of Islamic Republic of Pakistan, 1973.
- C- That the respondent department acted in arbitrary and malafide manner while issuing the impugned order dated 12.06.2024 which is not tenable in eye of law and liable to be set aside.
- D-That statements of witnesses have not been recorded by the authorities before issuing the impugned order dated 12.06.2024 which is necessary as per rule and law ibid.
- E- That no chance of cross of examination has been provided by the respondent department to the appellant before issuing the impugned order dated 12.06.2024 which is mandatory as per judgment of the superior Court.
- F- That no regular inquiry has been conducted by the authorities in the matter which is necessary as per law, rules and judgments of the Apex Court before taking punitive actions against the civil servants.
- G- That no chance of personal hearing/defense has been provided to the appellant before issuing the impugned order dated 12.06.2024.

It is, therefore, most humbly prayed that the appeal of appellant may very kindly be accepted as prayed for.

APPEAL UNDER SECTION 4 OF THE KHYBER PAKHTUNKHWA SERVICE TRIBUNAL ACT, 1974 THE IMPUGNED ORDER DATED 03.05.2023 WHEREBY MAJOR PENALTY OF DISMISSAL FROM SERVICE WAS IMPOSED TO THE APPELLANT AGAINST WHICH THE APPELLANT FILED DEPARTMENTAL APPEAL ON 16.05.2023 WHICH HAS NOT BEEN DECIDED WITHIN THE STATUTORY PERIOD OF NINETY DAYS.

#### **JUDGMENT**

KALIM ARSHAD KHAN, CHAIRMAN: Brief facts of the case, as enumerated in the memo and grounds of appeal are that appellant was appointed as Constable in the Police Department; that on the basis of allegations, he was dismissed from service on 03.05.2023; that feeling aggrieved, he filed departmental appeal on 16.05.2023,

which was not responded within statutory period of ninety days, hence, the instant service appeal.

- On receipt of the appeal and its admission to full hearing, the respondents were summoned. Respondents put appearance and contested the appeal by filing written reply raising therein numerous legal and factual objections. The defense setup was a total denial of the claim of the appellant.
- 4. We have heard learned counsel for the appellant and learned District Attorney for respondents.
- 5. The learned counsel for the appellant reiterated the facts and grounds detailed in the memo and grounds of the appeal while the learned District Attorney controverted the same by supporting the impugned order(s).
- 6. The appellant was dismissed from service vide order dated 03.05.2023 on the allegations leveled by the competent authority. The allegations are as follows:
  - "i. He alleged that nature of explosion in CTD Police Lines, Kabat District Swat was fabricated by officers/officials.
  - ii. He also stated that facts were tarnished and twisted as there is no electricity in Armoury/Kot.
  - iii. He stated about the treatment meted out to constabulary and alleged this disbursement of national, consensus amount was not appropriate as given the government/department.
  - iv. He stated that rights of constabulary are forfeited by senior command without any material facts and putting same before your chain of command."

Before issuance of the impugned dismissal order, charge sheet/statement of allegations were issued to the appellant. The



appellant was proceeded against departmentally on the basis of the said allegations. However, codal formalities have not been fulfilled before issuance of the impugned order. Show cause notice was mandatory, but the same was not issued to the appellant and he was dismissed from service without giving him opportunity of defense.

- 8. We, therefore, consider it necessary to remit the matter to the respondents to issue show cause notice and provide him opportunity of hearing and then pass appropriate order. Costs shall follow the event. Consign.
- 9. Pronounced in open Court at Peshawar and given under our hands and the seal of the Tribunal on this 14th day of May, 2024.

#### ORDER

Consequent upon the order passed in Service Appeal No.1670/2023 vide Judgment order dated 14-05-2024 by the Honorable Service Tribunal Peshawar, a show cause notice containing the following allegations was issued to constable Tariq Aziz No. 4886 Platoon No.57:-

- a- That it was circulated vide this office letter No. 9509-20/EF dated 13.09.2022 & 91-108/EF dated 04.01.2023 that no member of Khyber Pakhtunkhwa Police will upload and viral any sort of imauthentic and unauthorized information on social /Electronic media and shall not be a member of any Whatsapp groups. Still in violation of social media policy of KP Police under prohibition section 4,7 & 10 read with relevant section of Police Rules 1975, you proceeded with the use of social media with false and frivolous allegation against the department.
- b- He alleged that nature of explosion in CTD Police Lines, Kabal District Swat was fabricated by officers/officials.
- e- He also stated facts were tarnished and twisted as there is no electricity in Armour/Kot.
- d-. He stated about the treatment meted out to constabulary alleged this disbursement of national consensus amount was not appropriate as given the government/department.
- He stated about rights of constabulary are forfeited by senior command without any material facts and putting same before your chain of command.

Show cause notice was delivered to Ex-Constable Tariq Aziz No.4886 at his home address and was properly served upon him. He submitted his written reply to the show cause notice and was also heard in person on 29-05-2024. His written statement was thoroughly examined and he was also cross questioned. Neither his reply was found satisfactory nor did he defend himself with plausible and convincing grounds.

As such the undersigned being competent to exercise authority for disposal of the instant enquiry as directed by the Honorable Court, the defaulter constable Tariq Aziz No.4886 is found guilty of the charges as he bitterly failed to produce tangible grounds in his support with reference to the allegations framed against him. More-so he also failed to defend himself in context with police social media policy circulated vide this office letter No.9509-20/EF, dated 13.09.2022 & No.91-108/EF dated 04.01.2023. To uphold and maintain discipline in the Force such commission/omission cannot be overlooked so in the larges interest of maintaining discipline in the Force; Constable Tariq Aziz No.4886 of Elite Force is hereby awarded the major punishment of "Dismissal from Service" under Police Rules 1975 with (arnended rule 2014),

That the appellant has never committed the said acts mentioned in the impugned order, rather only the appellant was requested the higher authorities to conduct fair and impartial investigation and to dig out the responsible involved in the incident of Explosion in CTD Police Lines, Kabal District Swat which is a legal and favorable statements in great honour of the Police Force while the appellant is un-aware from the other allegations which are leveled against me and the same are baseless and fabricated.

That there was no malafide intention behind the said request of the appellant but only for the high reputation of the police force in the public and to keep secure the force from such kind of incidents in future but the appellant has been proceeded departmentally instead of giving honour to his request which was in best interest of all police force throughout the Province and awarded with major punishment of dismissal from service which unlawful, unconstitutional and against the principle of natural justice.

That no proper inquiry has been conducted in the matter which is necessary as per rule and judgments of the Apex Court before taking punitive actions against a civil servant.

It is, therefore, most humbly prayed that on acceptance of this departmental appeal the impugned order dated 12.06.2024 may very kindly be set aside and the appellant be re-instated into service with all back benefits i.e. with effect from 03.05.2023.
