

APPEAL THE APPELLANT MAY KINDLY BE
TREATED ACCORDING TO LAW AND
RULES TO ALLOW/ADJUST HIM FOR
PERFORMING HIS OFFICIAL DUTY WITH
RESPONDENTS/DEPARTMENTS AS WELL
AS THE RESPONDENTS/DEPARTMENTS
MAY KINDLY BE DIRECTED TO RELEASE
THE MONTHLY SALARY OF THE
APPELLANT WHICH WAS ILLEGALLY AND
WITHOUT ANY LEGAL JUSTIFICATION
STOPPED BY THE RESPONDENTS/
DEPARTMENTS W.E.F 01.03.2023 ALONG
WITH ALL BACK BENEFITS.

ANY OTHER RELIEF DEEMED
APPROPRIATE IN THE CIRCUMSTANCES
OF THE CASE NOT SPECIFICALLY ASKED
FOR, MAY ALSO BE GRANTED TO THE
APPELLANT.

Respectfully Sheweth.

1. That the appellant is a permanent bonafide resident of District Lukki Marwat having educational qualification upto master degree couple with B.ed, DAE Civil and Diploma in information technology. (Copy of CNIC and academic record are attached as annexure "A & B").

2. That the appellant was initially appointed as Theology Teacher (TT) BPS-15 on 10.06.2020 and after appointment he performed his official duty with full devotion and hard work and no complaint whatsoever was made against the appellant. (Copies of appointment order, medical fitness certificate and Service Book are attached as annexure "C, D & E"). EA
3. That the appellant was transfer from GPS Toor Gabar Bagh SDB Lakki to GPS Qamar Shah SDB Lakki against the vacant post of TT on 03.08.2020. (Copy of Transfer order is attached as annexure "F").
4. That since his appointment the appellant performing his duty with great zeal and zest and to the entire satisfaction on his high ups and are regularly drawn his salaries and the name of the appellant also entered in the HRMIS System by the respondents. (Copies of salary slips, attendance register and HRMIS account detail are attached as annexure "G, H & I").
5. That while performing his official duty as usual the respondents departments stopped the salary

of the appellant w.e.f 01.03.2023 without any legal reason.

6. That the appellant submitted application to respondent department on 13.03.2023 for the release of his salary but in vain. (Copy of application is attached as annexure "J").
7. That the respondents /defendants illegally without any reason and legal justification restrained the appellant from performing his official duty w.e.f 01.09.2023.
8. That the appellant submitted departmental appeal on 11.09.2023 to respondents departments for allowing/ adjustment which is still pending without any response. (Copy of departmental appeal is attached as annexure "K").
9. That the appellant submitted applications to respondents/departments for the response of departmental appeal but no response was given to the appellant by the respondents departments till now. (Copy of applications are attached as annexure "L & M").

10. That feeling aggrieved the Appellant prefers the instant service appeal before this Hon'ble Tribunal on the following grounds inter alia:-

GROUNDS:-

- A. That the act of the respondents to not allow the appellant for performing his official duty is against the law, rules norms of justice hence not sustainable in the eyes of law.
- B. That the appellant regularly performing his official duty with full devotion and hard work and into the entire satisfaction of his superiors, while the respondents departments without any legal justification restrained the appellant from performing his official duty w.e.f 01.09.2023 which is against the natural justice of law.
- C. That there is no illegality on part of the appellant and the appellant was appointed for the said post after fulfilling the required criteria for that very post.
- D. That there is no absentia and no complaint whatsoever was made against the appellant.

E. That the appellant performing his official duty since from the date of the appointment regularly with respondent department, while the respondents departments illegally and without any legal reason stopped the salary of the appellant w.e.f 01.03.2023 and that very act of respondents are against the will settle principal of "work done pay done".

F. That as mentioned above the appellant is performing his duty is theology teacher therefor, entitle to full emoluments and in his grade and pay scale with all the admissible allowances and there is no provision, in law to stop the salary or not releasing the monthly salary without any reason.

G. That the respondents departments having no authority whatsoever to stop the salary of the appellant without any reason and justification which act of the respondents is clear cut violation of fundamental rights of the appellant.

H. That the appellant belongs to a poor family and all the responsibility of the whole family is on the shoulder of the appellant.

I. That any other ground not raised here may graciously be allowed to be raised at the time of arguments on the instant service appeal.


It is therefore, most humbly prayed that on acceptance of this service appeal the appellant may kindly be treated according to law and rules to allow/adjust him for performing his official duty with respondents/departments as well as the respondents/departments may kindly be directed to release the monthly salary of the appellant which was illegally and without any legal justification stopped by the respondents/ departments w.e.f 01.03.2023 along with all back benefits..


Any other relief not specifically asked for may also graciously be extended in favour of the Appellant in the circumstances of the case.




restrained the appellant for performing his official duty with respondent department and illegally stop the salary of the appellant.
