### JOINT PARA-WISE COMMENTS ON BEHALF OF RESPONDENTS NO. 1 & 4.

#### PRELIMINARY OBJECTIONS.

- (1) That the appellant has no cause of action.
- (2) That the appeal is not maintainable in its present form.
- (3) That the applicant has not come to the court with clear hands.
- (4) The appellant has deliberately kept the facts concealed in his appeal and has not produced/annexed the relevant documents. This honorable Tribunal has no jurisdiction to entertain the appeal.
- (5) That no injustice has been done to the appellant and the appeal is based on malafide intentions and incorrect/ incomplete information.
- (6) That the appeal is bad for misjoinder and non joinder of necessary parties.
- (7) That the appeal is barred by law and limitation.

#### Sheweth: -

#### Facts: -

- 1. The appellant was appointed as an Assistant (BPS-14) at the District Sports Office in Buner, as per Office Order No. 34-39/Estt:/8(main file) dated January 18, 2008, issued by the then District Coordination Officer, Buner. (Annexure-I)
- 2. Correct. "Seniority" refers to the official seniority list that has been finalized and published in compliance with relevant laws and regulations.
- 3. Para-3 of the appeal is misleading. The final joint seniority of the Assistant Directors, District Sports Officers and Administrators (BPS-17) was issued 13.5.2019 wherein the private respondents stand at serial No. 14 21. The appellant, if aggrieved, was required to file departmental appeal to the Departmental Authority within a period of 30 days or in case no reply to the departmental appeal was responded after lapse of ninety days, the appellant was required to file appeal before the Tribunal on the expiry of limitation period. The appellant had neither submitted departmental appeal filed appeal before this Tribunal within the limitation period i.e till 15.08.2019 in accordance with law hereinafter mentioned.

Section 4 of Khyber Pakhtunkhwa Service Tribunal Act 1974 (Khyber Pakhtunkhwa Act No.1 of 1974). provides that;—

2)

Appeal to Tribunal,— Any civil servant aggrieved by any final order, whether original or appellate, made by a departmental authority in respect of any of the terms and conditions of his service may, within thirty days of the communication of such order to him or within six months of the establishment of the appropriate Tribunal, whichever is later, prefer an appeal to the Tribunal having jurisdiction in the matter; provided that (a) where an appeal, review or a representation to a departmental authority as provided under the Khyber Pakhtunkhwa Civil Servants Act, 1973, or any rules against any such order, no appeal shall lie to a Tribunal unless the aggrieved civil servant has preferred an appeal or application for review or representation to such departmental authority and a period of ninety ' days has elapsed from the date of such appeal, application or representation was preferred.

## (KP Service Tribunal Act, 1974 is attached as Annexure- II).

In view of the above provision of law, the final order (original or appellate i.e final seniority) had been issued on 13.05.2019) (Annexure-III) and has never been impugned at any competent forum to the extent of private respondents within the limitation period of 90 ddys. Therefore, valuable rights have been established in favour of private respondents. The final seniority list issued or to be issued afterward in respect of the private respondents in calendar years following the year 2019, cannot be impugned until and unless the seniority list in respect Of the private respondents are altered.

The appeal of the appellant is not maintainable in light of the final order issued on 15.8.2019 and the same is also hopelessly time barred. The appellant has to explain delay of each day and every day, because of delay valuable rights have been accrued in favour of private respondents with passage of time, which should not be disturbed. Reliance is placed on 2013 CLC 403, PLD 2011 SC 657 and PLD 2011 SC 174.

Para-4 of the appeal is misleading. All the posts of Deputy District Officers/District Sports Officer (BPS-16) in the province were upgraded to BPS-17 in accordance with Upgradation Policy, 2010 on permanent basis. The Competent Authority (Chief Secretary) approved the proposal of the up-grdation of Deputy Sports Officers/Sports Officers from BPS-16 to BPS-17 (Annexure-IV) and no such post remained in BPS-16 as evident from subsequent Notification issued on 08.03.2018 (Annexure-V). Hence, lien remained intact of the incumbent against the posts in lower scale of Deputy Sports Officers/Sports Officers (BPS-16). Similar is the case of the appellant. The appellant was appointed as Assistant (BPS-14) and upon general upgradation of the posts of Assistant from BPS-14 to BPS-16 vide Finance Department Notification No. FD/SO(FR)10-22/2014, dated 20.05.2014 (Annexure-VI), the appellant was placed in BPS-16. The appellant was promoted to the post of Assistant Director (BPS-17) vide Sports Department Notification dated 28.5.2019. (Annexure-VII). If, the upgradation of the private respondents is not justified then the upgradation of the appellant from BPS-14 to BPS-16 is also not justified.

It is further submitted that Rule-17 of the Khyber Pakhtunkhwa Civil Servants (Appointment, Promotion and Transfer) Rules, 1989 provides that:

"Seniority":-(1) the seniority inter se of civil servants appointed to a service, cadre or post shall be determined;-

the case of persons appointed by initial recruitment, in accordance with the order of merit assigned by the Commission or as the case may be, the Departmental Selection Committee; provided that persons selected for appointment to post in an earlier selection shall rank senior to the personsselected in a later selection; and

(a) in the case of <u>civil servants appointed otherwise</u>: with reference to the date oftheir continuous regular appointment in the post; provided that civil servants selected for promotion to a higher post in one batch shall, on their promotion to the higher post, retain their inter se seniority as in the lower post (Annexure-VIII).

The word "otherwise" connote civil servants appointed through promotion transfer or upgradation.

- 5. As explained in answering paras 3 and 4 above that the appeal is time barred. Moreover, the circulation of tentativeseniority list is not the final/original order against which departmental appeal or appeal before the Tribunal can be filed. In such circumstances, theappellant cannot invoke jurisdiction of this Honourable Service Tribunal. In this regard reliance is placed on the judgment of the Apex Court (1998 SCMR 60) which provides that "the only objection in the context could be that an appeal to the Service Tribunal is competent only against final order and such a regulatory periodic order as of suspension does not qualify as final order and hence is not amenable to the jurisdiction of Service. In terms of Section-8 of the Khyber Pakhtunkhwa Civil Servants Act, 1973 read with Rule-17 of the Khyber Pakhtunkhwa Civil Servants (APT) Rules, 1989, the Department, after the year 2019, has now issued the final seniority list as stood on 10.10.2023 (Annexure IX). However, the appellant has no vested rights to impugn the Final Seniority list dated 18.8.2023 to the extent of Private Respondents as the appellant failed to invoke jurisdiction of this Honorable Tribunal against the Final Seniority' list issued on 13.05.2019.
- 6. Para- 6 of the appeal is incorrect. The final seniority list has been issued on 10.10.2023 as referred in answering para 5 above. (Annexure- IX ibid).
- 7. In the meanwhile the meeting of the committee constituted for fixation of seniority of all the employees of the Directorate General of Sports, Khyber Pakhtunkhwa held on 27-07-2023 (Annexure-X) in which it was decided that the seniority lists of all the employees of BPS-03 to BPS-17 including the merged employees of erstwhile FATA Sports Directorate may be prepared as fresh in accordance with Sub-Rule (3) of Rule-17 of the Khyber Pakhtukhwa Civil Servants (APT) Rules, 1989 and subsequent advice of the Establishment Department dated 06.04.2021 conceveyed vide Sports & Youth Affairs Department, Khyber Pakhtunkhwa letter No. (Sports)2-75/Merged Areas/2021/7315-19, dated 07-05-2021(Annexure-XI). A copy of a reported judgment titled "Tikka Khan & others vs Syed Muzaffar Hussain Shah & others" (2018 SCMR 332) sub para (4) of para-6 read with para-7 of which is very relevant to the case in hand, is also attached for your information / guidance. In another words, the said judgment has interpreted sub rule (3) of the Rule-17 of the Khyber Pakhtunkhwa Civil Servants (APT) Rules, 1989 (Annexure-XII).

- 8. Furthermore, no restraining order was issued by the Honorable Service Tribunal due to which the process was continued for fixation of the employees. It is furthur added that he was responded according to rules & laws as and when he raised objections. (Annexure-XIII).
- 9. Pertains to record.
- 10. The private respondents entire promotion process was conducted in strict adherence to the relevant rules and regulations, with all requisite formalities and procedures as mandated by the government.

### **GROUNDS: -**

- [(4) The Chairman and members of a Tribunal shall be appointed by the Governor in consultation with the Chief Justice of the Peshawar High Court.]
- (5). The Chairman or a member of a Tribunal may resign his office by writing under his hand addressed to the Governor.
- (6) The Chairman or a member of a Tribunal may be appointed by name or by designation.
- <sup>2</sup>[3-A Adhoc appointment.—The Governor may, if necessary or expedient, for a particular case or cases, make an ad hoc appointment on the Tribunal of person qualified to be Chairman or a member as the case may be.]
- <sup>3</sup>[3-B Tenure, Terms and conditions of service of Chairman and members.\_(1) The Chairman and a member shall hold office for a period of three years or until he attains the age of sixty years, whichever is earlier, and shall not be eligible for re-appointment:

Tenure, Terms and conditions of service of Chairman and members,

Provided that if a judge of the High Court is appointed as Chairman, he shall hold office for a period of three years or until he attains the age of superannuation as judge of the High Court whichever is earlier.

- (a) Where an appeal, review or representation to a departmental authority is provided under the [Khyber Pakhtunkhwa]Civil Servants Act, 1973, or any rules against any such order, no appeal shall lie to a Tribunal unless the aggricved civil servant has preferred an appeal or application for review or representation to such departmental authority and a period of ninety days has elapsed from the date on which such appeal, application or representation was preferred;<sup>2</sup>
- no appeal shall lie to a Tribunal against an order or decision of a departmental authority determining
  - the fitness or otherwise of a person to be appointed to or hold a particular post or to be promoted to a higher post or
  - (ii) the quantum of departmental punishment or penalty imposed on a civil servant as a result of a departmental inquiry, except where the penalty imposed is dismissal from service, removal from service or compulsory retirement '[; and].

Explanation.—In this section, "departmental authority" means any authority other than a Tribunal which is competent to make an order in respect of any of the terms and conditions of service of civil servants.





#### PROBATION AND CONFIRMATION

<sup>34</sup>15. <u>Probation.</u> ---- (1) Persons appointed to posts by initial recruitment, promotion or transfer shall be on probation for a period of one year.

- (2) The appointing authority, if considers necessary, may extend the probation period for one year as may be specified at the time of appointment.
- (3) On the successful completion of probation period, the appointing authority shall, by specific order, terminate the probation:

Provided that if no specific order is issued on the expiry of the first year of probation period, the period of probation shall be deemed to have been extended under sub-rule (2):

Provided further that if no specific order is issued on the expiry of the extended period of probation, the period of probation shall be deemed to have been successfully completed.

16. Confirmation:-After satisfactory completion of the probationary period, a civil servant shall be confirmed; provided that he holds a substantive post, provided further that a civil servant shall not be deemed to have satisfactorily completed his period of probation, if he has failed to pass an examination, test or course or has failed to complete successfully a training prescribed within the meaning of sub-section (3) of Section 6 of the North West Frontier Province Civil Servants Act, 1973.

#### PART-VI

### SENIORITY

- 17. Seniority:-(1) the seniority inter se of civil servants <sup>55</sup>(appointed to a service, cadre or post) shall be determined:
  - in the case of persons appointed by initial recruitment, in accordance with the order of merit assigned by the Commission <sup>36</sup>[or as the case may be, the Departmental Selection Committee;] provided that persons selected for appointment to post in an earlier selection shall rank senior to the persons selected in a later selection; and
  - (b) in the case of civil servants appointed otherwise, with reference to the date of their continuous regular appointment in the post; provided that civil servants selected for promotion to a higher post in one batch shall, on their promotion to the higher post, retain their inter se seniority as in the lower post.

Explanation-I:- If a junior person in a lower post is promoted to a higher post temporarily in the public interest, even though continuing later permanently in the higher

EJAZ AFZAL KHAN, J.—These petitions for leave to appeal have arisen out of the judgment dated 20.10.2016 of the Federal Service Tribunal, Islamabad whereby appeals filed by respondents Nos. 3 to 11 sere allowed.

- 2. Learned Senior ASC appearing on behalf of the petitioners in C.Ps. Nos. 3577 to 3583 of 2016 contended that respondents Nos. 3 to 11 cannot rank senior to the petitioners whether they were appointed its the Ministry of Religious Affairs by transfer or on deputation and that their seniority would continue to be regulated by Rule 4 of the Civil Servants (Seniority) Rules, 1993.
- 3. Learned Standing Council appearing on behalf of Federation in C.Ps. Nos. 3889 to 3895 of 2016 also reiterated the arguments addressed by the learned Sr. ASC for the petitioners in Civil Petitions Nos. 3577 to 3583 of 2016.
- 4. Two of the respondents appearing in person defended the impugned judgment by contending that their case is fully covered by SL. No. 33(6) of the Esta Code Vol. I; that their transfer to the Ministry of Religious Affairs could not be considered as appointment by transfer or appointment on deputation and that the impugned judgment being free from any legal infirmity is not open to any interference.
- 5. We have gone through the record carefully and considered the submissions of the learned Sr. ASC for the petitioners, the learned Standing Council for the Pederation as well as the respondents appearing in person.
- 6. Before we discuss the rules cited above, let us see whether case of the respondents is covered by Rule 4, Rule 4-A of the Civil Servants (Seniority) Rules, 1993, or Sl. No. 33(6) of Estacode, Vol-I, Edition 2007, a reference to the said rules would thus be necessary which read as under:-








- (b) persons belonging to different services, cadre or posts selected for appointment by transfer in one batch shall take their inter se seniority in the order of the date of their regular appointment to the post which they were holding before such appointment and, where such date is the same, the person older in age shall rank senior.
- 4A. In the event of merger of Ministries, Divisions, Attached Departments or Subordinate Offices, the inter se seniority of civil servants, other than those belonging to regularly constituted Occupational Groups and Services, shall be determined in accordance with the date of regular appointment to a cadre or post".
- "SI, 33(6). Seniority on transfer from one office to another.(i) The instructions in the foregoing paragraphs regulate the position of a deputationist in his parent office. As regards his seniority in the office to which he is transferred, it should be determined in the following manner:-
- a) When it is open to the person concerned to accept or refuse an offer of appointment in another office, he should count his seniority in the new office from the date of his transfer to that office;

A look at the rules reproduced above would reveal that one deals with germination of seniority on appointment by transfer and the other deals side the determination of seniority on merger. A bare reading of the rule 4 reveals that the case of the respondents is not of appointment by muster or appointment on deputation. It is not even a case of absorption ly any attribute. The case of the respondents precisely is that many Ministries were abolished and reorganized in the wake of the Constitution (18th) Amendment) Act, 2010 and that they being the employees of the Ministry abolished were transferred to the Ministry morganized. Transfer of the respondents to the Ministry reorganized A cannot be seen through the prism of Rule 4 of the Rules mentioned above. Their case is fully covered by serial No. 33(6) of Estacode, Vol-I, Edition 2007. In this context, their case would be more akin to Rule 4A rather than Rule 4 of the Rules. No canons of interpretation yould scratch or strike off their past service when they on abolition of the Ministry, were compulsorily transferred to the Ministry of Religious Affairs and Interfaith Harmony. Their past service has to be respected and recognized for determining their seniority. It would, thus, be unfair and unjust to treat the respondents junior to the junior most civil servants in the Ministry for none of their faults. The view taken by the Service Tribunal is, therefore, not amenable to any change or modification.

For the reasons discussed above, these petitions being without merit are dismissed and the leave asked for is refused.


