

Qasid (BPS-03 to BPS-05), Village Councils/Neighborhood Councils Local Govt & Rural Development Department Tehsil Head Quarter City, Peshawar As it stood on 14-06-2024 Issued by office of the assistant director senior local government & rural Development Department head quarter city Peshawar. Where the name of the appellant is not included in the final seniority list for the promotion from Naib Qasid To Junior Village Secretary : (PBS-09) of village Council/Neighborhood Council local Government & rural development Tehsil Head quarter city Peshawar. The unqualified candidates having fake certificate of DIT/CIT have been included in the seniority list of dated 14-06-2024 but surprising the name of appellant has not been included in the first 11 candidates for promotion in seniority list of 14-06-2024. Not to include the name of appellant for promotion from Naib Qasid to Junior Village Secretary (PBS-09) are illegal unlawful in

effective. The seniority list date 14-06-2024 has been issued by respondent No. 3 in excess of lawful authority and is based on malafide, Discrimination against fundamental right.

Prayer in Appeal

On Acceptance of the instant appeal, the impugned order dated 14-06-2024 of Respondent No. 3 may be set-aside, the name of appellant be included for promotion to Junior Village Secretary (PBS-09)

Respondents be restrained not to finalized seniority list unless the name of appellant has been included in the first 11 candidates due for promotion and such other relief as this Honorable Tribunal May deem fit in the circumstance of the case may also be granted.

Respectfully Sheweth:

Brief facts giving raise of the instant appeal are as under:-

1. That the appellant being the permanent Government Employee of Local Government & Rural Development Department Tehsil Head Quarter City Peshawar. **(Copy of Salary Pay Roll is Attached as Annexure "A")**

2. That the name of appellant in final seniority list is at serial No. 76 Muhammad Usman Khan S/o Khan Muhammad for promotion to Junior Village Secretary (PBS-09). **(The copy of seniority list is attached as Annexure B).**
3. That the qualification required for promotion from Naib Qasid to Junior Village Secretary is matric with valid Diplome of DIT in information Technology or CIT certificate in Information Technology). The appellant having M.A & also Having Valid DIT. **(Copy of DIT & M.A are attached as Annexure C & D).**
4. That the seniority list issued by Respondent No.3 The appellant name is at serial No 76 and after finalizing the name of candidate for promotion only 11 candidates were considered as eligible but out of eleven only two candidate have valid diploma of DIT or certificate of CIT rest 9 of them having fake certificates but they are selected for promotion as Junior Village Secretary, where as DIT & CIT must be Verified by technical Board. **(Copy of letter is attached as Annexure E).**
5. That the appellant being aggrieved submitted representation to respondents for redressal of his grievances regarding his seniority/promotion as per

final seniority list dated 14-06-2024 issued by respondent No. 3 vid letter No-ADLG-P(1-3) establishment/seniority/NQ/2023/5732-36 is still exist. But the representation has not been entertained and the name of appellant has not been included in seniority list 14-6-2024 for promotion as Junior Village Secretary. **(copy of representation is attached as Annexure F).**

6. That being aggrieved and dis-satisfied with impugned order date 14-6-2024 of respondent No. 3 the appellant having no other alternative remedy seeks indulgence of this Honorable Tribunal, inter alia on the following Grounds.

GROUND S:

- A. That the impugned seniority list dated 14-06-2024 is illegal, unlawful, arbitrary, perverse and as such with out lawful authority, hence not maintainable in the eye of law.
- B. That the impugned seniority list deprived the appellant of his legal right of availing promotion from BPS-03 to BPS-09 Junior Village Secretary.
- C. That the impugned seniority list/promotion circulated vide Order No. ADLG-P(1-3) /Establishment/seniority/NQ/2023/5732-36 dated 14-06-2024 In Pursuance of section-8 of

the Khyber Pakhtunkhwa Civil Servant Act 1973. Final seniority list of Naib Qasid (BPS-03 to BPS-05), Village Councils/Neighborhood Councils Local Govt & Rural Development Department Tehsil Head Quarter City, Peshawar As it stood on 14-06-2024 Issued by office of the assistant director senior local government & rural Development Department head quarter city Peshawar cannot be termed as authentic, legal and valid.

- D. That the impugned seniority list of dated 14-06-2024 is against the spirit of policy and instruction necessary for promotion from Naib Qasids to Junior Village Secretary.
- E. That the seniority list dated 14-06-2024 in which the name of appellant is not included for Promotion, is based on malafide and is therefore illegal, unjust, perverse, and against the natural justice.

It is, therefore, most humbly prayed that on acceptance of this service appeal, the seniority list dated 14-6-2024 of respondent No.3 may kindly be set-aside and appellant name be

included for promotion from Naib Qasid to junior village Secretary.

Any other relief of which this Honorable Tribunal deems appropriate under the circumstances of the case may also be awarded to the appellant.

گزارش کی جاتی ہے کہ 14-06-2024 کو ڈیپارٹمنٹ میں نائب قاصدین کا فائنل سنڈرائی لسٹ لگا ہے۔ جس میں ایسے نائب قاصدین کو شامل کیا گیا ہے جس کا Criteria قانون کے مطابق بالکل بھی نہیں ہے۔ اس سے پہلے Tentative list پر میں نے تین اعتراضات جمع کئے تھے جس کے بارے میں فائنل سنڈرائی لسٹ میں کوئی عمل نہیں کیا گیا اور دوبارہ وہی نائب قاصدین کو فائنل سنڈرائی لسٹ میں شامل کئے گئے ہیں جس کا قانون سمجھنا آسانی میں نہیں ہے۔ نائب قاصدین کو سنڈرائی لسٹ سے ہٹایا جائے جن کے Course Completion ہے۔

مندرجہ ذیل سیریلز پر نظر ثانی کی جانے سے جو قانون کے مطابق درست نہیں ہے۔

(1) سیریل نمبر 12 کیساتھ یہ نہیں لکھا گیا کہ انسٹیٹیوٹ کس بورڈ کے ساتھ Affiliated Registered ہے۔

(2) سیریل نمبر 17 کیساتھ نہیں لکھا کہ CIT مکمل ہے یا کورس کمپلیشن ہے۔

(3) سیریل نمبر 25 کیساتھ انسٹیٹیوٹ کا نام نہیں لکھا گیا ہے۔

(4) سیریل نمبر 33 نے انسٹیٹیوٹ سے خود ساختہ 12 ماہ کا CIT بنایا ہے جسکی کوئی قانونی حیثیت نہیں ہے۔ اور انسٹیٹیوٹ 12 ماہ کا CIT جاری کر سکتا ہے۔

(5) سیریل نمبر 37 نے خود ساختہ DIT انسٹیٹیوٹ سے بنایا ہے جو سنڈرائی لسٹ میں شامل کیا ہے DIT صرف مسترد بورڈ BTE سے حاصل کیا جاتا ہے جو کہ

پورے پاکستان میں قابل قبول ہے۔ لہذا خود ساختہ DIT کو فائنل لسٹ میں غلط طور پر شامل کیا گیا ہے جو کہ قانون کے مطابق نہیں ہے۔

(6) سیریل نمبر 41 کو بغیر اعتراض جمع کئے فائنل سنڈرائی لسٹ میں شامل کیا گیا ہے جس نے میٹرک اکتوبر 2023 میں کیا ہے۔ اور CIT اپریل 2022 میں کیا ہے۔

جو کہ قانون کے خلاف ہے۔

(7) سیریل نمبر 68 کے کاغذات میں زور بدل کی گئی ہے اس سے پہلے Tentative سنڈرائی لسٹ میں اس کی 4 ماہ کی CIT شمولاً اب اسکو تبدیل کیا گیا ہے اور

یہ ٹیکسٹ لکھا گیا ہے ساتھ یہ ظاہر نہیں کیا گیا کہ جس انسٹیٹیوٹ سے اس نے CIT کیا ہے وہ کس بورڈ کے ساتھ Affiliated Registered ہے۔

لہذا مسترد و بالا اعتراضات کا جائز لیا جائے اور قانون کے مطابق عمل کیا جائے۔ تاکہ ہر کسی کو اپنا حق مل سکے۔ بصورت دیگر میں قانونی پارہ جوئی کا حق محفوظ رکھتا ہوں۔ جسکی تمام تر ذمہ داری ڈیپارٹمنٹ پر ہوگی۔


