



TERMS & CONDITIONS

1. His appointment will be considered regularly without pension or gratuity in terms of Section 19 of Khyber Pakhtunkhwa Civil Servant Act, 1973, as amended vide Khyber Pakhtunkhwa Civil Servant (Amendment) Act 2005. However, he will be entitled to Contribute Provident Fund as per Govt. rate / policy.
2. His services will be liable to termination on one month notice on either side, in case of resignation without notice, two months pay/allowances shall be refunded to the Government.
3. His services will be governed by such rules and regulations as may be issued from time to time by the government.
4. His services can be terminated at any time in case his performance is found unsatisfactory during probation period of one year extendable for two years.
5. The appointee should take over the charge within 15 days of the commencement, dated and charge report should be submitted to all concerned.
6. The appointee is required to produce his health certificate from the Medical Superintendent DHQ's Hospital Lakki Marwat.
