Respectfully Sheweth,

- 1. That the above-mentioned Execution/ implementation petition is pending before this Honorable Tribunal which is fixed for 03-10-2024.
- 2. That the respondent/ Appellant filed Service Appeal No. 1910/2022 before this Honorable Tribunal with the following prayers;

"The impugned final seniority list issued by the Directorate of Youth Affairs Khyber Pakhtunkhwa (respondent No.2) to the extent of placing the present appellant at Sr.No.76 instead at Sr.No.39 may kindly be declared as illegal, unlawful, void-abinitio, and ineffective upon the rights of the appellant. It is further prayed that directions may kindly be issued to the respondents to modify the final seniority list to the extent of placing the present appellant at Sr. No.39"

3. That the Hon'ble Tribunal vide judgement dated 12-06-2024, accepted the Service Appeal in the following words;

"In view of the above, instant service appeal is accepted and the respondents are directed that the appellant be placed in the final seniority, list, at the place where he was placed in provisional seniority, list." (Annexure-A)

4. That the Tentative Seniority list of Class-IV was circulated amongst the incumbents. In the provision seniority list the appellant was placed at serial No.39 based on his date of appointment i.e. 30-04-2019. After checking of his Matric Certificate final seniority list was accordingly corrected and he was placed at serial No.76 in the final seniority list based on acquiring qualification because in the Service Rules, 2022 it is clearly mentioned that seniority shall be maintained for the purpose of promotion with reference to the dates of appointment or acquiring the F. A/F.Sc qualification, *whichever is later*. The appellant is matriculate and his name was included in the Seniority List on the basis of Establishment Department Notification, No. SOE /(E&AD)/1-35/2014

dated 18.07.2019 wherein the existing Matriculate Class-IV were exempted from the condition of FA or equivalent qualification for promotion to the post of Junior Clerk BPS-11for a period of 04 years which is now expired on 19-7-2023. Relevant portion of the rules is as follows:

"Forty (40%) percent by promotion, on the basis of seniority-cumfitness, from amongst holders of the posts of Naib Qasid, Chowkidar, Mali, Sweeper, Cook, Generator Operator, Security Guard, Waiter, Tubewell Operator, Dispatch Rider, Electrician, Daftari cum Duplicate Machine Operator and other equivalent posts possessing F A/F Sc qualification or its equivalent qualification from a recognized Board with two (2) years' service as such, and

Note: A joint seniority list of the holders of the posts of Naib Qasid, Chowkidar, Mali, Sweeper, Cook, Generator Operator, Security Guard, Waiter, Tubewell Operator, Dispatch Rider, Electrician, Daftari cum Duplicate Machine Operator shall be maintained for the purpose of promotion with reference to the dates of appointment or acquiring the FA/F Sc qualification, *whichever is later*.

If two or more officials have acquired the F.A/F Sc qualification in the same session, the inter-se-seniority in the lower post shall be maintained for the purpose of determining seniority in the higher post, and

Where a senior official does not possess the requisite qualification at the time of filling up a vacancy the official next junior to him possessing the requisite qualification shall be promoted in preference to the senior official or officials:" (Annexure-B)

- 5. That the respondent/appellant have been awarded seniority as per existing Service Rules and awarding seniority from the date of appointment will create further litigation because all the other officials included in the seniority list have been awarded seniority from the date of acquiring qualification or date of appointment whichever is later as per existing Service Rules of the Department.
- 6. It is therefore requested that the instant objection petition may kindly be accepted and the operation of Execution/ implementation of the instant petition may be stopped/suspended till the final adjudication of the case in the apex supreme court of Pakistap.


