**PARAWISE COMMENTS ON BEHALF OF RESPONDENT NO. 01 TO 03**

**Respectfully Sheweth:**

**Preliminary Objections:-**

1. That the appellant has got no cause of action or locus standi to file the instant appeal.
2. That the appellant has filed the instant appeal just to pressurize the respondents.
3. That the instant appeal is against the prevailing Law and Rules.
4. That the appeal is not maintainable in its present form and also in the present circumstances of the issue.
5. That the appellant has filed the instant appeal with mala-fide intention hence liable to be dismissed.
6. That the appellant has not come to this Honorable Tribunal with clean hands.
7. That the appeal is barred by law and limitation.
8. That the instant appeal is bad for miss-joinder of unnecessary and non-joinder of necessary parties.
9. That the instant appeal is not maintainable under S 4(b) (i) of the Khyber Pakhtunkhwa Service Tribunal Act 1974.
10. That the Honorable Tribunal has no jurisdiction to adjudicate the Matter.

**ON FACTS:**

3. Pertains to record. However, 15 days deadline was given to the doctors for submission of their missing PERs vide letter No. 17506-90/AE.I dated 13//11/2018 (already attached with the appeal at Annex-C) however the appellant submitted his PERs on 01/4/2019 as per his own contention in the para.

- 4. Incorrect. No junior to the appellant was promoted nor did he challenged any such order before any forum including the instant appeal so far as Dr. Rawesh Mohmand, Dr. Gulab and Dr. Said Muhammad are concerned they were senior to the appellant as Dr. Darwesh was at S. # 206 & Dr. Gulab Khan was at S. # 290 & Dr. Said Muhammad was at S. # 295 while the appellant was at S. # 316 of the seniority list notified on 28/09/2018 (Annex-A). Furthermore, the last PSB before the retirement of the appellant was held on 31/07/2021. There were total 63 vacant posts of BPS-19 whereas the doctor concerned was at S. # 135 of the seniority list (Annexed-B) hence he was not in the promotion zone & was retired at the age of superannuation on 14/08/2022 therefore he was not promoted.
- 5. Incorrect. Already replied in detail in para 4 above that till his retirement he was not in the promotion zone.
- 6. Pertains to record, however detail reply has been given in the preceding paras.
- 7. Incorrect .the appellant is not an aggrieved person as no vested right of the appellant has been violated by the replying respondent however reply on the grounds is as under;

**GROUND**

- A. Incorrect. The replying respondents acted as per law, rules and principles of natural justice hence denied.
- B. Incorrect, as in preceding para.
- C. Incorrect. Already replied in Para-4 of the Facts.
- D. Incorrect. Already explained in Para-4 of the Facts.
- E. Incorrect. No junior to the appellant was promoted to the post of Principal Medical Officer as already explained in Para No. 4 of the Facts.
- F. Incorrect, detailed reply has already been given in para-4 of the facts.
- G. As per the preceding paras.
- H. Correct to the extent of FR 17, however FR 17 is not applicable to the appellant.
- I. As per preceding para.
- J. Incorrect. Already replied in the preceding paras.
- K. Incorrect. No fundamental rights of the appellant have been violated by the replying respondents.
- L. The answering respondents also seek prior permission of this Honorable Tribunal to adduce additional grounds at the time of arguments.

**Prayers:**

It is therefore humbly prayed that the instant appeal of the appellant may very graciously be dismissed with costs.
