Comments on behalf of Respondents are submitted as under:-

Preliminary objection:-

- 1. That the appellant has no cause of action to file the instant appeal against the answering respondents.
- 2. That the appeal of the appellant is time barred. Hence liable to be dismissed without any further proceeding.
- 3. That the Departmental Promotion Committee (DPC) was held on 19-10-2020 for the district cadre post to SST G, SST Bio/ Chemistry & SST Math/Physics wherein promotion to SST Maths/Physics from Senior Qari / Qari under 3 % share was not considered due to quota not applicable (0.42 which is less than 0.50) hence, appellant is not eligible for promotion against the said quota.
- 4. That this Honorable Tribunal has got nothing to do with the fitness for promotion case as per reported judgment 2013 SCMR 99 is very much clear in this regard hence, instant service appeal is liable to be dismissed without further proceedings.
- 5. That the instant appeal is not maintainable in its present form.
- 6. That the appellant has filed the present appeal just to pressurize the respondents.
- That no junior Senior Qari BPS-15 has been promoted against the post of SST (M/P).

- 8. That appellant neither annexed the copy of postal receipt alongwith his departmental appeal nor mentioned the date on his departmental appeal hence, the appeal in hand is not maintainable in its present form.
- 9. That the appellant has not come to this Honorable Tribunal with clean hands hence, not entitled for any relief.
- 10. That the appellant is estopped to sue due to his own conduct.
- 11.That the instant appeal is not maintainable due to non-joinder and mis-joinder of necessary parties.
- 12. That the instant appeal is against the Service Laws / existing policy.

Factual Objections:-

- 1. That the Para No. 01, of the service appeal relates to the service record of the appellant hence, need no further comment.
- That the Para No. 02, of the service appeal also relates to the promotion record of the appellant.
- 3. That the Para No. 03, of the service appeal relates to the service record of the appellant hence, need no further comment.
- 4. That the Para No. 04, of the service appeal relates to record hence, need no further comment.
- 5. That the Para No. 05, of the service appeal as composed is incorrect hence, denied As per Notification No. SO (PE)4-5/SSRC/Meeting/2013/Teaching Cadre dated 24-07-2014, 3 % share is reserved from amongst the Senior Qari with atleast 05 years service against the post of SST and no junior Senior Qari BPS-15 has been promoted against the post of SST (M/P). The meeting of Departmental Promotion Committee (DPC) was held on 19-10-2020 and the case of promotion of Senior Qari to SST M/P BPS-16 was considered vide item No. 03 and the DPC recommended as under:

However, in the remarks column against the name of appellant <u>erroneously</u> mentioned as "<u>considered suitable for promotion to the post of SST (G) in BPS-16</u> <u>on regular basis with immediate effect.</u>" and same was intimated to respondent No. 4 vide letter Endst: No. 2006/F.No. Clarification of Minutes/2020/Haripur dated 07-08-2024. Hence, appellant could not be promoted due to less share for

promotion against said quota. (Copy of Notification dated 24-07-2014, Minutes of Meeting & letter Endst: No. 2006/F.No. Clarification of Minutes/2020/Haripur dated 07-08-2024 are annexed as <u>Annexure "A", "B" & "C"</u> respectively)

6. That the Para No. 06, of the service appeal relates to record.

7. That the Para No. 07, of the service appeal relates to record.

- 8. That the Para No. 08, of the service appeal as composed is incorrect hence, denied. Comprehensive reply has already been given in Para No. 05 of the factual objections.
- That Para No. 09, of the service appeal as composed is incorrect hence, denied. Comprehensive / detailed reply has already been given in Para No. 05 of the factual objections.
- 10. That the Para No. 10, of the service appeal as composed is incorrect hence, denied.
- 11. That Para No. 11, of the service appeal as composed is incorrect hence, denied. As replied above.

12. That Para No. 12, of the service appeal as composed is incorrect hence, denied.

Grounds:

- a. <u>denied_not admitted</u>. As this Honorable Tribunal has got nothing to do with the fitness for promotion case as per reported judgment 2013 SCMR 99 is very much clear in this regard.

- i. That ground i, of service appeal as composed is incorrect hence, denied. Comprehensive / detailed reply has already been given in Para No. 05 of the factual objections.


j. The respondents seek leave to raise additional grounds at the time of arguments.


