- 1. I have six times been displaced/transferred in the last 6 years before completing my tenure.i.e
- i. SDEO (M) DIKhan to SDEO (M) Allai Battagram Vide Notification No. SO(SM)E&SED/7-1/2021/PT/G/MC Dated 07-10-2021 at S.no21
- ii. SDEO (M) Allai Battagram to SDEO (M) Ghazani Khel Lakki Mawart Vide Corrigendum No.SO (SM) E&SED/7 1/2021/PT/MC/ SDEOs Date 15/11/2021
- iii. SDEO (M) Ghazani Khel Lakki Mawart to SDEO (M) Allai Battagram Vide Notification No.SO(SM)E&SED/7-1/2021/PT/MC/SDEOs Dated 01/12/2021
  - iv. SDEO (M) Allai Battagram to SDEO (M) Tank Vide Notification No.SO(MC)E&SED/2 3/2022/promotion/MC(BS17 to 18)ACB consequential posting/transfer at S.No.24 dated

 I have served as ASDEO for Eight years and then after proper procedure I had been promoted to the post of SDEO vide Notification No.SO(SM)E&SED/3-2/Promotion of ASDEOs (BS-16) to SDEOs(BS-17) Dated 29-10-2018.

5. There is no complaint or enquiry lodged against me since the initial appointment as MC Officer.

According to the Management cadre rules there is no space to adjust a lower scale teaching cadre
employee on a post where a suitable management cadre employee is already working.

 Honorable Court has already given its verdict about such an adjustment and this adjustment is also going against the decision of the Honorable Court.

It is therefore very earnestly requested that keeping in view the above-mentioned facts my services might be retained at the post of SDEO (M) Paharpur to meet the end of justice. I believe that your good self will help me out and will not let me down.
