PRAYER.

THAT ON ACCEPTANCE OF THIS APPEAL THE IMPUGNED ORDERS DATED 18.07.2024 & 23.08.2024 MAY BE SET ASIDE. ANY OTHER REMEDY WHICH THIS AUGUST TRIBUNAL DEEMS FIT AND PROPER THAT MAY ALSO BE AWARDED IN FAVOUR OF APPELLANT.

RESPECTFULLY SHEWETH

That the appellant alongwith (1) Muhammad Naeem (2) Muhammad Hasham (3) Salim Khan (4) Mian Akber Shah (5) Muhmmad Farooq (6) Habib Gul were initially appointed as Junior Clerks on 09.03.2005 vide order No. 284-298/DSJ Dated 09.03.2005 wherein the respondent No.3 Mr. Shaheen Wahab and Mr. Sher Ahmad were placed in bottom in that said DPC/DSC order. Copy is attached as annexure-A.

That after appointment, the authority has been issuing seniority of each ending year by circulating amongst all the cadres with due acknowledgment.

That in the year of 2019, Mr. Muhmmad Naeem who was also appointed as Junior Clerk vide the same order, was

promoted to the post of senior clerk vide order No. 1305-1310/DSJ Dated 22.06.2019 but the respondent No.3 did not bother to challenge the said order. **Copy of order is attached as annexure-B**.

That in the year of 2020, Mr. Muhammad Hasham was promoted to the post of senior clerk vide order NO. 2134-38/DSJ Dated 21.11.2020, pursuance to which respondent No. challenged the seniority list and filed an application before the District & Sessions Judge Buner, but the same was turned down on 29.09.2020, and it withheld time barred. (Copy of order is attached as annexure-C).

That final seniority list was issued the competent authority vide order dated 05.10.2020. (Copy is attached as annexure-D)

That according to law of limitation the respondent No.3 should have challenged the initial order Dated 09.03.2005 and onward seniority lists issued time to time, then at that time he should have challenged the re-casted seniority list issued by the then Honorable DSJ Mr. Muzamil Shah Khattak in the year of 2015 (Annexure-E) and seniority list issued by the then Honorable DSJ Muhammad Iqbal Khan in the year of 2019 (Annexure-F but respondent No.3 again remained mum over that seniority lists.

That vide the order NO. 2134-38/DSJ Dated 21.11.2020, Mr. Muhammad Hasham was promoted to post of senior clerk (Copy is annexed-G) which was also not challenged by the respondent No. **3** rather he challenged the seniority list only issued on 10.10.2020 before the Administrative Judge of Peshawar High Court, Peshawar through departmental appeal No. 57/2020. Copy is attached as annexure-H.

That the appellant was promoted to the post of senior clerk vide order No. 96 106/DSJ dated 15.01.2022 but the respondent also failed to challenged the same and remained mum. (Copy is attached as annexure-I)

That another official namely Mr. Habib Gul was promoted to the post of senior clerk vide order No. 3086-92/DSJ, Buner Dated 15.10.2022. (Copy is attached as annexure-J) but the respondent No.3. again could not challenged the same promotion order.

10. That vide order dated 18.07.2024, the honorable Senior Puisne Judge of Peshawar High Court, Peshawar, (being administrative Judge), decided the departmental appeal in favour of respondent No.3 with connected appeal No. 58/2020, which is against the law and not sustainable. (Copy is attached as annexure-K)

11. That District & Sessions Judge vide her order No. 2010-2013/DSJ Buner Dated 23.08.2024 held that respondent No. 3 be kept pending till availability of post of senior clerk and thereafter he will be placed senior against the appellant which is against law and not sustainable in the eye of law because when there is no post exist presently then how department can make promise for future. (Copy is attached as annexure-L)

12. That the appellant approaches this worthy forum for ventilation of his gracious on the following grounds:

GROUNDS:-

c.

a. That the impugned order passed by honorable administrative Judge of Peshawar High Court, Peshawar in departmental appeal No. 57/2020 and endorsement No. 2010-2013/DSJ Buner Dated 23.08.2024 of District & Sessions Judge Buner is against law and rules.

b. That the law of limitation and laches is fully applicable to all the Govt employees and one cannot sleep over his right for a long period! Thus, respondent No.3 is not entitled for any kind of relief, hence the impugned order is not sustainable in the eye of law.

That the law of limitation, law of estoppel and principles of acquiescence is also applicable to the present

case because the respondent No3was well aware of the whole proceedings.

d. That the impugned order has been issued on the basis of presumption and conjectures as the same has no legal base and legal appreciation.

e. That in the order of Departmental Appeal the principal of natural justice i.e. *audi alteram partem* has grossly been violated and neither any notice has been issued nor sought any reply to hear the appellant. Hence, the said order is presumed *exparte* which need to be reviewed.

f. That after passing of 04 years without hearing the appellant, decision in departmental appeal is also not sustainable.

g. That a similar departmental appeal No. 06/2023 " Misal Khan vs DSJ Buner" and Appeal No. 17/2021 "Jehangir Khan vs DSJ Buner" were also fixed for 24.07.2024, in which both the parties were summoned and heard but in the present case/appeal the appellant was condemned unheard which is also amount to violate the principle of *audi alteram partem* and equal treatment enshrined in the constitution of Islamic republic of Pakistan. (Copies are attached as annexure-M&N)

h. That appellant has been condemned unheard on which score alone the impugned order is not sustainable in the eye of law.

That principal of *locus poenitentiae* is fully in favour of the appellant and the appellant could not be placed junior in the light of principal of the aforementioned doctrines.

j. That the principles of legitimate expectancy & promissory estoppels is also fully in favour of the appellant.

That the instant appeal is well within time because the appellant got knowledge against the impugned order when District & Sessions Judge circulated the same on 23.08.2024.

It is therefore kindly prayed that by ; acceptance of instant appeal the impugned orders passed the honorable senior puisne Judge in departmental appeals no. 57/2020, and order of DSJ Buner No. 2010-2013 dated 23-08-2024 be set aside and previous seniority may graciously be restored.

DISPOSAL OF OBJECTIONS OVER SENTORITY AMONG THE JUNIOR CLERKS OF THE ESTABLISHMENT OF DISTRICT & SESSIONS JUDGE, BUNER.

Peshawar High Court, Peshawar vide letter No.12900/968/PHC/SIDJ/HR&W at 24.07.2020 has circulated the approved format for maintaining the common seniority list for promotion to the post of Superintendent, Senior Clerk, Junior Clerk & for other posts.

The mentioned format along with seniority lists was circulated among the employees of this establishment vide letter No.1527-30/DS. Buner dated 08.08.2020 and objections/observations were also solicited till 10.09.2020.

That Sher Ahmad Khan & Shaheen Wahab both Junior Clerks have submitted their objections dated 09.09.2020 wherein they have contended that their first entry into service shall be corrected as 06.03.2000 & 08.05.2000

respectively. They have also contended that they were promoted to the post of Junior Clerks on 09.03.2005 and the officials namely Muhammad Hasham, Muhammad Nacem, Saleem Khan, Ahmad Gul & Habib Gul were appointed as Junior Clerks on 09.03.2005. That the promotees shall be ranked senior to appointees.

The objectors Sher Ahmad & Shaheen Wahab as well as the above-mentioned appointed Junior Clerks were summoned on 22.09.2020 for heafing in respect of their contentions concerning to seniority amongst them. Both the parties were heard at length and the: order was kept reserved which was announced today on 29.09.2020.

So far the request of Sher Ahmad & Shaheen Wahab in respect of the dates of their first entries into service is concerned, in this respect it is stated that the objectors have contended that they were appointed as Class IV employees on 06.03.2000 and 08.05.2000 respectively but the same is not properly incorporated in the seniority list of Junior Clerks, therefore, the same is accepted and correction be made accordingly.

So far the request/objection for ranking them senior to the appointees is concerned, in this respect the office record reveals that the then District & Sessions Judge, Buner Muzamil Shah Khattak had circulated tentative seniority list of different

categories on 19.01.2015. That Junior Clerks Ahmad Gul & Habib Gul of this establishment had filed objections that their seniority shall be determined on the basis of age. That Sher Ahmad Junior Clerk had also submitted objection to the extent only that his date of birth, date of first entry into the service and date of upgradation shall be corrected. That said Sher Ahmad has not raised objection that he being promotee shall be ranked senior to those who were appointed as Junior Clerks on 09.03.2005.

All the above-mentioned officials were summoned by the then DSJ, Buner Muzamniil Shah Khattak for personal hearing on 17.03.2015 at 01:30PM and after hearing all the concerned & going through the merit list of the Selection Committee, it was ordered by the then DSJ, Buner Muzammil Shah Khattak that the seniority of Junior Clerks shall be re-casted. The said seniority list dated 01.04.2015 signed by the then DSJ, Buner on 30.04.2015 was neither objected nor challenged in The Khyber Pakhtunkhwa Service Tribunal by anyone.

Thereafter, the then DSJ, Buner Muhammad Iqbal Khan has once again circulated the above-mentioned seniority list of Junior Clerks vide office order No.503-513 dated 06.03.2019 but the same too was not objected by anyone. Thereafter meeting of Departmental Promotion Committee was held on 22.06.2019 in order to promote one Junior Clerk to the post of Senior Clerk. As per minutes of the DPC dated 22.06.2019, Muhammad Hasham Junior Clerk being senior in schiority list was on long leave since two years, therefore, second in seniority list namely Muhammad Nacem was found fit for promotion and was recommended accordingly and resultantly, the said Muhammad Naeem was promoted to the post of Senior Clerk vide office order No.1305-103 dated 22.06.2019. The final seniority list of all the categories shall be issued and circulated among all employees of this establishment.



Departmental appeal against the impugried final seniority list dated 1/10/2020 wherein his juniors(i.e respondents) have been shown senior to him in total derogation of law and rules.

The appellant submits as follows:

- 1. That the appellant was initially appointed as chawkidar on 8/5/2000 and then promoted as junior clerk on 9/3/2005 and have served the department for about 20 years with full zeal and zest to the entire satisfaction of his superiors and is now serving as Muharir to SCJ buner at district court daggar.
- That the respondents were also appointed as junier clerk on the afore said date i.e on 9/3/2020 but through initial recruitment.
- 3. That as per law and rules the appellant should have been placed on high pedestal of seniority list then the respondents as he was promoted to the post of junier clerk on the same date on which the respondent was appointed through initial recruitment.
- That when the tentative seniority list for promotion to the post of senior
 That when the tentative seniority list for promotion to the post of senior
 clerk(BPS 14) district buner was issued on 7/8/2020 then astonishingly the name of the appellant was placed on low pedestal of seniority list then the respondent i.e at serial no 5.
- 5. That the appellant then filed an application before the district judge buner for correction of the seniority list but the application was declined vide order dated 29/9/2020. (order dated 29/9/2020 of district and



session judge buner attached as anx A while impugned seniority list attached as anx B)

- 6. That the district and session judge buner has rejected the application of the appellant on the ground of limitation and acquiescence but the district and session judge has misconceived the law and facts in the subject matter.
- 7. That the appellant for the first time came to know after issuance of the tentative merit list for onward promotion to the post of senior clerk that respondents have been shown senior to him for onward promotion and he then and there objected against the same. No promotion before this was under consideration hence the appellant did not knew about his interse seniority.
- 8. That as per prevailing law when the two candidates are appointed to a post on the same date and one candidate is appointed on promotion and one on initial recruitment than the candidate appointed to the post on promotion will rank senior.
- 9. That the impugned final seniority list dated 1/10/2020 is against the law and rules and is not tenable in the eye of law!
- 10. That the impugned seniority list is the result of misconception of law and facts which need interference of the appellate authority.
- 11. That the appellant have been ignored on wrong premises and the impugned seniority lists have been issued which are factually and legally baseless and unsound and is not correct to be made a base for promotion to the post of senior clerk.

It is therefore kindly prayed that on acceptance of this appeal the impugned seniority list may kindly be modified by placing the appellant's name in its proper position before the respondents as he rank senior to them.

ORDER

IJAZ ANWAR, J. Through this single order, I intend to decide the instant Departmental Appeal and <u>Departmental</u> <u>Appeal No.57/2020</u> titled <u>"Shaheen Wahab Vs. Muhammad</u> <u>Hasham and others"</u>. In both these appeals, the appellants are aggrieved of their placement as juniors in the seniority list dated 01.10.2020.

2. Perusal of the record reveals that the appellants Sher Ahmad Khan and Shaheen Wahab were appointed as Naib Qasid and Chowkidar on 06.03.2000 and 08.05.2000 respectively and were promoted to the posts of Junior Clerks on 09.03.2005. The respondents No.1 to 4 were appointed through direct recruitment vide order of the even date i.e. 09.03.2005. Seniority of the civil servants is determined under Section 8 of the Khyber Pakhtunkhwa Civil Servants Act, 1973 read with Rule 17 of the Khyber Pakhtunkhwa Civil Servants (Appointment, Promotion and Transfer) Rules, 1989. Rule 17. of the Rules ibid, being relevant, is reproduced as under:-

17. Seniority:- (1) the seniority inter-se of civil servants (appointed to a service, cadre or post) shall be determined:-

(a) in the case of persons appointed by initial recruitment, in accordance with the order of merit assigned by the Commission or, as the case may be, the Departmental Selection Committee; provided that persons selected for appointment to post in an earlier selection



shall rank senior to the persons selected in a later selection; and

(b) in the case of civil servants appointed otherwise, with reference to the dates of their continuous regular appointment in the post; provided that civil servants selected for promotion to a higher post in one batch shall, on their promotion to the higher post, retain their inter-se seniority as in the lower post.

Explanation-1:- If a junior person in a lower post is promoted to a higher post temporarily in the public interest, even though continuing later permanently in the higher post; it would not adversely effect the interest of his seniors in fixation of his seniority in the higher post.

Explanation-II:- If a junior person in a lower post is promoted to a higher post by superseding a senior person and subsequently that senior person is also promoted the person promoted first shall rank senior to the person promoted subsequently; provided that junior person shall not be deemed to have superseded a senior person if the case of the senior person is deferred for the time being for want of certain information or for incompletion of record or for any other reason not attributing to his fault or demerit.

Explanation-III:- A junior person shall be deemed to have superseded a senior person only if both the junior and the senior persons were considered for the higher post and the junior person was appointed in preference to the senior person.

(2) Seniority in various cadres of civil servants appointed by initial recruitment vizà-viz those appointed otherwise shall be determined with reference to the dates of their regular appointment to a post in that 'cadre; provided that if two dates are the same, the person appointed otherwise shall rank senior to the person appointed by initial recruitment.

(3) In the event of merger/restructuring of the departments, attached departments or subordinate offices, the inter-se seniority of civil servants affected by the merger/ restructuring, as aforesaid shall be determined in accordance with the date of their regular appointment to a cadre or post?

3. Sub-rule (2) of Rule 17 of the Rules ibid made it clear that seniority in between the promotees and the direct recruits is to be decided with reference to the dates of their regular appointments. Admittedly, the appellants were in the service of the respondent much prior, as such, on their promotion to the posts of Junior Clerks, they will be considered seniors to the direct recruits. The wrong determination, at any stage; by the Competent Authority, at the relevant time, is not a hurdle in the correction of the seniority: Reliance can be placed on the case titled <u>"Din Muhammad Vs. Director General: Pakistan Post"</u> Office, Islamabad and others (2003 SCMR 333)".

4. In view of the above; this and the connected Departmental Appeal are allowed. The appellants shall be ranked seniors to respondents No.1 to 4 who were appointed on the same date when the appellants were promoted to the posts of Junior Clerks.


