THAT ON ACCEPTANCE OF THIS APPEAL THE IMPUGNED ORDERS DATED 18.07.2024 & 23.08.2024 MAY BE SET ASIDE AND APPELLANT MAY BE PLACED IN SENIORITY LIST ATSERIAL NO. 10, I.E BEFORE THE RESPONDENT NO.2, ANY OTHER REMEDY WHICH THIS AUGUST TRIBUNAL DEEMS FIT AND PROPER THAT MAY ALSO BE AWARDED IN FAVOUR OF APPELLANT.

RESPECTFULLY SHEWETH

- Naeem (2) Salim Khan (3)Ahmad Gul (4) Mian Akber Shah (5) Muhmmad Farooq (6) Habib Gul were initially appointed as Junior Clerks on 09.03.2005 vide order No. 284-298/DSJ Dated 09.03.2005 wherein the respondent No.3 Mr. Sher Ahmad and Mr. Shaheen Wahab were placed in bottom in that said DPC/DSC order. Copy is attached as annexure-A.
- 2. That after appointment, the authority has been issuing seniority of each ending year by circulating amongst all the cadres with due acknowledgment.

- That in the year of 2019, Mr. Muhmmad Naeem who was also appointed as Junior Clerk vide the same order, was promoted to the post of senior clerk vide order No. 1305-1310/DSJ Dated 22.06.2019 but the respondent No.3did not bother to challenge the said order. Which meant that the respondent No.3 was having no objection over the seniority. Copy of order is attached as annexure-B.
- That in the year of 2020, Mr. Muhammad Hasham was promoted to the post of senior clerk vide the order NO. 2134-38/DSJ Dated 21.11.2020, pursuance to which respondent No.43challenged the seniority list and filed an (Annexure-C) before the District & Sessions Judge Buner, but the same was turned down on 29.09.2020, and it was held time barred. (Copy of order is attached as annexure-D.
- That final seniority list was issued the competent authority vide order dated 05.10.2020. (Copy is attached as annexure-E)
- That according to law of limitation the respondent No. 3 should have challenged the initial order Dated 09.03.2005 and onward seniority lists issued to time and If he was not in knowledge than when he made objection over the seniority for correction his DOB & entry of education in the year 2015 (Annexure-F); then at that time he should have challenged the re-casted seniority list issued by the then Honorable DSJ Mr. Muzamil Shah Khattak in the year of 2015 (Annexure-G) and seniority list issued by the then Honorable DSJ Muhammad Iqbal Khan in the year of 2019 (Annexure-H) but respondent No. 3 again remained mum over that seniority lists.
- 7. That vide the order NO. 2134-38/DSJ Dated 21.11.2020, appellant was promoted to post of senior clerk (Copy is annexed-I) which was challaneged by the respondent No.: (Sher Ahmad) 04.012.2020 before the Administrative Judge of Peshawar High Court, Peshawar



through departmental appeal No. 58/2020. Copy is attached as annexure-J.

- Promoted to the post of senior clerk vide order No.96-106/DPC, Buner Dated 15.01 2022. (Copy is attached as annexure-K.
- 9. That respondent No.4 challenged the same vide
 Appeal No. 09/2022 before the Administrative Judge of
 Peshawar High Court, Peshawar on 20.01.2022 (Copy is
 attached as annexure-L)
- That another official namely Mr. Habib Gul was promoted to the post of senior clerk vide order No. 3086-92/DSJ, Buner Dated 15.10.2022. (Copy is attached as annexure-M)
- 11. That the said order dated 15 10.2022 was also challenged by the respondent No.3 before the Administrative Judge of Peshawar High Court, Peshawar through departmental appeal No. 12/2023. (Copy is attached as annexure-N)
- Senior Puisne Judge of Peshawar High Court, Peshawar, (being administrative Judge) decided all the departmental appeals in favour of respondent No.3 which is against the law and not sustainable. (Copy is attached as annexure-O)
- 13. That District & Sessions Judge vide her order No. 2007-09/DSJ Buner Dated 23.08.2024 promoted the respondent No. 3 with retrospective effect i.e. w.e.f 21.11.2020 and ranked him senior to the appellant which is against law and not sustainable in the eye of law. (Copy bis attached as annexure-P)
- 14. That the respondent No3 was also promoted to the post of senior clerk vide order 4297-4303/DSC Buner dated 03.12.2022. (Copy is attached as annexure Q)
- 15. That fresh seniority list was issued on 2087-2100 dated 05.09.2024, which was received under protest and appellant is also going to challenge the same.



16. That the appellant approaches this worthy forum for ventilation of his gracious on the following grounds:

GROUNDS:-

d.

- Administrative Judge Peshawar High Court, Peshawar in departmental appeals No. 58/2020 WITH CONNECTED APPEAL NO. 03/2021, 09/2022 & APPEAL NO. 12/2023 and endorsement No. 2007-09/DS Buner Dated 23.08.2024 of District & Sessions Judge Buner is against law and rules.
- b. That the law of limitation and laches is fully applicable to all the Govt employees and one cannot sleep over his right for a long period. Thus, respondent No.3 is not entitled for any kind of relief, hence the impugned order is not sustainable in the eye of law.
- c. That the law of limitation law of estoppel and principles of acquiescence is also applicable to the present case because the respondent No.2was well aware of the whole proceedings.
 - That the impugned order has been issued on the basis of presumption and conjectures as the same has no legal base and legal appreciation.
- e. That in the order of Departmental Appeal the principal of natural justice i.e. audi alteram partem has grossly been violated and neither any notice has been issued nor sought any reply to hear the appellant. Hence, the said order is presumed exparte which need to be reviewed.
- f. That after passing of 04 years without hearing the appellant, decision in departmental appeal is also not sustainable.
- g. That a similar departmental appeal No. 06/2023 "
 Misal Khan vs DSJ Buner" and Appeal No. 17/2021 " Jehangir
 Khan vs DSJ Buner" were also fixed for 24.07.2024, in which
 both the parties were summoned and heard but in the
 present case/appeal the appellant was condemned unheard
 which is also amount to violate the principle of audi alteram



partem and equal treatment enshrined in the constitution of Islamic republic of Pakistan. (Copies are attached as annexure-R&S)

- h. That the principles of legitimate expectancy & promissory estoppels is also fully in favour of the appellant.
- That being condemned unheard on which score alone the impugned order is not sustainable in the eye of law.
 - That principal of *locus poenitentiae* is fully in favour of the appellant and the appellant could not be placed junior in the light of principal of the aforementioned doctrines.

It is therefore kindly prayed that by acceptance of instant appeal the impugned orders passed the honorable senior puisne Judge ir departmental appeals no. 58/2020, 3/2021, 09/2022, 12/2023 and order of DSJ Buner No. 2009-09 dated 23-08-2024 be set aside and previous seniority may graciously be restored.



i.

Peshawar High Court, Peshawar vide letter No.12900/968/PHC/SDJ/HR&W at 24.07.2020 has circulated the approved format for maintaining the common seniority list for promotion to the post of Superintendent, Senior Clerk, Junior Clerk & for other posts.

- ii. The mentioned format along with seniority lists was circulated among the employees of this establishment vide letter. No.1527-30/DSJ Buncr dated 08.08.2020 and objections/observations were also solicited till 10.09.2020.
- That Sher Ahmad Khan & Shaheen Wahab both Junior Clerks have submitted their objections dated 09.09.2020 wherein they have dontended that their first entry into service shall be corrected as 06.03.2000 & 08.05.2000

promoted to the post of Junior Clerks on 09.03.2005 and the officials namely Muhammad Hasham, Muhammad Nacem, Saleem Khan, Ahmad Gul & Habib Gul were appointed as Junior Clerks on 09.03.2005. That the promotecs shall be ranked senior to appointees.

The objectors Sher Ahmad & Shaheen Wahab as well as the above-mentioned appointed Junior Clerks were summoned on 22.09.2020 for hearing in respect of their contentions concerning to seniority amongst them. Both the parties were heard at length and the order was kept reserved which was announced today on 29.09.2020.

So far the request of Sher Ahmad & Shaheen Wahab in respect of the dates of their first entries into service is concerned, in this respect it is stated that the objectors have contended that they were appointed as Class IV employees on 06.03.2000 and 08.05.2000 respectively but the same is not properly incorporated in the seniority list of Junior Clerks, therefore, the same is accepted and correction be made accordingly.

So far the request/objection for ranking them senior to the appointees is concerned, in this respect the office record reveals that the then District & Sessions Judge, Buner Muzamil Shah Khattak had circulated tentative seniority list of different Page 2 of 5



Habib Gul of this establishment had filed objections that their seniority shall be determined on the basis of age. That Sher Ahmad Junior Clerk had also submitted objection to the extent only that his date of birth, date of first entry into the service and date of upgradation shall be corrected. That said Sher Ahmad has not raised objection that he being promotee shall be ranked senior to those who were appointed as Junior Clerks on 09.03.2005.

All the above-mentioned officials were summoned by the then DSJ, Buner Muzammil Shah Khattak for personal hearing on 17.03.2015 at 01:30PM and after hearing all the concerned & going through the merit list of the Selection Committee, it was ordered by the then DSJ, Buner Muzammil Shah Khattak that the seniority of Junior Clerks shall be re-easted. The order was implemented and final seniority list of Junior Clerks dated 01.04.2015 duly signed by the then DSJ, Buner on 30.04.2015 was issued which is as under;



ORDER

LIAZ ANWAR, J. Through this single order, I intend to decide the instant Departmental Appeal and Departmental Appeal No.57/2020 titled "Shaheen Wahab Vs. Muhammad Hasham and others". In both these appeals, the appellants are aggrieved of their placement as juniors in the seniority list dated 01.10.2020.

2. Perusal of the record reveals that the appellants Sher Ahmad Khan and Shaheen Wahab were appointed as Naib Qasid and Chowkidar on 06.03.2000 and 08.05.2000 respectively and were promoted to the posts of Junior Clerks on 09.03.2005. The respondents No.1 to 4 were appointed through direct recruitment vide order of the even date i.e. 09.03.2005. Seniority of the civil servants is determined under Section 8 of the Khyber Pakhtunkhwa Civil Servants Act, 1973 read with Rule 17 of the Khyber Pakhtunkhwa Civil Servants (Appointment, Promotion and Transfer) Rules, 1989. Rule 17 of the Rules ibid, being relevant, is reproduced as under:-

17. Seniority:- (1) the seniority inter-se of civil servants (appointed to a service, cadre or post) shall be determined:-

(a) in the case of persons appointed by initial recruitment, in accordance with the order of merit assigned by the Commission or, as the case may be, the Departmental Selection Committee; provided that persons selected for appointment to post in an earlier selection

2

shall rank senior to the persons selected in a later selection; and

(b) in the case of civil servants appointed otherwise, with reference to the dates of their continuous regular appointment in the post; provided that civil servants selected for promotion to a higher post in one batch shall, on their promotion to the higher post, retain their inter-se seniority as in the lower post.

Explanation-I:- If a junior person in a lower post is promoted to a higher post temporarily in the public interest, even though continuing later permanently in the higher post; it would not adversely effect the interest of his seniors in fixation of his seniority in the higher post.

Explanation-11:—If a junior person in a lower post is promoted to a higher post by superseding a senior person and subsequently that senior person is also promoted the person promoted first shall rank senior to the person promoted subsequently; provided that junior person shall not be deemed to have superseded a senior person if the case of the senior person is deferred for the time being for want of certain information or for incompletion of record or for any other reason not attributing to his fault or demerit.

Explanation-III: A junior person shall be deemed to have superseded a senior person only if both the junior and the senior persons were considered for the higher post and the junior person was appointed in preference to the senior person.

- (2) Seniority in various cadres of civil servants appointed by initial recruitment vizarize those appointed otherwise shall be determined with reference to the dates of their regular appointment to a post in that cadre; provided that if two dates are the same, the person appointed otherwise shall rank senior to the person appointed by initial recruitment.
- (3) In the event of merger/restructuring of the departments, attached departments or subordinate offices, the inter-se seniority of

civil servants affected by the merger/ restructuring as aforesaid shall be determined in accordance with the date of their regular appointment to a cadre or post".

- 3. Sub-rule (2) of Rule 17 of the Rules ibid made it clear that seniority in between the promotees and the direct recruits is to be decided with reference to the dates of their regular appointments. Admittedly, the appellants were in the service of the respondent much prior, as such, on their promotion to the posts of Junior Clerks, they will be considered seniors to the direct recruits. The wrong determination, at any stage, by the Competent Authority, at the relevant time, is not a hurdle in the correction of the seniority. Reliance can be placed on the case titled "Din Muhammad Vs. Director General, Pakistan Post Office, Islamabad and others (2003 SCMR 333)".
- 4. In view of the above, this and the connected Departmental Appeal are allowed. The appellants shall be ranked seniors to respondents No.11 to 4 who were appointed on the same date when the appellants were promoted to the posts of Junior Clerks.
