RESPECTFULLY SHEWETH:

PRELIMINARY OBJECTIONS:-

- a) That the appeal is not based on facts.
- b) That the appeal is barred by law and limitation.
- c) That the appeal is not maintainable in the present form.
- d) That the appeal is bad for mis-joinder and non-joinder of necessary and proper parties.

- e) That the appellant is estopped to file the instant appeal by his own conduct.
- 1) That the appellant has not come to this Hon'rable Tribunal with clean hands.
- g) That the instant Service Appeal is badly time barred.
- h) That the appellant has got no cause of action and locus standi to file the instant Service Appeal.

Facts

- 1. Pertain to record, hence need no comments.
- 2. Pertain to record, hence need no comments.

- 4. Pertain to record, hence need no comments.
- 5. Para to the extent of appointment of appellant, pertains to record needs no comments while rest of the Para is not plausible. As every Police Officer is under obligation to perform his duty up to his ability and entire satisfaction of high ups. Moreover, non receipt of complaint against an official does not mean clean chits that the officer is exonerated from future wrong deeds.
- 6. Para to the extent of enactment of Police Act 2017 is correct, hence need no comments while to the extent of repealing Police Ordnance 2016 is incorrect. As according to



section 141 of the Act ibid, Police Order 2002 was repealed to the extent of Khyber Pakhtunkhwa through Police Act 2017 moreover, the remaining contents of the Para regarding section 32,33 & 34 of Police Act 2017 are correct hence, need no comments.

- 7. Incorrect, hence denied. Promotion are granted to the official of Police Telecommunication after successful completion of mandatory training/courses and on the basis of seniority cum-fitness while before the enactment of Police Act, 2017, Police Telecommunication Unit was governed by Standing Order and there were different trades like Wireless Telegraphy (WT), Tele Printer (TP), Radio Mechanic (RM), Fitter Guard Duty (GD, Electrician, Mason, Barber, Washer man, Vehicle Mechanics, Motorcycle Mechanic, etc and their seniority were maintained in their respective trades and promotion were granted to the official on the basis of Seniority Cum-fitness subject to availability of vacancies in their respective trades. (Copy of Standing Order attached as Annex-A)
- 8. Pertain to Police Rule 1934 hence needs no comment.
- 9. Pertain to Police Rule 1934 hence needs no comments.
- Pertain to enactment of Police Act 2017 and amendments in Police Rule, 1934 vide notification No. 755/Legal dated 16.03.2017.
- 11. Incorrect, hence denied. After rule 13.9, new rule 13.9(A) was added to Police Rule 1934 vide amendment notification dated 16.03.2013 referred above.
- 12. Incorrect, hence denied. The appellant was appointed as Wireless Operator. As explained in the preceding Para before enactment of Police Act 2017 Police Telecommunication was governed by standing order wherein a separate seniority list was maintained for each trade and official were promoted on the basis of seniority cum-fitness subject to the availability of vacancy in their respective trade. However, after enactment of Police Act 2017 Police Force was organized on functional basis and Telecommunication & Transport Branch was declared as separate branch/Unit with Technical staff whereas separate rules, 22.A.13 was inserted in Police Rule 1934 through amendment vide notification dated 16.03.2017 refer above. In the wake of enactment of Police Act 2017 and newly amendment in Police Rule, a meeting of Police Policy Board was held on 03.05.2018 at Central Police Office Peshawar



regarding issues faced by the official of Police Telecommunication during the meeting the following recommendation were approved.

- Promotional Courses: Quota for officers of Telecommunication for Lower, Intermediate and Upper College Course at PTC Hangu to be given on priority basis and syllabus for these courses already submitted to CPO, may be approved.
- 2) BI exam case may be taken up with ETEA at the earliest.
- Implementation of amended Police Rule 2017 w.e.f 01.07.2019 may be considered. (Copy of Minutes of 36th Police Policy Board Meeting attached as Annex-B)

In the light of above decision appellant along with sum others official were allowed to appear in professional test for List A,B,C held at Police School of Telecommunication Tele HQRs Peshawar. Later on combine seniority list was prepared and suitable official for such list were promoted to the rank of Offg: HC against the existing vacancies strictly in accordance with the merit policy.

- 13. Para is Correct to the extent of promotion of appellant to the rank of Offg: Head Constable as discussed in preceding Paras.
- 14. Incorrect, hence denied after qualifying the professional test for List A, B, C considered combined seniority list was issued strictly in accordance with rules and policy.
- 15. Para is mis leading and against the facts. As per amendment Police rule 13.9(A) the upper age limit for intermediate college course (required for promotion to the rank of ASI) is 48 years whereas the appellant has already crossed upper age limit therefore not selected for such course. (Copy of Police rule 13.9 A at Annex-C)
- 16. Incorrect. Appellant and others were treated as per law and rules, the grievances of appellant are against the rule referred above.
- 17. Incorrect, the appellant has got no cause of action and the instant appeal is devoid of merit which is liable to be dismissed with cost.
- 18. That in the light of decision of 36th Police Policy Board Meeting, appellant and some others were allowed to appear in the professional test for A,B,C and after qualifying such list promoted as Offg: HC as discussed in Para 12 above.

- 19. Incorrect, appellant is treated as per law/rules detail reply already given vide Para 15 above.
- 20. Incorrect, hence denied, already explained above.
- 21. Incorrect, hence denied, respondent have acted strictly as per law/rules.
- 22. Incorrect, hence denied, as explained in the preceding paras, no discrimination whatsoever has been made in case of appellant; rather he was treated as per law /rules.

- e. Incorrect, the case of appellant is on different footing and he was treated as per law/rules.
- f. Incorrect, reply already given above.
- g. Incorrect, already explained in above Para's.
- h. Incorrect, already explained in above Para 18.
- Incorrect, The case of appellant is on different footing and reply already given vide Para C above.
- j. Incorrect, the respondents treated the appellant's case strictly as per law/rules.
- k. Incorrect, the appellant had crossed the prescribe age limit for Intermediate collage Course i.e 48 years as per Police rules 13.9 A

- m. Incorrect, appellant was treated as per law/rules.
- n. Incorrect: the amendment made in Police rules are in conformity with the provision of Police Act, 2017 and rules.



NOTIFICATION

Peshawar, dated the 16.03.2017.

No.755/Legal.-In exercise of the powers conferred by section 140 of the Khyber Paklituikhwa Police Act. 2017 (Khyber Pakhtunkhwa Act No. II of 2017), the Provincial Police Officer, with the approval of Government, is pleased to direct that in the Police Rules, 1934, the following further amendments shall be made, namely:

AMENDMENTS -

- In rule 12.1, after sub-rule (4), the following new sub-rules shall be added, namely:
 - No official of police establishment shall be allowed to change the cadre in which he was initially appointed.
 - The official appointed on contract shall not perform duty in any other Unit except in the Unit for which his services are hired. The period of contract shall be for one year and may be renewed upon satisfactory performance report.".
- For rule 12.4, the following shall be substituted, namely:
 - "12.4. Recruitment in Traffic Warden Service .-- (1) Direct recruitment in the Traffic Warden Service shall be in rank of Constable and Assistant Sub-Inspector in the same manner as provided for initial recruitment of Conslable and Assistant Sub-Inspector in the general cadre.
 - On appointment, the Constable and Assistant Sub-Inspector in addition to the basic recruit and probation courses, shall undergo mandatory Elite Course and Specialized Traffic Training Courses as determined by Provincial Police Officer.
 - The ratio of Past Track Promotion in the Traffic Warden Service, in the ranks of Assistant Sub-Inspector, Sub-Inspector and Inspector, shall be same as provided for Assistant Sub-Inspectors, Sub-Inspectors and Inspectors under the Khyber Pakhtunkhwa Police Act, 2017.
 - The Constable and Assistant Sub-Inspector shall be promoted on seats allocated for them in their respective districts and regions. The promotion within the Traffic Wardens shall be upto the rank of Inspector subject to completion of requisite promotional and capacity building courses as determined by Provincial
 - An Inspector of Police Worden Service shall be eligible for promotion as Deputy Superintendent of Police against general posts of Deputy Superintendents of Police, if he successfully completes the requisite courses including Advance Course provided under these rules and also qualifies specialized courses of minimum two (02) weeks each in the Police School of Intelligence, Police School of Investigation, Police School of Tactics and Police School of Public Disorder and Riot Management besides (04) weeks general policing orientation course and (08) weeks field attachment with Sub-Divisional Police Officer office and Police Stations. Deputy Superintendent of Police so promoted shall be eligible to be posted anywhere on any assignment.



22.A.13 Telecommunication and Transport Branch.—(1) There shall be a Telecommunication and Transport Branch at the Central Police Office. The Branch shall consist of Telecommunication Wing and Transport Wing, each to be headed by an officer not below the rank of Superintendent of Police.

- (2) The Telecommunication Wing shall be responsible for-
 - the prompt communication of orders and dissemination of information to the concerned quarters while keeping its confidentiality;
 - (ii) linking all Police Establishments with the WT System; provided that all Police Units and Districts shall have their Control Rooms linked with the Central Control Room at Peshawar; and
 - (iii) linking and making liaison with police patrols and Police Establishments.
- (3) The Head of Telecommunication Wing shall be responsible for-
 - (i) efficient working of the Telecommunication Wing;
 - (ii) upkeep of the equipments in the Telecommunication Wing;
 - (iii) quarterly inspection of the Base station and equipments;
 - (iv) management of human resource;
 - (v) ensuring accessibility of the equipments to authorized persons;
 - (vi) maintenance of record and logbooks;
 - (vii) modernization of equipments;
 - (viii) condemnation process of equipments;
 - (ix) maintenance of workshop;
 - (x) preparing annual procurement plan;
 - (xi) recommending use of code words for approval by the Provincial Police Officer; and
 - (xii) any other function assigned by the Provincial Police Officer.
- (4) The Head of Transport Wing shall be responsible for-
 - (i) efficient working of the Transport Wing;
 - (ii) upkeep of the vehicles at the central pool and supervise the upkeep at the Provincial level;
 - (iii) quarterly inspection of the vehicles and equipments;
 - (iv) management of human resource;
 - (v) distribution of vehicles in the Province;
 - (vi) maintenance of record;
 - (vii) modernization of equipments;
 - (viii) condemnation process of the vehicles;
 - (ix) maintenance of workshop;
 - developing a system of efficient use of POL and maintenance amount;
 - (xi) annual procurement plan relating to maintenance of vehicles;
 - (xii) preparing annual procurement plan; and
 - (xiii) any other function assigned by the Provincial Police Officer.
- (5) The Deputy Inspector General of Police at the Central Police Office shall supervise the functioning of Telecommunication and Transport Branch and shall be responsible to the Provincial Police Officer on matters relating to transport and telecommunication.

(6) The appointment on various posts in the Telecommunication Wing and Transport Wing shall be in accordance with the criteria as provided in Appendix 22.A.4.

- Note: (i) In case of initial recruitment of Assistant Sub-Inspector Technical and Constable Technical, the condition of required height and chest of the general cadre of Assistant Sub-Inspector and Constable shall also be applicable to this cadre, however,
 - (a) the Provincial Polices Officer, may give relaxation in height and chest to minimum extent of 2 inches, and 11/2 inches, and 11/2
 - (b) running shall be as follows:
 - l. Male candidates 1 Km in seven minutes
 - ii. Female candidates 1 Km in eight minutes
 - (ii) the syllabus for examination for initial recruitment of Assistant Sub-Inspector Technical and Constable Technical shall be provided to the Provincial Public Service Commission and the approved testing agency. as the case may be, with the approval of Provincial Police Officer;

Note:

- Lady Police candidates shall be exempted from Rope Climbing (1) and wall climbing tests. The total marks obtained by a Lady Police candidate in Rifle Shooting, Pistol Shooting and Cross-Country Run shall be adjusted in the scale of 100 marks.
- Each category of marks shall be further elaborated by Provincial (2) Police Officer through standing orders.
- A candidate who tops shall be declared as Cadet, provided that marks (6)obtained by the candidate in the Cadetship Examination shall not be, in any case, less than 60% of the total marks".

In rule 13.8,-

- in sub-rule (2), after the words "ten percent of vacancies", the words "in (i) the manner as provided in sub-rule (3) and (4)" shall be added; and
- after sub-rule (2), as so amended, the following new rules shall be added, (ii) namely:
 - Each District shall maintain list "C-II" of all those Constables for promotion to Head Constables, who have not passed the lower school course at the Police Training School and have exceeded upper age limit for the lower school course and are otherwise considered suitable for
 - For the purpose of sub-rule (3), a Selection Board consisting of District Head of Police of the district concerned and two other officers not below than the rank of Superintendent of Police shall be constituted by the Capital City Police Officer or Regional Police Officer, as the case may be, to consider on the basis of outstanding performance and good reputation of Constables for placement on list C-II; provided that in District Peshawar, Senior Superintendent of Police Operation shall be member of the Board in place of District Head of Police.".
- After rule 13.9, the following new rule shall be added, namely:
 - Upper age limit for lower, intermediate and upper college courses and its duration .-- (1) The upper age limit for Lower School Course shall be forty (40) years.
 - The upper age limit for intermediate college course required for promotions to Assistant Sub-Inspector, shall be upto forty-cight (48) years and the duration of this course shall be sixteen (16) weeks.
 - There shall be no upper age limit for joining upper college course and the duration of the course shall also be sixteen (16) weeks.

Quota of seats for upper college course shall be allocated to each Region in proportion to the existing strength of Sub-Inspectors of that Region. The cutoff date for calculating the upper age limit for lower school and intermediate college course shall be the 31st day of the month of December falling before the commencement of the course."
