
Preliminary Objections.

1. That the appellant has got no cause of action to file the instant appeal.

- 2. That the appellant is estopped by his own conduct to file the appeal.
- 3. That the appellant has not come to the Court with clean hand.
- 4. That the appeal is not maintainable in its present form.

OBJECTION ON FACTS.

- 1. Correct to the extent that the appellant was working as Assistant (BPS-16) in this office, however his performance is a matter of record.
- 2. Transfer/Posting is a routine matter ordered for running official business smoothly.
- Correct to the extent that the appellant was serving at the Office of Assistant Commissioner Mattani, when complaints were received against him and therefore he was closed to the main office and deputed with Addl. Assistant Commissioner (HQ) Peshawar, but he did not obey the orders. After explanation was called, the appellant submitted his reply and arrival report. But he did not attend the office and continue to serve at Assistant Commissioner Mattani office, despite the directions/orders of the competent authority i.e. Deputy Commissioner Peshawar (Respondent No.2). The appellant is well aware of the fact that the appointing authority i.e. Deputy Commissioner Peshawar (Respondent No.2) is the superior/competent authority and his orders are final, but the appellant ignored the order of the competent authority and continue to serve with Assistant Commissioner Mattani who is a sub-ordinate officer and thus showed glaring misconduct and dis-obedience. Certainly his performance with Assistant Commissioner Mattani must have malafide intention as he had no obligation to obey the orders of a sub-ordinate officer after issuance of the orders of the competent authority (Respondent No.2). This conduct on the part of the appellant was not becoming a Govt. Servant and pre-judicial to good order of service discipline and comes under misconduct as per Rule-2(I) of Khyber Pakhtunkhwa Govt. Servants (Efficiency & Discipline) Rules 2011.
- 4. Incorrect. The appellant submitted his reply to Show Cause Notice which had no footings and he continued to argue that he was obeying orders of Assistant Commissioner Mattani thereby accepting his glaring dis-obedience.
- 5. Incorrect. The case of the appellant was delayed due to severe engagements in official routine business such as Eid-ul-Fitr arrangements, Ramazan/Eid Package, Polio Eradication Campaign etc. as well as newly established regime started working rigorously and thus the case could not be processed in a timely manner.

6. Correct to the extent that in emergency and due to shortage of staff, he was assigned only one day duty for just checking the proceedings at the Joint Check Post at Islamabad-Motorway Toll Plaza and no major responsibility was given to him.

7. The order was righteously issued as per Law and all the grounds raised by appellant are incorrect and attempt to hide his fault. Details objections on the ground are below.

OBJECTION ON THE GROUNDS

A. Incorrect. All the legal procedures were followed as prescribed in the Khyber Pakhtunkhwa Govt. Servant (Efficiency & Discipline) Rules 2011 as accepted by the appellant himself in the above paras.

B. Incorrect. The appellant was closed from AC Mattani on the direction of competent authority (Respondent No.2) who was the superior authority and appellant was bound to accept his orders. Appellant's utter disregard/disobedience to the lawful authority shows his malafide intention due to which he was proceeded subsequently as per law prescribed under Khyber Pakhtunkhwa Govt. Servant (Efficiency & Disciplinary) Rules 2011. After suspension and even stoppage of his pay, the appellant insisted, by his own will, to perform duty with AC Mattani which reflects his attitude towards the orders of the competent authority. In an another Inquiry, no record of challan for the year 2023-24 in the Assistant Commissioner Mattani office.

C. Incorrect. The appellant was given full opportunity, heard personally and after considering all the information and facts available and fulfilling the requirements under the law the Inquiry officer submitted his inquiry report (copy of the Inquiry report attached as Annex-A).

D. Incorrect. Appellant was proceeded as per law and his behaviour/attitude towards orders of the competent authority reflects his malafide intention and ulterior motives.

E. No comments.

It is, therefore, very humbly prayed that the instant appeal of the appellant may graciously be dismissed with cost.

Respected Sir:

Reference office order No.0226/DC(P)/EA, dated.26-07-2023, regarding suspension of Fayaz Muhammad (Assistant, Under-suspension) on charge of disobedience and habitually absenting himself from duty. The undersigned was appointed as Inquiry Officer to probe into the matter and submit fact finding inquiry report.

Background:

Mr. Fayaz Muhammad (Assistant, Under-suspension) was posted as Reader to Assistant Commissioner, Mattani Peshawar. He was transferred to the office of Additional Assistant Commissioner, Shah Alam, vide office order No.0178/ADC(P), dated. 13-06-2023 and Mr. Asad Ullah (Junior Clerk), was transferred to Assistant Commissioner Mattani's Office. However, Fayaz Muhammad (Assistant), was retained in the office of Assistant Commissioner, Mattani, Peshawar, vide Additional Deputy Commissioner (G), Peshawar, office order, No.7547-53/DC(P)/EA, dated.16-06-2023. Mr. Asad Ullah (Junior Clerk) was transferred from Assistant Commissioner Mattani Office to Establishment Section of DC Office, Peshawar, vide order No. 0193/DC(P)/EA, Dated. 23-06-2023.

On 06th July, 2023, vide office order No. 2624/DC(P)/EA, Fayaz Muhammad, was closed to the office of Addl: Assistant Commissioner (HQ), Peshawar.

The Additional Assistant Commissioner (HQ), Peshawar, vide No. 0209/DC(P)/EA, dated. 12-07-2023, issued explanation to Fayaz Muhammad (Assistant) for non submission of arrival report in pursuance to office order No. 2624/DC(P)/EA, dated. 06-07-2023. The official concerned submitted his arrival report on 13-07-2023 (F.N) to worthy Deputy Commissioner, Peshawar, duly endorsed by Addl; Assistant Commissioner (HQ), Peshawar, dated. 13-07-2023.

He also submitted his departure report to the Assistant Commissioner Mattani, $\tilde{\circ}$ Peshawar, on 13-07-2023 (F.N). The Assistant Commissioner, (Mattani) Peshawar, on the face of departure report, directed the official concerned namely Fayaz Muhammad, "Do not relinquish the charge before the arrival of another reader, as it would affect the court cases and revenue matter as well, therefore, on the arrival of new reader from DC Office, you may relinquish the charge, as this office does not have the Reader and Computer Operator as well".

Mr. Fayaz Muhammad, Assistant, was placed under suspension vide office order No. 0226/DC(P)/EA, dated: 26-07-2023, for disobedience of the office order of Competent Authority and his continuous absence from the section, where he was supposed to perform duty as per direction of competent authority.

Proceedings:

The office order was received on 26-07-2023.

In pursuance of Rule-12(a) of Khyber Pakhtunkhwa, Govt; Servant (Efficiency & Discipline) Rules-2011, summon was issued to Fayaz Muhammad (Assistant Under suspension), on 26-07-2023, vide office No. 885-88/AC(HK)/179, to appear before the undersigned. The official attended this office. He requested another date for submission of his written statement. The Official attended this office again on 31-07-2023 and submitted his written statement, as well as, reply to the questionnaire conveyed to him on 31-07-2023.

The complainant namely Feroz Khan C/O Rosh Tikka Restaurant (RTR), at Ring Road, Peshawar, as mentioned in order, issued vide No.0226/DC(P)/EA, dated.26-07-2023, was summoned for personnel hearing and submission of written statement. He submitted his written on 31-07-2023.

Statement of Fayaz Muhammad (Assistant):

Alexal Sh

Fayaz Muhammad (Assistant, under suspension), submitted in his written statement that on 06-07-2023, I, was transferred from Assistant Commissioner Mattani Office, to Deputy Commissioner Office, Peshawar. However, I, was unaware, nor officially informed. He further stated that he has submitted arrival report and reply to the explanation issued from office of Addl; Assistant Commissioner (HQ), Peshawar.

He also stated that on the same day, he submitted relinquish / departure report to Assistant Commissioner, Mattani, Peshawar. Wherein, Assistant Commissioner, Mattani, Peshawar, directed through her note on departure report, not to relinquish charge.

He further explained in his written statement that he is unaware of the public complaints and the same have not been provided to him.

In a questionnaire provided to him, he has replied that arrival report to the Litigation Branch has been submitted and attached.

Statement of Feroz Khan:

On 31-07-2023, Feroz Khan attended inquiry proceedings and submitted his written statement. He submitted in his written statement that he had verbally complained due to some misunderstanding, which is clear now. He further submitted that he has no complaint against Fayaz Muhammad.

Findings:

Discreet and secret inquiry was also made from officers / officials of District Administration Peshawar. Available record was thoroughly perused.

During inquiry, no sufficient material found against Fayaz Khan (Assistant, under suspension), regarding extorting of illegal money from public. Verbal complaint made by Feroz Khan has also been withdrawn by him in his written statement.

Perusal of the record reveals that Fayaz Muhammad (Assistant Under, suspension), did not obey the office order No. 2624/DC(P)/EA, dated.06-07-2023, of the competent Authority i.e Deputy Commissioner, Peshawar. He submitted only his arrival report on 13-07-2023, after, he was issued explanation, on 12-07-2023. His plea, which he submitted in his written statement, that Assistant Commissioner Mattani has directed him, not to relinquish charge, is legally not justified for the reason that the Competent Authority in such a matter and for the post of Assistant (BPS-16), is the Deputy Commissioner. The official concerned, after submitting his arrival on 12-07-2023, was supposed and bound to perform duty, as per directions of the Deputy Commissioner, Peshawar, which, he has failed to comply in the instant case.

During the discrete and secret inquiry, it was found that official concerned namely Fayaz Muhammad is still performing his duties in the office of Assistant Commissioner Mattani, Peshawar, even after, his suspension issued vide order No.0226/DC(P)/EA, dated.26-07-2023. This conduct on part of Govt; servant is un-becoming and pre-judicial to good order or service discipline. It leads to misconduct as per Rule -2(I) of Khyber Pakhtunkhwa, Govt; Servants (Efficiency & Discipline) Rules-2011.

Fact finding report is submitted for further proceedings / action as per law, please.
