Preliminary Objections.

- 1. That the appellant has got no cause of action and locus standi to file instant appeal.
- 2. That the appeal is bad due to misjoinder and nonjoinder of necessary parties.
- 3. That the appeal is barred by law and & limitation.
- 4. That the appellant has not come to this Tribunal with clean hands.
- 5. That the instant appeal is not maintainable in its presents form.
- 6. That the appellant concealed the material facts from this Hon'ble Tribunal.
- 7. That the appellant has been estopped by his own conduct to file the appeal.

REPLY ON FACTS.

- 1. Para is correct to the extent of enlistment, however, appellant during service proved himself an efficient and habitual absentee.
- 2. Para No. 2 pertains to service record, hence need no comments.
- 3. Appellant while posted at investigation wing Swabi absented himself from duties w.e.f 02.12.2022 to 05.06.2023 and 05.06.2023 to till date of his dismissal without any leave/prior permission of the competent authority. On account of habitual absence and disinterest in official work, appellant was transferred to district Mohmand by the order of respondent No.2 vide order Endst: No. 342-44/ES dated19.01.2023 but he did not report his arrival and thereby disobeyed the order of senior officer, hence on account of such mis-conduct appellant was placed under suspension vide order No. 1418-20 dated 08.03.2023. (Copies of bad entries, transfer and suspension orders are as annexure "A, B")

- 4 Para is incorrect being member of discipline forced, he was supposed to apply for medical leave or ultimate competent authority if he was suffering from the alleged illness, but he himself availed self-sanctioned leave and absented himself from lawful duties.
- 5. Incorrect and misleading. Plea taken by the appellant is totally baseless rather he has looked the story just to give cover his willful absence.
- 6. Para is incorrect and misleading. Appellant was posted as Pay Officer in the office of SP investigation, who was found unwilling worker habitual absentee and absented himself from lawful duties w.e.f 28.03.2022 to 15.06.2022 without any leave/prior permission of the competent authority. Therefore, on account of such misconduct he was issued charge sheet along with summary of allegations and after proper departmental proceedings appellant was awarded major punishment of reduction to lower post.(

 Copies of charge sheet, summary of allegations, and Enquiry report along with order are attached as annexures C,D,E & F). It is worth mentioning here that: appellant has not challenged such order before appellate forum and such order got finality.
- Para is incorrect and misleading. Despite of his reduction from senior clerk to junior clerk on account of his willful absence, he did not mend his way and after few months of his reduction order, he again absented himself from lawful duties w.e.f 02.12.2022 to 05.06.2023 and from 05.06.2023 till his dismissal i-e18.08.2023. On account of such misconduct, he was proceeded against departmentally, for which he was served with charge sheet/summary of allegations and proper departmental enquiry was conducted in accordance with law/rules during which he was found guilty. After issuance of Final Show Cause Notice, he was dismissed from service being not interested in job through speaking order. (Copy of charge sheet, enquiry report, Final Show Cause Notice and order are attached as annexure "G,H,I &J")
- 8. Incorrect and misleading; on account of absence, he was transferred to district Mohmand and was well informed regarding his transferred but he did not report to district Mohmand for duty as a result he was suspended by respondent No. 2. Moreover, he took this whimsical plea just to save his skin in terms of his willful absence
- 9. Incorrect and misleading. Appellant during service proved himself a habitual absentee and unwilling worker; on account of which he was awarded major punishment after fulfillment of all legal and codal formalities through proper departmental enquiry wherein the appellant was full-fledged opportunity of defending himself but he bitterly failed to prove his innocence.



- 10. Incorrect. Plea taken by the appellant is totally bereft any legal footing because the punishment in question were passed after due course of law/rules regarding the issue in question by fully abiding /adhering to the proceeding devised for the purpose. Moreover, the order 15.06.2022 regarding reduction in rank has attained finality as he has not challenged such order before appellate forum.
- 11. Incorrect and unfounded, the orders are quite legal and in accordance with law passed by the competent authorities.
- 12. Incorrect, after proper departmental enquiry appellant was awarded punishment.
- 13 Incorrect, the appellant is treated in accordance with law/rules and no discrimination whatsoever has been made by the respondents as ill will or grudge is found on the part of respondents:
- 14. Incorrect, reply given vide para above.
- 15. Incorrect, appellant has got no cause of action and orders passed by the respondents are quite legal in accordance with law/rules. Hence, his appeal is liable to be dismissed with cost.

It is, therefore, requested that the instant appeal being devoid of merits may be dismissed with costs.

<u> Allegations:-</u>

It is alleged that Senior Clerk Muhammad Bilal, while posted as Pay Officer in the office of Superintendent of Police Investigation Swabi, has been found unwilling worker and habitual absentee, he was absented himself from lawful duty w.e.f 28.03.2022 till date without any leave/prior permission of the competent authority, which is highly against the discipline and amount to gross mis conduct.

Hence, the Worthy District Police Officer, Swabi as a competent authority served him Charge Sheet and summary of allegations and the enquiry was entrusted to the undersigned to scrutinize the conduct of the said delinquent official.

Proceedings:-

To unearth the real facts the undersigned summoned to the delinquent Senior Clerk Muhammad Bilal vide letter No.261/L dated 18.04.2022 and No.303/L dated 12.05.2022 (letters attached).

On 13.05.2022 the delinquent Pay Officer Muhammad Bilal appear before the undersigned and disclosed that he did not absent for his lawful duty deliberately but due to illness he was absented. In this connection the undersigned directed him to produce medical documents and record his statement regarding his illness and to prove his innocence. After some time he went into hiding from the office of undersigned and did not recorded his statement. A few days later, he handed over medical documents to another unknown person which are attached herewith but failed to submit his statement. After this, the delinquent pay officer (Muhammad Bilal) was contacted several times through his Cell no.0300-1761777, 0301-9755000 but unfortunately his Cell numbers were found switched-off which is clearly shows that he has not solid evidence/proof regarding his innocence.

Keeping in view the above the undersigned reckons that the delinquent Pay officer Muhammad Bilal was absented himself from lawful duty w.e.f 28.03.2022 till date. His total absent period is 62 days continuously. He is found guilty.

Hence, it is recommended that a lenient view may please be taken and he may be awarded with a suitable punishment if agreed.

Sub-Divisional Police Officer,

This Order will dispose of the departmental enquiry against senior Clerk Muhammad Bilal, who while posted as Pay Officer in the office of Superintendent of Police, Investigation, Swabi, has been found unwilling worker and habitual absentee. He absented himself from duty w.e.f 28.03.2022 to 15.6.2022 without any leave/prior permission of the competent authority. Therefore, he was issued with charge sheet alongwith summary of allegations and SDPO Lahor was appointed as Enquiry Officer. The enquiry officer conducted proper departmental enquiry, recorded statements of all concerned, collected evidence and submitted his findings, wherein he recommended the defaulter Senior Clerk Muhammad Bilal for suitable punishment.

The undersigned has gone through the enquiry papers and findings of the enquiry officer and by agreeing with the recommendations of the enquiry officer issued Final Show Cause Notice to the defaulter. The defaulter Senior Clerk Muhammad Bilal submitted his reply to the Final Show Cause Notice, which was perused and he was heard in Orderly Room but his reply was found un-satisfactory.

Therefore, I, Muhammad Shoaib Khan, PSP, District Police Officer, Swabi, in exercise of the powers vested in me under Khyber Pakhtunkhwa Civil Servants (E&D) Rules 2011, hereby award Senior Clerk Muhammad Bilal, Major Punishment of Reduction to a lower post from Senior Clerk to Junior Clerk with immediate effect. The pay for the period of his absence is hereby deducted from his salary.





ORDER

Therefore, Regional Police Officer, Mardan placed him under suspension and directed the undersigned to initiate departmental proceedings against him vide his office endst: No.1412-20/ES, dated 08.03.2023.

He was issued charge sheet on the said allegations and enquiry proceedings were entrusted to DSP HQrs Swabi under Police Rules-1975 ammended-2014. The Enquiry Officer conducted departmental enquiry, collected evidence, recorded statements of all concerned and submitted his finding wherein he found Junior Clerk Muhammad Bilal guilty for the mis-conduct and recommended him for suitable punishment. The undersigned thoroughly perused the findings of the Enquiry Officer. Therefore, he was served with Final Show Cause Notice at his home address through DPO Mardan on 14.07.2023. He was clearly directed vide para No:05 of the Final Show Cause Notice to submit his reply within 07 days of its delivery, otherwise it will be presumed that he has no defence to offer and ex-parte action will be taken against him. He was due to respond by 21.07.2023 but even after a month, he did not which means that he has nothing to offer in his defence and deserves exparte action.

Keeping in view findings report of the Enquiry Officer and conduct of the defaulter Junior Clerk, the undersigned came to the conclusion that the charges leveled against him have been proved beyond the shadow of doubt.
