SUBJECT: DE-NOVO INQUIRY IN SERVICE APPEAL NO. 1376 & 1377 OF 2018 TITLE SARFARAZ & KHIAL MUHAMMAD VS GOVT OF KHYBER PAKHTUNKHAW AND OTHERS.

Memo,

Reference to the subject cited above and to state that the Honorable KP Service Tribunal Peshawar accepting the service appeals and reinstating the appellants with the direction to hold denovo proceedings against the appellants on 06-06-2024, the operative part of the judgment is reproduced for ready reference: "*Vide our consolidated judgment of today placed on file of connected service appeal bearing No. 1376/2018 titled " Sarfaraz Khan vs. Director, Elementary & Secondary Education Khyber Pakhtunkhawa, Peshawar and others", the present appeal is accepted. The appellant is reinstated in service. However, the department is directed to hold denovo proceeding within a period of ninety days from the date of receipt of this judgment. The issue of back benefits etc. shall be subject to the final outcome of de-novo proceedings and rules on the subject. Cost shall follow the events. Consign. (Copy of Judgment is attached)*

That this office has filed an application for attested copy of the said judgment on 06-06-2024 and completion of copy on 03-07-2024 and received by this office on 19-07-2024.

That this office sent a CPLA request vides No 6848-49 dated 27-06-2024 to Director E & SE Peshawar.

That the scrutiny committee was held on 19-07-2024 under the chairmanship of secretary Law Department Khyber Pakhtunkhwa Peshawar and declared the subject case fit for filing of CPLA before the Supreme Court of Pakistan.

That the Department filed CPLA No. 601-P/2024 in Supreme Court of Pakistan.

That this office issued notification No. 7775 dated 23-07-2024 regarding reinstatement of Mr. Sarfaraz Khan Son of Umar Fad and Khyal Muhammad Son of Noran Shah for the purpose of Denovo inquiry.

That this office constituted De-Novo inquiry committee vide office notification No. 7776-79 dated 23-07-2024.

That this office sent reminder to inquiry officer for submission of De-Novo inquiry report vides No. 8250-51 dated 18-08-2024.

That the inquiry committee submitted their inquiry report vide No. 1626 dated 26-09-2024 and received to this office vide diary No. 5992 dated 27-09-2024 and recommended that "*(i) The appointment order and charge report provided by Mr. Sarfaraz and Mr. Khial Muhammad are fake and they have neither been appointed by the competent authority of the E & SE Department, nor they performed their duties at any of the school in the jurisdiction of E & SE District Battagram. (ii) The salaries drawn by the mentions persons do not justified their position as government employees sense their salaries fraudulently released by some corrupt offices/ officials of District Account Office Battagram who have already being proceeded for their misconduct and corrupt practices by NAB as well as by the concerned Department.*" (Copy of Inquiry Report along with annexure are annexed)

That in the light of denovo inquiry report the undersigned issued office orders No. 9816-19 & 9812-15 dated 27-09-2024 regarding the appointment order of both the appellant declare Fake, bogus, Null & void. (Copies of office orders are annexed)

Therefore, the denove Inquiry report is submitted for further necessary action please.

Subject: Inquiry Report in respect of Mr. Sarfaraz Khan & Mr. Khayal Muhammad

Reference to your notification bearing, Endstt. No. 7776-79 dated 23-07-2024, we the undersigned conducted the said inquiry on 21-09-2024.

PROCEDURE:

The relevant record of the DEO (M) Battagram, DAO Battagram, SDEO Male Battagram, SDEO Male Allai, GPS Toba Pashto, GPS Bandi Chari Said & GPS Lgharai Sar Naseem was scrutinized. Statements of Mr. Sarfaraz Khan, Mr. Khayal Muhammad, Head Teachers of the mentioned schools, ASDEOs and SDEOs were also recorded.

SUMMARY OF STATEMENTS:

1. Mr Sarfaraz stated (Annex-I) that he was appointed in BPS 07 at GPS Bandi Chari Said on 17-06-2008 and he took charge on 18-06-2008 at the mentioned school. He attached the appointment order (Annex-II) and charge report (Annex-III) as evidences. However, he failed to provide any documentary proof regarding the advertisement, test, interview, verification of documents and release of salary and performance of duty.
2. Mr Khayal Muhammad stated (Annex-IV) that he was appointed in BPS 07 at GPS Lgharai Sar Naseem on 06-07-2008 and he took charge on 09-07-2008 at the mentioned school. He also attached the appointment order (Annex-V), and charge report (Annex-VI) as evidences. However, he failed to provide any documentary proof regarding the advertisement for the post, test and interview, verification of documents and release of salary and duty performance.
3. The Head Teachers of the relevant /mentioned schools, (Annex-VII, VIII. & IX) and concerned ASDEOs (Annex-X, XI, & XII) & SDEOs (Annex-XIII) stated in written that both the persons i.e. Mr Sarfaraz Khan & Mr Khayal Muhammad have never been appointed by the department neither they took charge nor performed duties for a single day at the schools mentioned by them.

FINDINGS:

1. The appointment orders attached by the concerned persons have the following shortcomings:
 - i) The dispatch numbers of these appointment orders are fake having no record in the diary dispatch register of DEO(M) office Battagram (Annex-XIV).
 - ii) The name of the education department was schools and literacy departments in 2008 which was changed as Elementary and secondary Education department later on. The appointment orders provided by both the persons have been issued on the letter head and with the stamp of EDO elementary and secondary education Battagram which proves that the appointment letter has been fabricated/forged later on when the name of the department had been changed to E&SE.
2. The arrival report /charge report provided by Mr. Sarfaraz Khan has been signed by head teacher of GPS Bandi Saray Said instead of Bandi Charri Said, as evident by the stamp affixed on the charge report (Annex-III), and there is no school in the name of Bandi Saray Said in district Battagram, which further discloses that the charge report is also forged and fake.
3. The record of the concerned schools (XV, XVI & XVII) also reveals that both the persons have never ever made their arrival at the schools they claim, and they did not perform their duty for a single day at these schools, rather they are completely strangers to the schools as well as to the department.
4. The salaries of these persons were activated fraudulently by some of corrupt officers/officials of the District Account Office Battagram, who have been proceeded by NAB as well as by the concerned department for the mentioned fraud. Thus, they have no right to declare themselves as govt employee on the basis of getting their pay fraudulently.
5. The NAB has conducted a thorough investigation in this regard and has already declared these appointment orders and service status of the persons under inquiry, as fake, forged and fabricated. (The record of NAB proceeding is available in the file of DEO (M) Battagram.

CONCLUSION

All the above findings lead to the conclusion that:

1. The appointment orders and charge report provided by Mr. Sarfaraz and Mr. Khial Muhammad are fake as they have neither been appointed by the competent authority of the E&SE department, nor they performed their duty at any of the schools in the jurisdiction of E&SE Battagram.
2. The salaries drawn by the mentioned persons do not justify their position as government employees since their salaries were fraudulently released by some corrupt officers/ officials of District Account Office Battagram who have already been proceeded for their misconduct and corrupt practice by NAB as well as by the concerned department.

ANSWERS TO THE QUESTIONNAIRE SERVED ON SARFARAZ KHAN

1. I belong to village Qalandar Kasu/C Banna, Tehsil Alial, District Battagram.
2. I am FA and also got PTC at my credit.
3. I was appointed on 17/06/2008 in BPS-07, and was posted at "GPS Bandi Charl Said".
4. Regarding the record of test and interview, it is duty of the department to maintain it. It is also indispensable to submit that as NAB reference is pending against some of the account officers Battagram, therefore, in this connection, NAB has already taken into custody the relevant record. NAB Peshawar may kindly be approached to see and examine the record.
5. Regarding the vacancy, I got information from one of my family relative in my village. Regarding publication in the newspaper, as the issue pertains to 2007-2008, I don't remember the name of the newspaper but I got information from my relative regarding the vacant posts. Furthermore, the area was badly hit by earthquake previously so all the inhabitants were living in camps and makeshift arrangements.
6. I took charge soon after getting the appointment order from the competent authority. The date of charge was 18/06/2008.
7. It was in fact, duty of the competent authority to verify the documents. No doubt, the same would have been verified by the relevant quarters.
8. I received my salary continuously till I was stopped from service. My bank account No. is 79001069-03HBL Ajmeera Battagram. All the pay slips are available with me.
9. I have already annexed all my record with my service appeal. The original record is available in the concerned office.
10. My salary was in fact, stopped in the month of March 2015 and I immediately preferred departmental request on 05/03/2015.
11. I have lawfully been appointed. All the record is available in the office as well as in the NAB office. My appointment order has only been questioned because the NAB KP when took cognizance, I was unlawfully stopped from service and question mark was raised on my appointment order. It does not appeal to a prudent mind that when the appointment order was issued in the 2008, how the same was questioned in the year 2015 after the flow of 07 years. I am a lawful appointee having the relevant qualification and fulfilled the entire required touchstone.
12. All the available documents are annexed.
13. Already NAB reference is pending which would be concluded in near future. There are about 15 other employees facing NAB charge.




