

**Application for correction in judgment and

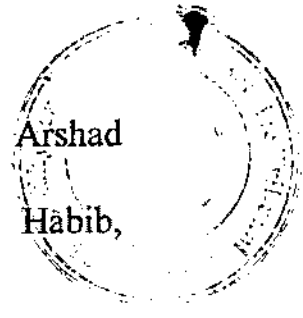
