department for more than 40 years, after his retirement be suffered from a fatal disease. On his request the applicant was granted two years / E.O.L without pay with effect from

01.09.2010 to 01.09.2012 for looking after of this ailing father.

On expiry of the leave, he applied for further leave with effect from 02.09.2012. His application could not be attended by the controlling officers and no response was conveyed to the applicant. As such he presumed that he had been granted the leave and so he remained away from duly till 26.02.2020 During the period his father died and his mother also suffered from paralysis, Due to this un avoidable circumstance, the teacher concerned could not attend his duties.

CONCLUSION:

That the then ASDEO/SDEC (M) now proceeded on retirement from service were required to had initiated disciplinary action against the absent teacher but they failed to mind their responsibility thus the teacher concerned remained on un authorized leave till he requested for adjustment on 26.02.2020. There appeared no fault on part of the absent teacher. The concerned officers of the department were accountable for the negligence in their duties.

- 3. He should take over charge of his posting on reporting of schools with effect from 01.06.2020.


