**NOTIFICATION**

WHEREAS, Mr. Farrukh Jadoon, Ex-PMS BS-17, then then Assistant to Commissioner (Pol/Dev), Hazara Division, holding Additional Charge of the LAC CPEC-HIT, now OSD was proceeded under Khyber Pakhtunkhwa Government Servants (Efficiency & Discipline) Rules, 2011 and after fulfilment of due process, the Competent Authority ordered to impose major penalty of "Removal from Service" upon him vide Notification of even No. dated 18.08.2023.

AND WHEREAS, aggrieved with the decision, he filed Departmental Appeal and upon regretal, filed Service Appeal No. 2455/2023 in Khyber Pakhtunkhwa Services Tribunal, Peshawar.

AND WHEREAS, the Khyber Pakhtunkhwa Service Tribunal vide judgment dated 13.02.2024 accepted his appeal, set aside the impugned order of this Department dated 18.08.2023 and ordered his reinstatement into service for the purpose of de-novo inquiry.

AND WHEREAS, upon approval of the Chief Minister, Khyber Pakhtunkhwa, he was re-instated into service for the purpose of de-novo inquiry vide this Department Notification dated 17.05.2024.

AND WHEREAS, Muhammad Khalid Zaman (PMS BS-19), Project Director, Computerization of Land Record (Phase-I), Board of Revenue was appointed as Inquiry Officer to conduct de-novo inquiry.

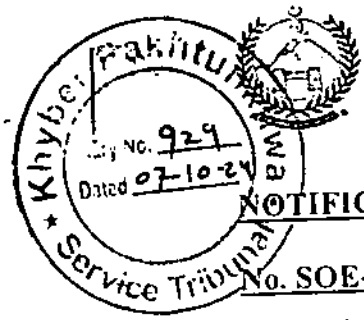
AND WHEREAS, the Inquiry Officer conducted de-novo inquiry and submitted his report, wherein he recommended that the accused officer may be exonerated as none of the charges / allegations could be proved against him.

NOW, THEREFORE, Mr. Ali Ameen Gandapur, Hon'able Chief Minister, Khyber Pakhtunkhwa being Competent Authority in terms of Rule-4(1)(a) of the Khyber Pakhtunkhwa Civil Servants (APT) Rules, 1989 has been pleased to exonerate the accused officer namely Mr. Farrukh Jadoon (PMS BS-17), the then Assistant to Commissioner (Pol/Dev), Hazara Division, now, OSD in Establishment Department from the charges levelled against him under Rule-14(3) of E&D Rules, 2011.


