<u>Parawise Joint Comments on Behalf of the Respondents 1 to 4:</u> <u>Respectfully Shewith</u> Preliminary Objections

- 1. That the Appellant is not an aggrieved person within the meaning of section 4 of the Service Tribunal Act, 1974.
- 2. That the Appellant has no cause of action / locus standi.
- 3. That the Appellant has not come to this Honorable Tribunal with clean hands.
- 4. That the Appellant has filed this instant Service Appeal just to pressurize the respondents.
- 5. The present Service Appeal is liable to be dismissed for non-joinder/mis joinder of necessary parties.
- 6. That the instant Service Appeal is against the prevailing law and rules.
- 7. That the Appellant has filed this instant Service Appeal on malafide motives.
- 8. That the instant Appeal of the Appellant is time barred.
- 9. That the instant Service Appeal is not maintainable in the present form, and above in the present circumstances of the issue.
- 10.That the Appellant has estopped by his own conduct by harassing the miners/students.
- 11. That the Appellant has concealed the material facts from this Honorable Tribunal.

FACTS

- 1. Correct
- 2. Irrelevant
- 3. That this para is correct to the extent of conducting enquiry against the Appellant and issuance of show cause notice against the Appellant, the rest of the para is incorrect and denied. In fact, the Appellant was working as Chowkidar at GPS No.02 Koza Bandai Since 29.08.2019. The SDEO Sub Division Male Primary Kabal Swat sent a letter dated 16.06.2023 along with written complaints of some of the girl students of the school with some serious allegations against the Appellant. The respondent No. 03 nominated Principal GHSS Aboha Swat and SDEO (M) Kabal Swat as enquiry committee to probe into the matter vide office order dated 19.06.2023. The enquiry committee conducted a detailed enquiry and submitted its report to

the office of respondent No.03 with clear recommendations to remove the Appellant from Service. Thereafter, respondent No.03 being competent authority issued a show cause notice to the Appellant vide Endst: NO. 5031-35 dated 04.07.2023. The Appellant Submitted his reply dated 13.07.2023 which was found unsatisfactory. Respondent No. o3 provided another opportunity of defense to the Appellant and nominated personal hearing officer vide Endst No. 6428-29 dated 12.08.2023. The personal hearing officer heard the Appellant in person, his statements as well as the statements of affected girls/students, teaching staff, headmaster and complainant parents were recorded. The personal hearing officer recommended that the penalty proposed by the enquiry committee may be retained. (SDEO office letter dated 16.06.2023 along with statements of students, enquiry report along with annexures, Copy of show cause notice, office order, and personal hearing report annexed A, B, C, D and E).

- 4. That this para is correct to the extent of imposition of major penalty of removal from service of the Appellant, the rest of the para is incorrect and denied, All the allegations leveled against the Appellant were proved and the enquiry committee as well personal hearing officer having considered the allegations and proofs recommended that the Appellant may be removed from service. Therefore, being the competent authority, respondent No.03 imposed the major penalty of removal from service upon the Appellant.
- 5. Correct.
- 6. The instant Service Appeal of the Appellant is bereft of any merit, hence, liable to be dismissed inter-alia following grounds.

GROUNDS

- i. Incorrect and denied. The act of the respondents is legal, lawful and in according to the relevant rules.
- ii. Incorrect and denied. The allegations leveled against the Appellant have been proved trough reliable sources and thus the Appellant is not entitled for reinstatement at all.
- iii. Repetition.
- iv. Irrelevant.
- v. Irrelevant.
- vi. Incorrect and denied. Enquiry committee has heard the Appellant orally as well as his written reply has also been obtained.
- vii. Incorrect and denied. The Appellant has not been dismissed from service rather he has been removed from service.
- viii. Irrelevant.
- ix. Incorrect and denied. No discrimination, whatsoever, has been made with the Appellant.

- x. Incorrect and denied. The Appellant has violated law, rules and policy and committed severe misconduct, therefore, his instant Service Appeal is liable to be dismissed.
- xi. That the respondents also seek permission to raise further ground be at the time of the arguments.

It is therefore very humbly prayed that the instant Service Appeal of the Appellant may be dismissed with cost in favor of the respondents.







The accused was telephonically contacted and was advised to attend personal hearing regarding the show cause issued vide No.5031-35 P/file/C-lv dated 4.7.23 to be held on 16.8.23 at GHSS Balogram swat and all the evidences, proofs which can be helpful to you may be presented along with your written statement to the undersigned during session of personal hearing. <u>CONCLUSSION</u>

During the personal hearing a questionair regarding the allegations reflected in the show chase on the bases of enquiry report was served on him and he was given sufficient relaxed time to counter all the charges with concert proofs in the enquiry report having against him supporting by sufficient proofs in terms of written statements of affected girls' students attested by Headmaster, statements of teaching staff, Head Master self-statement, Parents complaint, His questionair and his reply attached a annexure (A) page No. 5-6.


The accused could not present any concert proof in terms of witness videos etc, to wash out the allegitions level against him supported by more than ten (10) officials, parents and even the effected girls students statements. Therefore, the undersigned is of the view that under section 366(A) of penal code read with section 2(H) of the protection harassment of women Act 2010 of Pakistan. Section 366A of Pakistan Penal Code 1860; if a girl under the age of 18 is forced to perform sexual intercourse, the offender is liable to a punishment of 10 years and fine.

According to Section 2(H) of the Protection Against Harassment of Women at Workplace Act 2010, anyone making an unwelcoming sexual advance, requests for sexual favors, or his any verbal or physical conduct (falls in the category of workplace harassment) causes interference with work performance or creates an intimidating, hostile or offensive work environment for fellow co-workers, can be liable to following penalties

Minor penalties:-

Censure withholding for a specific period

Promotion or increment stoppage for a specific period

Recovery or compensation, payable to the complainant from pay or any other source of the accused

Major Penalties:-

Reduction to a lower post

Compulsory retirement

Removal from service~

Dismissal from service or fine.
