SERVICE APPEAL UNDER SECTION 4 OF THE KP SERVICE TRIBUNAL ACT, 1947, AGAINST THE IMPUGNED CANCELATION ORDER DATED 13.06.2024 WHICH WAS PASSED IN UTTER VIOLATION OF POSTING/TRANSFER POLICY.

PRAYER:

ON ACCEPTANCE OF THIS SERVICE APPEAL.

THE IMPUGNED ORDER DATED 13-06-2024

MAY PLEASED BE SET ASIDE, BEING PASSED

IN VIOLATION OF POSTING/TRANSFER

POLICY, AND THE ORDER DATED 07.06.2024

MAY KINDLY BE RESTORED, MOREOVER THE

RESPONDENT DEPARTMENT MAY PLEASE BE

DIRECTED TO ALLOW THE APPELLANT TO

COMPLETE HIS NORMAL TENURE.

Respectfully Sheweth:

FACTS:-

- 1. That the appellant is serving as SS (Islamiat) in the respondent department with full zeal and zest.
- That the appellant was transfer from GCMHSS Nahaqi Peshawar, and was posted at GMHSS Khar Bajaur against the vacant post vide order dated 07.06.2024. (Copy of the transfer order is annexed as annexure-A)
- 3. That after the transfer the appellant took over charge in GMHSS Khar Bajaur vide secretary and elementary & secondary education Notification No.SO (S/M)E&SED/5-17/2024/PT/SS dated 07.06.2024. (Copies of the charge report and relieving chit are annexed as annexure-B)
- 4. That there after the respondent suddenly withdrew the transfer order dated 07.06.2024 without any reasonable/ legal and just cause and due to political interference vide impugned order dated 13.06.2024. (Copy of impugned cancelation order is attached as annexure-C).
- 5. That the appellant feeling aggrieved from the impugned order dated 13.06.2024 filed departmental appeal but in vain. (Copy of departmental appeal is annexed-D).
- 6. That the appellant has no other adequate remedy therefore constrained to file this appeal on the following grounds inter alia:

GROUNDS:

- A. That the impugned order dated 13-06-2024 is against the law, facts, norms of justice, politically motivated, violation of Govt: circulars, therefore not tenable and liable to be set aside.
- B. That the impugned cancellation order dated 13.06.2024 was passed after proper compliance of transfer order dated 07.06.2024 by the appellant without giving any prior notice and opportunity of hearing, which is against the norms of justice.

- C. That the appellant has been subjected to injustice and appellant has not been treated in accordance with law.
- D. That a proper transfer order of the appellant has been withdrawn without any lawful reason, exigencies of service and without any just cause, which is violation of posting transfer police.
- E. That after having taking charge in his school and sudden withdrawal of his transfer order is against the policy and against the rule of legitimate expectation.
- F. That the respondent have transferred the appellant again and again before the impugned order and make the appellant rolling stone, hence the impugned withdrawal order of the transfer of appellant is the result of political ill-will and against the law and policy.
- G. That the cancelation order was made on the basis of external influence and not as a routine transfer, so without showing any cogent reasons and without giving personal hearing is against the law rules, posting and principal of locus poenetentiae.
- H. That the relevant law, rule and regulations have blatantly bypassed/violated by the respondents and the relevant law, rules and regulation has never been taken into consideration by the respondents and thus the notification so passed by the respondents have no legal sanctity in the eyes of law.
- I. That the impugned order has neither been in the best interest of public service nor in exigencies of service, hence not tenable and liable to be set aside.
- J. That the impugned order is violation of clause-I,IV and XIII of the transfer/posting policy of the government of Khyber Pakhtunkhwa as the appellant has been transferred from his current post.
- K. That the power or jurisdiction are vested in authority to exercise it justiy, fairly, honestly, judiciously and in accordance with law, rules and regulation but the respondents have transgressed upon their power while dealing with the matter in hand.
 - L. That the impugned order is not a rational one and based on liking and disliking.

- M. That the transfer of the appellant is also violation of circular based on the Anita Turab case dated 27.02.2013 in which it was clearly mentioned that when the ordinary tenure for a posting has been specified in the law or rules made there under, such tenure must be respected and cannot be varied, except for compelling reasons, which should be recorded in writing and are judicially reviewable.
- N. That no reasons has been mentioned in the impugned order which is the violation of Clause-24-A of the General Clause Act 1897.
- O. That this Hon'ble Service Tribunal already accepted the same nature appeal (Muhammad Usman S.A# 993/2024). So the appellant may also be treated at par and the same relief may also be given to the appellant.
- P. That according to the posting transfer policy normal tenure for posting is 2 year, but the appellant transferred order was cancelled just after 7 days, which is total violation of Govt: Posting Transferred Policy. Thus the impugned order is liable to be set aside on this score alone.
- Q. That the appellant seeks permission to advance others ground and proof at the time of hearing.

It is therefore, most humbly prayed that the appeal of the appellant may be accepted as prayed for.

- a) To ensure the posting of proper persons on proper posts, the Performance Evaluation Report/annual confidential reports, past and present record of service, performance on post held presently and in the past and general reputation with facus on the integrity of the concerned officers/officials be considered.
- b) Tenure on present post shall also be taken into consideration and the posting/transfers shall be in the best public interest.
- aggrieved due to the orders of posting/transfer authorities may seek remedy from the next higher authority / the appointing authority as the case may be through an appeal to be submitted within seven days of the receipt of such orders.  - Serious and grave personal (humaniturian) grounds.

To streamline the postings/transfers in the District Government and to remove any irritant/confusions in this regard the provision of Rule 25 of the North West Frontier Province District Government Rules of Business 2001 read with schedule – IV thereof is referred. As per schedule-IV the posting/transferring authorities for the officers/officials shown against each are as under:-

- iii. At the time of entry in service, all civil servants be asked to give 4 options from unattractive areas.
- iv. After a stint of service in unattractive area, employees may be offered option to serve in district of choice.

PLACEMENT POLICY.

In order to utilize the expertise of the officers who have received foreign training in various fields, the provincial Government has decided to adopt the Placement Policy, approved by the Prime Minister of Pakistan, and make it a part of its Posting/Transfer Policy. Placement Policy is as follows:-

- All placements would be made on the basis of merit and keeping in view the needs of the organization.
- The first priority in placement must go the parent organization of the participant from where the individual had applied. This will be in
