

Perusal of record reveals that the office of the Accountant General Khyber Pakhtunkhwa, vide tetter No.Admn-II/Dis/A.G Office/2020-21/08 dated 16.02.2021 addressed to the Director General Health Services Khyber Pakhtunkhwa, Peshawar, wrote for verification of employees in order to inquire regarding their appointments, wherein, the appellant's name was also included. But the office of Director General Health Services Khyber Pakhtunkhwa, Peshawar failed to submit reply in this regard. Besides, the District Accounts Officers, Bajaur had also intimated the matter to the respondent department for conducting inquiry into the matter.
