**APPEAL U/S 4 OF THE KHYBER PAKHTUNKHWA SERVICE TRIBUNAL ACT 1974 AGAINST THE IMPUGNED ORDER DATED 19-09-2024 PASSED BY RESPONDENT NO.1 WHEREBY DEPARTMENTAL APPEAL OF THE APPELLANT FILED AGAINST THE ORDER DATED 21-02-2023 HAS BEEN REJECTED.**

**PRAYER:-**

On acceptance of this appeal the impugned Order dated 19-09-2024 and 21-02-2023 may kindly be set aside and the appellant may kindly be ordered to be reinstated in service with all back benefits.

**Respectfully Submitted:-**

1. That the appellant was appointed as primary school teacher at GPS Gujrano Shafiq Abad on 25-03-2016 and was posted at Govt. Primary School No.1 Takht Bhai, the Service of the appellant were regularized later on. Since appointment he performed his duties with honesty and full devotion and to entire satisfaction of the high ups. **(Copy of appointment Order is enclosed as Annexure A).**
2. That the appellant earlier got admission in Harban Normal University China through scholarship for online PhD degree but when the online classes were completed the concerned university issued notification for research work in which physical appearance of the student was necessary, in this regard the appellant had requested for study leave w-e-f 10-10-2022 to July 2023 vide application dated 05-10-2022. **(Copy of application & relevant documents are enclosed as annexure B).**
3. That in the meanwhile the appellant was dismissed from service vide order dated 21-02-2023, copy of which was obtained by the appellant on 24-1-2024. **(Copy of order dated 21-02-2023 is enclosed as Annexure C)**

4. That thereafter, the appellant preferred departmental appeal on 12-02-2024 which was regretted by respondent No 1 vide order dated 19-09-2024. **(Copy of Departmental Appeal & Order dated 19-09-2024 are enclosed as annexure D & E).**
5. That the impugned orders dated 19-09-2024 & order dated 21-02-2023 are against the law, facts and principles of natural justice on the grounds inter-alia as follows:

**GROUND:**

- A. That both the impugned Orders are illegal, unlawful, without lawful authority and void.
- B. That the appellant is not treated in accordance with law and rules which being his fundamental right as per Article 4 & 25 of the Constitution of Islamic Republic of Pakistan 1973 and law of the land.
- C. That under the rules governing the subject the appellant was entitled to the requested leave being his fundamental right as under the constitution and law of the land, education and career progression is the fundamental right, and thus the appellant has not been treated according to law and rules.
- D. That the appellant was entitled to study leave as per rules on the subject and his request for the purpose was never refused, thus the impugned orders are liable to be set at naught.
- E. That no charge sheet was communicated to the appellant nor any proper inquiry was conducted in the matter, thus the impugned orders are void.
- F. That no prior notice as required under rule 9 E & D rules 2011 was sent to the appellant, nor the publications as required under the law were made in the leading newspapers, thus too the impugned orders are not tenable in the eyes of law.
- G. That the appellant was not provided opportunity of personal hearing.
- H. That the fact of study leave was dully in the knowledge of respondents and as such the proceedings taken were not warranted in law.

I. That the appellant has about 7 years of service with unblemished record with no complaint during his entire service career.

J. That any other ground not raised specifically here may kindly be allowed to be raised at the time of arguments.




It is therefore prayed that appeal of the appellant may kindly be accepted as prayed for in the heading of the appeal.
