

PARA WISE COMMENTS ON BEHALF OF PRIVATE RESPONDENT No. 03

(SHAHNAZ BEGUM)

Respectfully Sheweth;

Preliminary legal objections:-

1. That the present Appellant has got no cause of action.
2. That the present appeal is untenable, unmaintainable and unmerited, hence, it is liable to be dismissed.
3. That the present Appeal is not maintainable as the impugned order has lost the legal existence and is no more in the field.
4. That the Appellant has further posted / transferred to the Kohat District whereupon she has joined / assumed the new place of posting / transfer hence, the instant Appeal is infructuous.
5. That the Appellant is no more aggrieved person in terms of Section 4 of the Service Tribunal Act, hence, the instant Appeal is liable to be dismissed.
6. That the grievance of the Appellant has been redressed on account of desirable posting / transfer to the Kohat station.
7. That the prayer in appeal is totally groundless and the Tribunal has no power to exercise in terms of suo moto action.
8. That the appellant has come to this tribunal with uncleaned by making false statement with affidavit.
9. That this Hon'ble Tribunal lacks the elements necessary for evoking the jurisdictional of this Honorable Tribunal.
10. That this Tribunal lacks jurisdiction to adjudicate upon the matter in the executive matters wherein no interference is allowed and also held unlawful by the Supreme Court of Pakistan in very landmark verdicts, hence, this Appeal is liable to be dismissed.
11. That the son of answering respondent is Disable and require to be posted / adjusted at the Takhti Nasrati Karak on humanitarian ground.
12. That the Appellant has suppressed material facts from this Honorable Tribunal therefore, she is not entitled for the coveted relief.

- 13. That the appellant has been dealt according to law and no question of mala fide and discrimination whatever has been found on the surface of record in the instant Impugned order.
- 14. That all the alleged allegations levied against the answering respondent are denied vehemently thus as being incorrect, inaccurate, invalid, false, frivolous, and baseless thus liable to be rejected.
- 15. That the Appellant has filed instant Appeal in order to pressurize the answering respondents.

Para-wise comments on facts;

1. That the contents of para 1, 2, 3 to some extent pertains to official record need no comments. Further admitted by Appellant herself with regard to answering respondent that she was also **Posted / Transferred** up to the last District of KP such as District Tank, Tehsil Jandola and Lakki Marwat Khyber, Peshawar and so far which strengthen the version of answering respondent. The answering respondent was **Promoted** to the post of SDEO BPS-17 by the office order dated 21.02.2019 is **(Annex-A)**. Thereafter, the answering respondent was posted / transferred to District Tank, Jandola (Hard / war Area) whereas the Appellant was **Posted / Transferred** to the desirable station i.e Takhti Nasrati, Karak /home district due to highhandedness vide transfer Office Order dated 07.10.2021 is **(Annex-B)**. The answering respondent was further **Adjusted / Posted / transfer** to far flung area i.e Sarai Norang District Lakki Marwat vide office order dated 07.10.2021 **(Annex-C)** which is sufficient away from the Takhti Nasrati Karak. The answering respondent was again **Posted / Transferred** from Sarai Norang District Lakki Marwat to District Karak vide office order dated 06.12.2022 **(Annex-D)**. The Appellant was made another attempt successfully in order to **Replace** the answering respondent by approaching the Departmental Authority in very hasty and discriminative manner and she was further **Posted / Transferred** repeatedly to Sarai Norang District Lakki Marwat despite of the fact she has one disable son, lying on bed and no one of his look after at home except mother herein answering respondent vide office order dated 04.05.2023 is **(Annex-E)**. The appellant was made another attempt successfully by **Posting / Transferred** the answering respondent from Takhti Nasrati to District Peshawar in a very slipshod manner in the

absence of completion of normal tenure by humiliating answering respondent by various means which is very highly condemned vide office order dated 26.05.2023 is (Annex-F) and thereafter, answering respondent was further **Posted / Transferred To Hard Area** and last boundary District Khyber newly merged after expiry of 5 months vide office order dated 04.12.2023 is (Annex-G) wherein the interference of this Tribunal is mandatory and obligatory as it amounts to punishment and premature transfer. The appellant has posted / transferred from Takhti Nasrati District Karak to Directorate and answering respondent was adjusted / posted / transferred to Takhti Nasrati and the aforesaid Notification was challenged by the Appellant by means of filing Departmental Appeal and thereafter approached to this Tribunal under section 4 of the Service Tribunal being aggrieved person vide impugned office order dated 16.05.2024 (Annex-H). The Appellant was further posted / adjusted / transferred to District Kohat vide office order dated 23.09.2024 (Annex-I) and against the same post, she has actualized the charge dated 01.10.2024 (Annex-J), hence, the instant appeal is infructuous on this scenario and noble ground. The son of answering respondent is disable vide certificate is (Annex-K). The appellant remained outside the District Karak for a period of 05 months at Sarai Norang Lakki Marwat whereas the answering respondent had remained at different stations through even in hard and last boundary districts for a period of 03 years.

2. Para no. 4 of the appeal pertains to record and official respondent will reply the same.

GROUND

1. That grounds A to H are incorrect, false, allegations, frivolous utterly baseless: hence, they are most vehemently and vigorously denied. The impugned office order is passed by competent authority and no mala fide has been found on the surface of record. The appellant has been dealt according to law and no discrimination has been established. No violation of posting and transferring policy has been committed. Now the appellant has been very happy at district kohat as it is her choice station. The appellant has been high handedness and very influential in the executive matter. The appellant is under bounden duty to comply the order of authority passed u/s 10 of CSA. The impugned office order has been passed in the public interest.






