2. The cases in hand have been converted into service appeals in pursuance of the judgment of the Peshawar High Court, Peshawar in Writ Petition No.2195-P/2020 dated 27.05.2021.

3. The basic issue involved in these cases is that the appellants were qualified and having Bachelor's degree in different branches of Pathology, were not considered as eligible for the post of Clinicial Technologsts (BPS-17). As a result of inaction of the respondent, they allegedly remained without their own cadre and seniority list. For the purpose,

5. We have heard learned counsel for the appellants and learned Assistant Advocate General for respondents and some private respondents.

6. The learned counsel for the appellants reiterated the facts and grounds detailed in the memo and grounds of the appeals while the learned Assistant Advocate General District-Attorney controverted the same by supporting the impugned order(s).
